A list of political prisoners in Russia

Avtozak LIVE Russian Antiwar Committee September 2024 Thousands of people in Russia continue to act against the war and Putin's regime. Many of them are doing it from prison cells. The exchange of political prisoners is a success for which we are grateful to Western leaders, however, this does not negate the tragedy of what is happening. According to OVD-Info (the largest and most respectable human rights organisation monitoring repressions in Russia), as of August 3, 2024, 4672 people have been criminally persecuted for political reasons in Russia, with 2973 currently under persecution and 1289 imprisoned. Since Russia's full-scale invasion of Ukraine on February 24, 2022, a new wave of political repression has targeted dissenters. OVD-Info recorded 996 criminal anti-war cases from February 24th, 2022, to August 3rd, 2024. The number of prisoners continues to rise, with new repressive laws and harsher sentences for political cases.

The Russian state also persecutes children. For statements against the war and graffiti, 17-year-old Lyubov Lizunova was sentenced to 3,5 years, and Valery Zaitsev, a 15-year-old schoolboy with tuberculosis, is on trial for supporting the Azov Battalion.

These people knew what they were doing, they knew that their lives and freedom would be in the complete power of Putin who could kill them at any moment, just as he killed Alexei Navalny or Pavel Kushnir. Nevertheless, they made their choice; they fulfilled their human duty and acted against Putin's regime to uphold the ideas of equality and justice. These heroes fight not only for the freedom of Russia but also for the freedom of the entire civilised world, for the preservation of peace in Europe.

We urge you to advocate for their safety and freedom. Please remember them at international conferences, during meetings with decision-makers, and in conversations with journalists. Mention them in your articles and speeches because these individuals pay the highest price every day for their and our beliefs — they pay with their freedom, their health, and their lives.

We must protect them as much as they protect us from Putin's tyranny, war, and the spread of dictatorship around the world.



#### ABDULLAZHANOV OYBECK

He is accused of organising a terrorist attack due to an alleged attempt to damage electrical equipment on the railway.

#### **ABDULLIN AYTUGAN**

Eco-activist accused of organising mass riots, essentially because he demanded the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, a city in the Republic of Bashkortostan, Russia; the people were dispersed by more than 1000 police officers and national guardsmen with batons.

#### ABDURAKHMANOV BOGDAN

A native of Minsk, Belarus, was charged with terrorism for a failed arson attack on a military recruitment centre in Goryachiy Klyuch, Krasnodar Krai. Arrested in October 2022.

#### ABDURAKHMANOV BILYAL

A 66-year-old Crimean Tatar was charged with participating in an "illegal armed formation" for allegedly taking part in the Crimean Tatar battalion named after Noman Chelebidzhikhan, participating in the civil blockade of Crimea, commenting on the need to return Crimea to Ukraine and on the destruction of the Russian military in annexed Crimea.

#### ABDURAKHMANOV RUSLAN

A security guard of Lenur Islyamov (vice-president of The World Congress of Crimean Tatars), organiser of the energy blockade of the Crimean peninsula, was convicted of creating an armed formation and participating in activities of the Noman Chelebidzhikhan Battalion, a Ukrainian armed formation and sentenced to 5 years of high-security prison.

# **ABDYKANOV KAMIL**

Activist from Samara region convicted of "rehabilitating Nazism" for anti-war action he had performed at the T-80 tank monument site. Sentenced to 1 year and six months in a correctional facility.

# **ABISHEV URALBAY**

A resident of Almetyevsk was convicted of state treason for allegedly trying to join the Ukrainian Armed Forces and sentenced to 9 years of high-security prison.

# **ABRAMOV VYACHESLAV**

A resident of St. Petersburg was accused of organising mass riots, political activity, administrating chat rooms of the "What is to be done?" Telegram channel and calls to express opposing views during the deputy elections to the State Duma in 2021. He was sentenced to 6 years and six months of high-security prison.



#### **ABSALYAMOV AIGIZ**

Accused of organising mass riots, essentially for demanding the release of the Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and the National Guard with batons dispersed the crowds.

#### **ABUKAROV RAMAZAN**

A 16-year-old teenager was accused of committing sabotage by attempting to set fire to a fighter jet at a military airfield in the Chelyabinsk region.

## **ABUSHAKHMIN BURANBAI**

Accused of organising mass riots for demanding the release of a Bashkir activist and exleader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.

#### **AFANASYEV MIKHAIL**

The editor-in-chief of the Novy Focus Khakassian internet media source was convicted of dissemination of 'fake news' about the Russian Armed Forces for the article about 11 OMON soldiers from Khakassia region who refused to fight in Ukraine. Sentenced to 5 years and six months low-security prison.

#### **AGIBALOVA SVETLANA**

A Moscow resident was charged with threatening to kill or cause serious harm to health, vandalism motivated by political hatred, and obstructing the lawful professional activities of journalists for drawing a pentagram on the apartment door of Izvestia war correspondent Valentin Trushnin.

# **AKBALIN DINAR**

Accused of organising mass riots for demanding the release of a Bashkir activist and exleader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.

# **AKHATOV ILMIR**

A 41 years old Bashkir activist is accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. Arrested in February 2024.

# **AKHMEDIN ZAKIR**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. Arrested in January 2024.



#### **AKHMETOV AYRAT**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 police and National Guard with truncheons dispersed the crowds.

#### **AKHMETOV DANIS**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.

#### **AKHMETSHIN FATIKH**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.

#### **AKIMOV DANIIL**

An ex-deputy of the United Russia party (Znamensky municipal district) from the village of Ivanteevka, Saratov Region, was charged with terrorism for attempting to set fire to a military commissariat. Arrested in 2022.

#### **AKIMOV KIRILL**

An amateur radio engineer and beekeeper from Saransk, Republic of Mordovia, was convicted of "public justification of terrorism" for statements he had made on the radio disguised under the pseudonym of 'Mordovian Farmer.' The statements were in support of Ukrainians and the need to oppose Putin. Sentenced to 6 years of prison.

# **ALCHINOV (ALSYNOV) FAIL**

Bashkir activist, father of 4 children, is convicted of eco-activism protecting the Kushtau shikhan. Kushtau, along with other mountains like Toratau and Yuraktau, is really important for its natural, cultural, and historical significance. Fail is sentenced to 4 years of low-security prison.

# **ALEKSANDROV VLADISLAV**

Charged with discrediting the armed forces and intentional infliction of minor harm to health, acting on political or ideological grounds, for fighting with veterans of the so-called 'special military operation' and criticising participation in the war in Ukraine. Arrested in August 2023.

#### **ALEKSEENKO NIKITA**

A 17 years old teenager accused of committing sabotage due to allegedly making several attempts to set fire to the transportation infrastructure in the Moscow region. Arrested in November 2023.



#### **ALEKSEEV VITALY**

Chief inspector of the Siberian electronic customs in Krasnoyarsk was convicted of preparing a terrorist attack and for cooperating with the Freedom of Russia Legion, allegedly for a plan to set fire to the building of the United Russia political party. Sentenced to 12 years of high-security prison.

#### **ALEKSEEV ANDREY**

The military conscript was convicted of a terrorist act for attempting to set fire to the building of the military commissariat in Vladivostok and sentenced to 7 years of high-security prison.

#### **ALEXANDROV SEMYON**

A 50-year-old resident of Yakutia was accused of being a member of a "terrorist organisation", allegedly for recruiting people to the Freedom of Russia Legion.

# **ALEXANDROVA ANNA**

45 years old hairdresser accused of disseminating false information about the Russian armed forces because of her anti-war publications on the VK social network. She faces up to 10 years of imprisonment.

#### **ALEYNIK IGOR**

A resident of Novocherkassk, Rostov region, was tried for public calls to carry out extremist activities: Aleynik posted anti-war publications on the Internet. Compulsory psychiatric treatment was ordered.

# **ALIYEV TEYMURAZ MUSLIM OGLU**

Former Russian Armed Forces lieutenant colonel was sentenced to 18 years of high-security prison for allegedly transferring classified information

# **ALIYEV INTIGAM ILTIZAM OGLU**

He was convicted of insulting religious feelings and attacking a police officer as he compared Russian Orthodox Christians with fascists because of the war in Ukraine. Sentenced to 2 years in a correctional facility

# **ALIMORDONOVA MOMAGUL**

She is accused of using violence against a representative of the authorities for allegedly attacking a female police officer. In reality, she is persecuted for being the wife of an activist.

## **ALFIMTSEV ROMAN**

He is convicted of public justification of terrorism, probably for his anti-war stance, and sentenced to 5 years low-security prison.

## **ANDINA IRINA**

A member of the Police Ombudsman's team was convicted of false denunciation for the Save the Police Ombudsman movie. The movie highlighted the fabricated case against Vladimir Vorontsov. Sentenced to 3 years low-security prison.



#### ANGEL-BAROQUE SOFIA

A resident of Maykop, Adygea republic, was accused of justifying terrorism and insulting religious feelings for publishing videos about magic and temple fires on her Goddess Tiamat YouTube channel.

## **ANFALOV ANDREI**

A native of Ukhta, Komi republic, was convicted of public incitement to terrorist acts and for posts in the Odnoklassniki social network calling out to set fire to military recruitment offices. Sentenced to 5 years and six months low-security prison.

#### **ANOKHIN DENIS**

A 25 years old resident of Tula was convicted of posting comments about the Russian military, calling not to go to the military recruitment centre, and to evade military service. Sentenced to 4 years low-security prison.

#### **ANTONETS KONSTANTIN**

Convicted of allegedly cooperating with the Latvian secret services. Sentenced to 12 years and six months of high-security prison.

#### **ANUFRIYEVA OLGA**

A resident of Togliatti was convicted of participating in the activities of the Citizens of the USSR (the formal name in English is Union of Slavic Forces). This group was proclaimed an extremist organisation. Therefore, Olga was sentenced to 4 years and six months of low-security prison.

## **AMINEV AZAMAT**

He is accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. Arrested in February 2024.

# **ARBUZENKO ALEXEI**

A teacher and speech therapist was convicted of discrediting the Russian army, defacing posters depicting the military who showed heroism in the course of a so-called special military operation (i.e., the war in Ukraine)—sentenced to 6 years of low-security prison.

# **ARITKULOV DMITRY**

Convicted of public justification of terrorism because of anti-war comments on the Telegram social network. Sentenced to 5 years and six months of low-security prison.

# **ARSLANOV TAKHIR**

A 67-year-old resident of Novosibirsk was convicted of public incitement to extremism and terrorism and calls for mass disorder, all this due to two comments in the Wave of Change Novosibirsk VKontakte group. The comments were about setting fire to a military recruitment centre and about the Russian invasion as an invasion war run by Kremlin fascists. Sentenced to 2 years and ten months low-security prison.



#### **ARTYKOV RUSLAN**

Senior lieutenant convicted of state treason for allegedly collecting secret information about the Russian army on behalf of the Ministry of Defense of Ukraine. He was deprived of the military rank of senior lieutenant, sentenced to 13 years of high-security prison.

#### **ARKHIPOVA ANNA**

Anna participated in NGO activities that were counted as infringing on citizens' rights and was also charged with incitement to mass disorder. In reality, Anna was an activist of the Vesna democratic movement, which called for participation in anti-war protests. In custody since June 2023.

#### **ARCHILOV DALERZHON**

A citizen of Tajikistan was charged with spreading false information about the Russian army and hooliganism acts that threatened violence for criticising the president of the Russian Federation and Russia's military actions.

#### ATAEV EDUARD

Former head of Navalny's headquarters in Makhachkala, Dagestan republic, convicted of possession of weapons but essentially prosecuted for his political activity. He was reported wearing a bag during detention, and using force to put objects in his hands that looked like a pistol grip and a grenade. Sentenced to 6 years and five months low-security prison.

#### **ASRIYAN MAXIM**

A nurse who worked at a St. Petersburg GP surgery was convicted of an attempted terrorist act, allegedly for preparing to set fire to the Frunzensky military enlistment office in St. Petersburg. In reality, Maxim was tried for his anti-war stance and sentenced to 8 years of high-security prison.

# **ASHIMOV MARAT**

Charged with attempted fraud. In reality, the case was initiated for political reasons, as Ashimov defends the rights of Muslims as a lawyer. Arrested in March 2024.

# **ASHIROV ZUFAR**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baimak, and more than 1000 police and National Guard with batons dispersed the crowds.

## **ASCHEULOV TIMOFEY**

One of three sons of Lipetsk priest Igor Ascheulov was convicted of state treason for an attempt to illegally cross the border of the Russian Federation and planning to fight on the side of Ukraine. Sentenced to 17 years of high-security prison.



#### **ASCHEULOV JOHN**

One of the three sons of a Lipetsk priest, Igor Ascheulov, was convicted of treason, attempting to cross the Russian border and planning to fight on the side of Ukraine. Sentenced to 17 years and 6 months of high-security prison.

#### **ASCHEULOV ALEXE**

One of the three sons of a Lipetsk priest, Igor Ascheulov, was convicted of treason, attempting to cross the Russian border and planning to fight on the side of Ukraine. Sentenced to 17 years of high-security prison.

## **ASYLGUZHIN ILNAR**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.

#### **AUGUSTOV DANILA**

A 16-year-old teenager was charged with terrorism for allegedly trying to set fire to a military enlistment office in Tobolsk. Compulsory psychiatric treatment has been ordered.

#### **AVAKOVA YEKATERINA**

The chief accountant of the "Vperyod" ("Forward") newspaper in Bataysk, was convicted of fraud allegedly for overstating circulation, but in reality, she was persecuted for criticising the local authorities in the newspaper and sentenced to 4 years of prison.

## **AVDONIN MIKHAIL**

He was accused of state treason and attempted terrorist acts because of his alleged intention to set fire to the building of a military camp storage following the Freedom of Russia Legion's instructions. Avdonin's testimony was extracted under torture. Arrested in September 2023.

# **AYDYN DENIZ**

He is charged with participating in terrorist activity for allegedly intending to carry out terrorist actions out of hatred for the current state regime in the Tyumen and Sverdlovsk regions, as well as Khanty-Mansi Autonomous Okrug. In custody since August 2023.

# **AYUPOV ILNUR**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.



## **AYUPOV YULAI**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.

#### **BABINTSEV MIKHAIL**

A resident of the village of Mukhorshibir, Republic of Buryatia, convicted of committing a terrorist act for setting fire to the building of the military commissariat in protest against the war in Ukraine. Sentenced to 13 years of high-security prison.

#### **BABURIN ILYA**

Convicted of committing a terrorist act, participating in the activities of a terrorist organisation, and attempted treason for allegedly setting fire to two military enlistment offices in Novosibirsk and cooperating with the Azov battalion. The testimony was extracted under torture. Sentenced to 25 years of high-security prison.

#### **BAGAUTDINOV ALIK**

A resident of the Republic of Bashkortostan was convicted of sabotage and state treason for arson of a relay cabinet, for an anti-war stance, and allegedly for cooperation with the Freedom of Russia Legion. Sentenced to 15 years of high-security prison.

#### **BAZHOV ARTYOM**

A resident of Polevskiy, Sverdlovsk region, was accused of committing a terrorist act for spreading anti-war leaflets and allegedly setting fire to a transformer booth.

# **BAZHUTOVA ANNA**

A Twitch streamer was convicted of dissemination of 'fake news' about the Russian Armed Forces on the grounds of political hatred for a private stream during which she read out the stories of the Bucha residents and said the phrase 'death to Russian occupants'. Sentenced to 5 years and six months of low-security prison.

# **BAIGUSKAROV ILYAS**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. Arrested in January 2024.

## **BAICHURIN ILYAS**

Convicted of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and the National Guard with batons dispersed the crowds.



#### **BAKHTIN ALEXANDER**

Convicted of an anti-war picture on the Internet. Sentenced to 6 years low-security prison.

#### **BALABANOV MIKHAIL**

Convicted of preparing for a terrorist act, allegedly for the plan to set fire to a military enlistment office in Nevinnomyssk under the direction of the Ministry of Defense of Ukraine. Sentenced to 4 years and 6 months of high-security prison.

#### **BALAZEIKIN YEGOR**

A 16-year-old student of a St. Petersburg gymnasium was convicted of an attempted terrorist act for allegedly trying to set fire to a military recruitment centre. Sentenced to 6 years in a correctional facility.

#### **BALASHOV ANDREI**

Charged with attempted terrorist act for allegedly intending to blow up fuel tank cars positioned on railroad tracks. In custody since 2023.

#### **BALIN ANDREI**

Former co-chairman of the Togliatti branch of the PARNAS party was convicted of dissemination of 'fake news' about the Russian Armed Forces for making six posts dedicated to the Russian invasion of Ukraine on the VKontakte social network. Sentenced to 7 years of low-security prison.

#### **BARAGUNOVA LARISA**

The 66-year-old leader of the Trade Union Union of the Union of SSR organisation from Tyrn-yauz, Kabardino-Balkar Republic, was accused of assault on a representative of authority: she flicked a police officer on the forehead in response to his issued statement about beating, which she took as a joke.

## **BARANNIK KIRILL**

Charged with state treason and participation in the activities of a terrorist organization for allegedly blowing up railway tracks in Crimea, testimony was obtained under torture. Arrested in Simferopol in July 2023.

## **BARANOV ARTYOM**

Resident of Novaya Kakhovka, Kherson region, convicted of espionage and international terrorism for opposing a so-called 'special military operation.' Sentenced to 10 years and 6 months of high-security prison.

## **BARATOV USMAN**

Charged with incitement to hatred or enmity, as well as humiliation of the human dignity of participants in so-called 'special military operation' because of his anti-war comment in Odnoklassniki social network and the call to 'Bring c\*cksuckers back from the frontline.'



#### **BARAKHOEV AKHMED**

Convicted of using violence against law enforcement officers because of participation in protests in Magas against the establishment of the new border between Ingushetia and Chechnya. Sentenced to 9 years of low-security prison.

#### **BARYSHEV PAVEL**

A resident of Yakutsk was convicted of repeated discreditation of the armed forces, and for statements against Russia's invasion of Ukraine in WhatsApp messenger group chats. Sentenced to 1 year six months low-security prison.

#### **BARYSHNIKOV IGOR**

Convicted of spreading false information about the army because of three anti-war publications on social networks. Sentenced to 7 years 6 months low-security prison.

#### **BASKAYEVA IRINA**

A 60-year-old resident of Karachay-Cherkessia was convicted of participating in the activities of an extremist organisation, for her activism in the Citizens of the USSR movement. Sentenced to 4 years six months low-security prison.

#### **BATSENIN ALEXANDER**

A resident of Khabarovsk was convicted of state treason for allegedly cooperating with the Russian Volunteer Corps fighting on the side of Ukraine. Alexander reported being tortured. Sentenced to 12 years of high-security prison.

## **BAYANDIN IGOR**

A resident of Rostov-on-Don was convicted of a case of unlawful impact on the critical information infrastructure of the Russian Federation. Igor performed a hacker attack on government websites, he did this due to his anti-war stance. Sentenced to 2 years in a correctional facility.

# **BAYAZITOV RUSLAN**

A businessman from Kazan was accused of discrediting the armed forces and displaying banned symbols, for his avatar photo on his Telegram and Facebook profile with the following inscription: 'FreeNavalny! Free Navalny! Let him go!,' and for displaying the flag of Ukraine and the picture with 'Kherson is Ukraine, Donetsk is Ukraine, Lugansk is Ukraine, Crimea is Ukraine!' written over it.

## **BEGOYAN ARTYOM**

He was accused of sabotage, allegedly for arson of relay and battery cabinets in Chuvashia region, due to his anti-war stance.

## **BEDAI MAXIM**

A resident of Salekhard was convicted of participating in an illegal military formation, allegedly for planning to go to fight on the side of Ukraine. Sentenced to 3 years of low-security prison.



#### **BEZRUKOV YURI**

Charged with attempted terrorist acts by setting fire to the Yeletsky district court and administration. Arrested in April 2023.

#### **BEZRUKOV SERGEI**

An aircraft engineer from Moscow was accused of justifying terrorism and for anti-war publications in LiveJournal and X (Twitter).

#### **BELIKOV NIKITA**

A resident of Stavropol was convicted of participating in the activities of a terrorist organisation, allegedly for a video message about joining the Azov battalion. Sentenced to 11 years of high-security prison.

#### **BELOUSOV OLEG**

Convicted of dissemination of 'fake news' about the Russian Armed Forces because of anti-war and anti-Putin publications on the Internet. Sentenced to 5 years six months low-security prison.

## **BELOUSOV KIRILL**

A resident of Balakovo, Saratov region, was convicted of participating in an illegal armed formation, allegedly in an attempt to join the Freedom of Russia Legion. Sentenced to 5 years of high-security prison.

#### **BELOUSOV ANDREI**

A 17 years old teenager accused of sabotage for allegedly setting fire to a relay cabinet in the Irkutsk region.

# **BELKOVICH VLADIMIR**

A 19-year-old resident of Tulun, Irkutsk region, was accused of state treason and incitement to terrorism and an attempt to participate in a terrorist organisation, allegedly for participating in the Free Russia organisation. In fact, he distributed leaflets that displayed images of the white-blue-white flag (a symbol of peaceful, free Russia). Sentenced to 13 years of high-security prison.

# **BELYI BOGDAN**

A resident of Nefteyugansk, Khanty-Mansiy Autonomous District, was convicted of an attempt to participate in a terrorist organisation, for support of the Ukrainian military in social networks. Sentenced to 12 years of high-security prison.

## **BERDYUGIN DANIL**

An 18-year-old resident of Novosibirsk was convicted of preparing for high treason and attempted illegal crossing of the state border, allegedly for attempting to switch to the side of Ukrainian armed forces. Sentenced to 6 years of high-security prison.



#### **BERKOVICH YEVGENIYA**

Theatre director convicted of propaganda of terrorism because of the Finist the Brave Falcon play about women who were baited to marry representatives of radical Islam and go to Syria to live with them. Sentenced to 6 years of low-security prison.

#### **BESSARABOV ALEKSEY**

Convicted of attempted sabotage for allegedly intending to commit sabotage of military infrastructure in Crimea per the instructions of the Ukrainian Special Operations Forces. Sentenced to 14 years of high-security prison.

#### **BESTUZHEV YEVGENY**

The Democratic Russia movement coordinator, head of the Department of the Strategy Humanitarian and Political Science centre, and co-chairman of the St. Petersburg branch of the Solidarnost movement was accused of disseminating false information about the Russian armed forces for publishing 27 posts on the VK social network criticising Russia's invasion of Ukraine.

#### **BIGAYEV TAMERLAN**

The ex-journalist of Life.ru was convicted of extorting 11 million rubles from Chemezov (Head of Rostec), but in reality, he is persecuted for his professionalism. Sentenced to 5 years of high-security prison.

#### **BILENKO HRYHORIY**

A pensioner was accused of cooperating with the Security Service of Ukraine. He faces up to 20 years of imprisonment.

# **BIRYUKOV ANDREI**

Convicted of justification of terrorism and calls to extremist activities for a speech in court with the words: 'I do not consider Putin's fascism legal, I do not consider it a state.' Sentenced to 6 years of low-security prison.

# **BLINOV DMITRY**

A St. Petersburg resident was accused of vandalism for insulting the authorities with an inscription on a transformer booth. Arrested in February 2024.

# **BOBROVITSKY ALEXANDER**

Convicted of participating in the activities of a terrorist organisation, attempted terrorist act, allegedly for conveying a plan to blow up one of the objects of transport or industrial infrastructure as a protest against Russia's invasion of Ukraine. Sentenced to 12 years of high-security prison.

#### **BOGDANOV RUSLAN**

A 19-year-old was convicted of a plan to commit a violent seizure of power. Sentenced to 18 years of high-security prison.



# **BOGMUT DMITRY**

Charged with dissemination of 'fake news' about the Russian Armed Forces, for publishing anti-Putin posts. Dmitry faces up to 10 years of imprisonment.

## **BOGOLYUBOV ARTYOM**

A resident of the Leningrad region was convicted of participating in an illegal military formation, allegedly for attempting to travel to Ukraine and join Ukrainian armed forces. Sentenced to 6 years of high-security prison.

## **BOYTSUN IGOR**

A resident of Inta, Komi Republic, was convicted of incitement to terrorism and calls to extremism for anti-war comments on YouTube. Sentenced to 6 years of low-security prison.

#### **BOLDYREV ROMAN**

Accused of committing a terrorist act by setting fire to a relay cabinet at a railway station. Roman faces up to 20 years of imprisonment.

#### **BONDAREV BOGDAN**

A native of Kemerovo region was accused of executing a terrorist act due to his arson of a relay cabinet in St. Petersburg, as well as for cooperating with the Freedom of Russia Legion and distributing anti-war leaflets.

#### **BONDARENKO DANIEL**

Convicted of justifying terrorism because of an alleged positive reaction to the Crimean Bridge explosion, overheard in a conversation with fellow soldiers. Sentenced to 2 years of correctional facility.

# **BONDARENKO OLEG**

A resident of Cherkessk was accused of founding an extremist organisation due to his participation in the movement in support of the USSR/RFSR.

# **BORZENKO MARK**

An 18 years old teenager was convicted of an attempted terrorist act for allegedly preparing to set fire to a military recruitment centre. Sentenced to 6 years in a correctional facility

## **BORZENKOV DMYTRO**

Convicted of treason for allegedly passing classified information to the Security Service of Ukraine. Sentenced to 13 years of high-security prison.

## **BORIEV ALAN**

He is charged with state treason. Details unknown.

## **BORISENKO VLADISLAV**

Convicted of terrorist act due to committing arson of a military enlistment office. Sentenced to 12 years of high-security prison.



#### **BORISOV SERGEY**

A resident of Tver was convicted of state treason for allegedly planning to join one of the units of the Armed Forces of Ukraine. Sentenced to 6 years of high-security prison.

#### **BOJARSHINOV VLADISLAV**

A serviceman, a graduate of a paratrooper school from Tatarstan and a participant of the Victory Parade on Red Square was convicted of state treason for allegedly collecting intelligence and other information that could be used against the security of the Russian Federation. Sentenced to 12 years of high-security prison.

#### **BOYARSHINOV ANDREI**

An activist from Kazan was convicted of justifying terrorism, spreading anti-war leaflets, as well as writing messages in Telegram chats, including 'the need to purchase megaphones and means of armed resistance against representatives of the authorities'. Sentenced to 5 years of low-security prison.

#### **BREDIKHIN ALEXEI**

A resident of Unecha, Bryansk Region, has been charged with promoting terrorist activity and participating in terrorist activity for allegedly corresponding with members of the Freedom of Russia Legion via Telegram chats.

#### **BRIK KIRILL**

Charged with being a member of a terrorist organisation for allegedly intending to carry out terrorist activities out of hatred for the current state regime in the Tyumen and Sverdlovsk regions and Khanty-Mansi Autonomous Okrug. Sentenced to 8 years of high-security prison.

## **BUBENSHCHIKOV MAXIM**

A resident of Primorsky district was charged with sabotage for allegedly setting fire to relay cabinets.

# **BUDALOV BORIS**

A resident of Yekaterinburg was accused of publicly justifying terrorism, probably for his antiwar posts. Arrested in October 2023.

## **BUDJERAK ARTYOM**

A resident of Ivanovo region, a native of Ukraine, was detained while travelling to Serbia with his wife and children, convicted of state treason for allegedly wanting to fight on the side of Ukraine and talking to 'foreign agents' (his mother and sister, who live in Ukraine). Sentenced to 6 years and four months of high-security prison.

## **BUGAYEV MIKHAIL**

Charged with attempted terrorist act by setting fire to a battery cabinet on railroad tracks.



#### **BULDAKOV ALEXANDER**

A 60-year-old resident of Izhevsk was convicted of creating an illegal armed formation, in reality he was persecuted for his activist stance and participation in the activities of the Union of Indigenous Peoples of Great Russia of the USSR. Witnesses reported testimony made under pressure from investigators. Sentenced to 13 years of high-security prison.

## **BULIAKBAEV DIM**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.

#### **BUNIN KIRILL**

A member of the StopXam movement was convicted of assaulting police officers. In truth, he attempted to stop a car driving on the sidewalk violating traffic rules. The car turned out to be a service car, and the driver and the passenger were members of the Grom special unit (Main Department of the Ministry of Internal Affairs of Russia in Moscow). Sentenced to 6 years in low-security prison.

#### **BURIKOV DMITRY**

Charged with intent to join the Russian Volunteer Corps. Details unknown.

#### **BURKEEV RINAT**

Charged with organising a terrorist organisation: Rinat was a political activist of the Marxist Circle. The video he posted reporting that Russia is 'occupied by capitalists' was the reason for the charges brought against him. Arrested in March 2022.

# **BUROV ANATOLY**

An activist from Vologda was convicted of justifying terrorism, likely for posting a video to a Telegram channel in support of Ukraine. Sentenced to 5 years low-security prison.

# **BUTOV VALENTIN**

A 18 years old teenager was convicted of promoting terrorist activity for allegedly preparing an explosion at the Novosibirsk Passport and Visa Service unit of the Ministry of Internal Affairs. Sentenced to 4 years in a correctional facility

## **BUTYLIN KIRILL**

Convicted of vandalism, terrorist act and public incitement to terrorism because of arson of military enlistment office in Moscow region and distributing of Arsonist Anti-war Manifesto across the Internet. Sentenced to 13 years of high-security prison.

#### **BUYANOVA NADEZHDA**

The 68 years old paediatrician working at a Moscow GP surgery was tried for a complaint by a military widow to whom the doctor had allegedly said, 'Your husband was a legitimate target of Ukraine.'



#### **BYVSHEV ALEXANDER**

The poet was convicted of writing a poem reflecting his opposing views, and for publishing a post about a destroyed village near Kyiv. Sentenced to 6 years ten months low-security prison.

#### **CHALTSEV ANDREI**

Accused of using violence against a representative of the authorities for allegedly attacking a police officer and shouting pro-Ukrainian slogans. Arrested in January 2024.

## **CHARLOT EDUARD**

The singer was accused of rehabilitating Nazism and insulting religious feelings for an Instagram video in which he tears a St. George ribbon hung in the shape of the letter Z, and for a video in which he nails his military ID, a picture of Patriarch Kirill and a crucifix made of branches to a tree. In custody since December 2023.

#### CHEBANOV DMITRY

Resident of Moscow convicted of organising mass riots, for political activity and maintenance of regional chat rooms of the What to do! Telegram channel, calls to express an opposition position in the election of deputies to the State Duma in 2021. Sentenced to 7 years 6 months low-security prison.

#### CHEBUKOV VITALY

Convicted of property damage, for unsuccessful arson of the building of the administration of Kulikovo rural settlement in protest against the actions of the authorities. Sentenced to 4 years of low-security prison.

# **CHELDIEV VADIM**

Convicted of organisation of mass riots for announcing a rally against covid restrictions in Vladikavkaz. Sentenced to 10 years of high-security prison.

# **CHEMURZIEV BARAKH**

Activist from Magas convicted of using violence against law enforcement officers because of participation in protests against the establishing of the new border between Ingushetia and Chechnya. Sentenced to 8 years of low-security prison.

# **CHERVOV ALEXANDER**

A pathologist at the Kuzbass regional clinical hospital was convicted of attempted sabotage and terrorist act, allegedly for a plan to damage power lines, military conscription offices and police departments. Sentenced to 17 years 6 months of high-security prison.

## **CHEREPANOV ALEKSEY**

A resident of Perm convicted of calls for extremist activity and justification of terrorism, as well as in the illegal sale of narcotic substances on a particularly large scale, in truth for participation in the organisation Citizens of the USSR. Sentenced to 13 years of high-security prison.



#### **CHERNETSOV ARTYOM**

Convicted of participating in a leftist youth organization, reported torture. Sentenced to 11 years of high-security prison.

#### **CHERNIKOVA IRINA**

Accused of participating in the activities of an extremist organisation due to posts with links to Alexei Navalny's Anti Corruption Foundation. In custody since February 2024.

#### **CHERNICHKIN NIKITA**

A pet defender from Ryazan was convicted under article the rehabilitation of Nazism and dissemination of 'fake news' about the Russian Armed Forces, for insulting comments on social networks about the Russian soldier Nikita Samoilov, who was killed in Gostomel. Sentenced to 6 years of low-security prison.

#### **CHERNOV ANDREY**

Convicted of organisation of a terrorist organisation, actually for political activity of the antifascist and the Set' ('Network') anarchist community. Participants of the Set' reported torture. Sentenced to 14 years of high-security prison.

#### **CHERNOVA ZHANNA**

Civil wife of activist Dmitry Chebanov was convicted of the organisation of mass riots, for political activity and maintenance of regional chat rooms of the What to do! Telegram channel, calls to express an opposition position in the election of deputies to the State Duma in 2021. Sentenced to 5 years 2 months low-security prison.

## **CHERTKOVA ANASTASIA**

Charged with incitement and discrediting the armed forces, for approving fights with former members of the 'special military operation' and criticising participation in the war in Ukraine.

## **CHERTYKOV DANIL**

Vet from Ekaterinburg charged with participating in a terrorist organisation for allegedly intending to carry out terrorist activities out of hatred for the current state regime in the Tyumen and Sverdlovsk regions and Khanty-Mansi Autonomous Okrug. Tortured, arrested in August 2022.

## **CHIRKOV GRIGORY**

Convicted of displaying Nazi symbols for the inscription in Izhevsk: 'Glory to Heroes! Glory to Ukraine!'. Sentenced to 1 year 5 months of high-security prison.

## **CHISTOV EVGENY**

A police officer was convicted of state treason for allegedly passing classified information to the CIA. Sentenced to 13 years of high-security prison.



#### **CHICHUNOV MAXIM**

Convicted of hooliganism motivated by political hatred with the use of an object used as a weapon because of the publication of a video of the shooting of a memorial plaque from a model of a grenade launcher. Sentenced to 3 years 6 months of low-security prison.

#### CHISHKOVSKY MAXIM

A Vladivostok resident convicted of terrorism for a failed attempt to set fire to a military recruitment treatment. Sentenced to 11 years of high-security prison.

#### **CHUBUKOV ILYA**

A resident of Kaliningrad was charged with hooliganism for setting fire to an installation with the letter Z in Belgorod. Reported being beaten with a bag over his head and handcuffed, tortured with a stun gun and a gas torch. In custody since September 2023.

#### **CHUVILIN DMITRY**

Deputee from Bashkortostan charged with organising a terrorist organisation, actually for political activism within the Marxist Circle, in particular for a video reporting that Russia is 'occupied by capitalists'. In custody since 2022.

#### **CHUMAK DANILA**

An 18-year-old resident of Norilsk was accused of rehabilitating Nazism and justifying terrorism for two videos of burning the St. George Ribbon, a symbol of Russia's military glory.

#### **CHUNOSOV SERGEY**

A resident of Blagoveshchensk was convicted on attempted state treason, allegedly for attempting to fly to Moscow 'for subsequent service in the Russian Volunteer Corps in Ukraine' in order to 'fight the Russian authorities by armed means'. Sentenced to 6 years of high-security prison.

## **CHUPROV ANDREI**

Convicted of participating in the activities of an extremist organisation because of the publication of materials of the Citizens of the USSR movement online. Sentenced to 2 years of high-security prison.

# **DAINEKO NIKOLAI**

The poet was convicted of incitement to hatred or enmity with the threat of violence and on calls for anti-state activity, for poetic statements against mobilisation and volunteer armed formations of Lugansk and Donetsk regions during the Mayakovskiy Reading event. Sentenced to 4 years of low-security prison.

## **DAITUMOV KARIM**

Convicted of rehabilitating Nazism, and insulting the symbols of Victory in the Great Patriotic War (WWII) by urinating on the Eternal Flame to protest against war. Sentenced to 2 years of correctional facility settlement.



#### **DAMIROV RAMIL AZIZ**

Azerbaijani resident of the Orel region was accused of participating in the activities of a terrorist organisation, allegedly for a plan to fight for the armed forces of Ukraine. The man wrote an application to renounce his Russian citizenship.

#### **DARII MIKHAIL**

A resident of the Moscow region was accused of justifying terrorism and participating in the activities of a terrorist organisation, allegedly for participation in the NS/WP group and support for the Azov battalion, allegedly for preparing sabotage.

#### **DAROVA SVETLANA**

A resident of Cherkessk was accused of creating an extremist organisation for her participation in a movement in support of the USSR/RFSR.

#### **DARSHT LEON**

An 18-year-old resident of Gulkevichi, Krasnodar region, was charged with attempted sabotage and vandalism for attempting to set fire to a transformer booth on the railroad tracks in protest against the war, and for burning a 'We do not abandon our own' banner.

#### **DAVAAKAI RUSTAM**

An accused serviceman from Abakan. Rustam evaded military service.

#### **DAVLETBAEV GAZIZ**

Convicted of justifying terrorism because of an anti-war comment on the Internet. Sentenced to 2 years of low-security prison.

# **DAVLETBAYEV RAYAT**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 police and National Guard with truncheons dispersed the crowds.

# **DAVLETBERDIN UMUTBAI**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.

## **DAVLETKILDIN DIM**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. Was beaten by local police.



#### **DAVLETOV SAMAT**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. Arrested in January 2024.

#### **DAVYDENKO KONSTANTIN**

Ukrainian citizen convicted of espionage for allegedly collecting information on the latest military equipment on behalf of the Special Operations Forces of Ukraine. Sentenced to 7 years of high-security prison.

#### **DAVYDOV DENIS**

Convicted of rehabilitating Nazism for throwing a cigarette butt into the fire inside the monument. Sentenced to 3 years of high-security prison.

#### **DEVYATY NIKOLAI**

Convicted of using violence against a representative of the authorities for allegedly fighting with police officers at a rally in support of Alexei Navalny. Sentenced to 4 years 6 months low-security prison.

## **DEMESHOV ILYA**

Accused of sabotage in Chuvashia republic, for anti-war action (arson of relay and battery cabinet).

#### **DEMIDCHIK DMITRY**

A resident of Magnitogorsk was charged with sabotage for allegedly trying to set fire to a military recruitment centre and a relay cabinet.

# **DEMCHENKO DANILA**

A resident of Ivanovo region convicted of preparing a terrorist act, allegedly for a plan to set fire to a military recruitment centre. Sentenced to 6 years of high-security prison.

## **DEMCHUK OSTAP**

Charged with state treason, allegedly for transferring money, which was then used in the interests of the Ukrainian Armed Forces. Arrested in June 2023.

#### **DERKUNSKY ALEXANDER**

Convicted of treason for allegedly obtaining the results of scientific research work related to the Russian Defense Ministry. Sentenced to 9 years of high-security prison.

#### **DERYAGIN GENNADY**

Doctor of Medical Sciences, Professor and Head of the Department of Forensic Medicine and Law of SSMU, and former professor of the Department of Criminalistics was accused of repeatedly discrediting the army of the Russian Federation for posts on VK social network about Russian missile strikes on Ukrainian cities, and about a Russian air bomb that fell in Belgorod.



#### **DILMUKHAMETOV AYRAT**

He was convicted of public justification of terrorism, for a video clip he posted depicting Ayrat Dilmukhametov (candidate for the President of Bashkortostan) delivering a speech during the Free Russia V Forum. Sentenced to 9 years of high-security prison.

#### **DILMUKHAMETOV VLADISLAV**

Convicted of preparing a terrorist act for allegedly planning to set fire to a military enlistment office in Perm. Sentenced to 10 years of high-security prison.

## **DIMITRENKO ALEXANDER**

Convicted of preparing sabotage, state treason, and illegal possession of explosives for allegedly intending to blow up a railway station in Voronezh region. Testimony was extracted under torture. Sentenced to 23 years of high-security prison.

#### **DMITRIEV ALEXEI**

Charged with organising a terrorist organisation, for taking part in political activism within the Marxist Circle, in particular for a video reporting that Russia is 'occupied by capitalists'.

## **DMITRIEV YURI**

Convicted of committing violent acts of sexual nature against his adopted daughter (fabricated case), in fact he was persecuted for compiling memorial books on the victims of political repressions of the 1930s-1940s and researching the burial sites of repression victims in Sandarmokh and Krasnyy Bor. Sentenced to 15 years of high-security prison.

# **DMITRIEV OLEG**

Convicted of attempted terrorist attack for allegedly intending to commit arson against government buildings during an anti-government rally on November 5, 2017. Sentenced to 8 years of high-security prison.

## **DMITRIENKO MAKSIM**

Convicted of alleged cooperation with the Freedom of Russia Legion. Sentenced to 4 years of high-security prison.

# **DOBROV VLADISLAV**

An 18 years old teenager was accused of organising a terrorist attack for allegedly trying to damage electrical equipment on railway tracks.

## **DOBRYNIN VYACHESLAV**

A journalist of the Rosderzhava publication was convicted of extortion to obtain goods in large amounts and insulting an official. However, he was actually persecuted for his professional activities and investigations on his YouTube channel. He was sentenced to 10 years and 6 months of high-security prison.



#### **DOROFEEV SERGEY**

Convicted of participating in an extremist group but persecuted for his political activism. Sentenced to 3 years of low-security prison.

#### **DOTSENKO OLEKSANDR**

Convicted of justification of terrorism for a postcard found in a store with the following inscription: 'Our father is Bandera, Ukraine is our mother, We will fight for Ukraine! Glory to Ukraine, glory to Heroes! Putin is a dickhead, Putin go to hell, Happy New Year!' The court ruled to confiscate the printer and the family car to the benefit of the state. Sentenced to 3 years low-security prison.

## **DROBKOV GLEB**

An 18 years old teenager was accused of preparing a terrorist act because of his alleged intention to blow up a police station in Volgograd region and damage 16 cars that displayed Z-symbols.

#### **DROZDOV PAVEL**

Convicted of dissemination of 'fake news' about the Russian Armed Forces because of antiwar publications on the Internet. Sentenced to 8 years of high-security prison.

#### **DUDKA VOLODYMYR**

Convicted of attempted sabotage for allegedly intending to commit sabotage of military infrastructure in Crimea per the instructions of the Special Operations Forces of Ukraine. Sentenced to 14 years of high-security prison.

# **DUDCHENKO SERGEI**

A Stavropol resident was accused of sabotage, allegedly for attempting to set fire to a military enlistment office. He reported pressure from law enforcers and blackmail to plant drugs and weapons on his property.

# **DUNAYEV ANTON**

A 17-year-old teenager was charged with justification of terrorism for allegedly cooperating with the Freedom of Russia Legion and distributing anti-war leaflets.

## **DURNYKIN MAXIM**

A resident of Balakhna, Nizhny Novgorod Region, convicted of attempted terrorist act, for a failed attempt to set fire to the Balakhna administration building and the local military enlistment office. Sentenced to 7 years of high-security prison.

## **DYACHENKO NIKOLAI**

Serviceman accused of evading military service during mobilisation. Deprived of the Sergeant of the Guard military rank.



#### **DYUDYAEVA ANASTASIA**

Convicted of justification of terrorism for a postcard found in a store with the following inscription: 'Our father is Bandera, Ukraine is our mother, We will fight for Ukraine! Glory to Ukraine, glory to Heroes! Putin is a dickhead, Putin to hell, Happy New Year!'. The court ruled to confiscate the printer and the family car to the benefit of the state. Sentenced to 3 years 6 months low-security prison.

#### DZHUMAYEV SAYD-MUKHAMAD (MIKAIL MARKHIEV)

Convicted of using violence against a representative of the authorities because of a fight with a riot police officer at a rally in support of Alexei Navalny. Sentenced to 5 years of low-security prison.

#### **ELIZARIEVA YEVGENIA**

Krasnoyarsk eco-activist was accused of insulting a government representative for her active stance on garbage reform, speaking out against the construction of class 1 and 2 radioactive waste burial grounds, and other Rosatom projects.

#### **ELISEEV OLEG**

A resident of Krasnodar region, born in the GDR, was convicted of preparation for state treason and participation in the activities of an extremist group, allegedly for participation in the Battalion of the International Legion (Ukraine). Sentenced to 6 years of high-security prison.

#### **ELISEEV FELIX**

A resident of the Lipetsk region was convicted of incitement to terrorism, for posts in the Kolhoz Madness Telegram channel against the current government and support for strikes on an oil depot in the Russian city of Belgorod, as well as for allegedly transferring funds to the Ukrainian Armed Forces. Sentenced to 14 years of high-security prison.

# **EREMEEV SERGEY**

Accused of committing a terrorist act by blowing up two trains with oil products allegedly per the instructions of the Special Operations Forces of Ukraine. Arrested in December 2023.

# **ERMISHIN VITALY**

Accused of using violence against representatives of the authorities, was detained after being beaten by a security guard of the RIO shopping centre in Moscow for writing on the asphalt: 'War stinks of corpses, war is a factory for producing beggars!'. The man's statement about beatings was not accepted. Arrested in August 2023.

## **EROFEEV VLADIMIR**

Convicted of inciting servicemen to surrender as prisoners of war. Sentenced to 3 years of low-security prison.

## **ESAULENKO ANTON**

A 60 years old resident of the Rostov region charged with attempted terrorism by attempting to set fire to two relay cabinets. Arrested in September 2023.



#### **EFIMOV YURI**

Charged with starting a terrorist organisation, actually persecuted for political activism as part of the Marxist Circle, in particular for a video reporting that Russia is 'occupied by capitalists'.

#### **EFIMOV DANIL**

Convicted of treason for allegedly transferring money to a charity fund connected with the U-krainian Armed Forces. Sentenced to 12 years of high-security prison.

## **EZHAYEV ASLAMBEK**

Convicted in a trumped-up case for promoting terrorist activities by allegedly financing terrorists from the accounts of the Umma book publishing house. Sentenced to 17 years of high-security prison.

#### **ETKEEV ANDREI**

Convicted of spreading false information about the army because of reposts of anti-war streams online. Sentenced to 5 years of low-security prison.

#### **FARARITDINOV RUSTAM**

The half-brother of Bashkir activist Ruslan Gabbasov was charged with promoting terrorist activity, for his WhatsApp messages with his brother: they discussed the Ukrainian Armed Forces units in which Bashkirs are fighting.

#### **FARAFONOV NIKOLAI**

A resident of Vuktyl in the Komi Republic was convicted of calling for terrorism, for publications in the Cynical Komyak anti-war Telegram channel, and for commenting on a VKontakte video approving the arson of a military recruitment centre. Sentenced to 6 years of low-security prison.

## **FARBER ILYA**

Convicted of intentional destruction of property: arson of a military enlistment office in Udmurtia. Sentenced to 3 years 2 months of high-security prison.

## **FATTAKHOV RAYAN**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. In custody since February 2024.

## **FELDMAN MIKHAIL**

Kaliningrad activist convicted of discrediting the Russian army, for his reposts and publications on the VKontakte social network, previously convicted of going to an anti-war rally and for anti-Putin publications in social networks. Sentenced to 2 years of high-security prison.

## **FETALIEV VADIM**

A resident of Naro-Fominsk, Moscow region, was accused of justifying terrorism, probably for his anti-war stance.



#### **FILATOV MIKHAIL**

A resident of Uryupinsk, Volgograd Region, was convicted of terrorism for setting fire to a military recruitment centre in protest against the war in Ukraine. Sentenced to 12 years of high-security prison.

#### **FILIMONOV ALEKSANDR**

Charged with state treason for allegedly passing data on military facilities to the Right Sector. Details unknown.

#### **FILONOVA NATALIA**

Journalist, human rights activist, editor of Everything Against All Odds, an independent Petrovsk-Zabaikalsk newspaper, was convicted of the use of violence against a representative of the authorities, allegedly for attacking four police officers with a ballpoint pen, in reality she was persecuted for her participating in a live video on the Nadezhda Nizovkina YouTube channel discussing mobilisation. Sentenced to 2 years 10 months of low-security prison.

#### **FILYANKIN VADIM**

Charged with terrorist act in Chuvashia republic, for anti-war action: arson of relay and battery cabinet. Vadim is sentenced to 2 years of prison.

#### **FILYUGIN ALEXEI**

Charged with dissemination of 'fake news' about the Russian Armed Forces and repeated discrediting of the armed forces for his publications and comments on his VK page condemning the Russian invasion of Ukraine. Sentenced to 1 year 6 months of forced labour in a correctional centre.

## **FIMUSHKIN DMITRY**

Charged with promoting terrorist activities because of alleged cooperation with the Freedom of Russia Legion. Arrested in October 2023.

# **FLORINSKY ILYA**

Convicted of public calls to carry out terrorist activities due to publications in the Citizens of the USSR group in VK. Sentenced to 6 years of low-security prison.

## **FOKIN IVAN**

Ivan was convicted of attempted treason and an attempt to participate in a terrorist organisation for allegedly intending to cross the state border and join the Freedom of Russia Legion. Sentenced to 9 years of high-security prison.

## **FROLOV SAVELY**

Convicted of allegedly cooperating with the Freedom of Russia Legion. Reported being tortured. Sentenced to 6 years of high-security prison.



#### **FURGAL SERGEI**

Convicted in a murder case that took place in 2004-2005, essentially persecuted for his oppositional political activity as governor of Khabarovsk Krai. Sentenced to 22 years of high-security prison.

#### **FYODOROV VASILIY**

A member of the Police Ombudsman team was convicted of false denunciation for the Save the Police Ombudsman movie, the film was about the fabricated case against Vladimir Vorontsov. Sentenced to 4 years low-security prison.

#### **FEDOROV SERGEY**

A 59-year-old resident, a pensioner from Moscow, was charged with terrorism for allegedly setting fire to a relay cabinet. Details unknown.

#### **FEDOROV EVGENY**

A resident of Kireyevsk, Tula Region, convicted of displaying and of propaganda of Nazi symbols and tattoos with such symbols. Sentenced to 1 year 4 months of high-security prison.

## **FYODOROVA OKSANA**

Ukrainian citizen accused of espionage, details unknown.

## **GABIDULLIN ALBERT**

A resident of Davlekanovo, Bashkortostan republic, was previously convicted of criticising the authorities and Russian troops' participation in the war, accused of threatening to kill or cause serious harm to health, for a letter addressed to Ainur Birgalin, the chairman of the Spiritual Administration of Muslims of Bashkiria.

# **GABOV KONSTANTIN**

Charged with being a member of an extremist group for allegedly preparing photos and videos for NavalnyLIVE YouTube channel.faces up to 6 years of imprisonment.

# **GABYSHEV ALEXANDER**

The Yakut shaman was tried for calling for extremist activity and allegedly using violence against a representative of the government because of the 'march to the Kremlin to expel Putin'. Forced psychiatric treatment was ordered.

## **GADZHIMURADOVA HAVA**

A 19-year-old resident of the town of Kizilyurt in the Republic of Dagestan was convicted of participating in an armed formation on the territory of a foreign state, allegedly for a plan to take part in the Islamic State terrorist organisation. She reported being illegally detained and coerced to sign a confession. Sentenced to 5 years low-security prison.



#### **GAEVSKY ANDREY**

Tried for dissemination of 'fake news' about the Russian Armed Forces because of his antiwar publications on the Internet. Mandatory psychiatric treatment was imposed.

## **GAIVORONSKY ALEXANDER**

Convicted of being a member of an extremist group, due to his political activism. Sentenced to 3 years of low-security prison.

#### **GAISIN DANIS**

A father of 4 children accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 police and National Guard with batons dispersed the crowds.

#### **GALIN RAIL**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 police and National Guard with truncheons dispersed the crowds.

#### **GALKIN VLADISLAV**

A scientist from Novosibirsk, was accused of state treason, for a scientific publication in the Iranian Journal of Applied and Computational Mechanics.

## **GALCHEVSKY ANDREI**

A 60-year-old financial director of a business in Kaliningrad was convicted of state treason and of calls to terrorist actions, allegedly for a plan to join the foreign legion of the Ukrainian Armed Forces and an Instagram comment calling for killing of heads of military commissariats in Russia. Sentenced to 11 years of high-security prison.

# **GALETA ANTON**

Convicted of allegedly cooperating with representatives of the armed forces of Ukraine. Sentenced to 12 years of high-security prison.

# **GARANIN ALEXEI**

A blogger and a resident of Pereslavl was accused of inciting hatred or enmity against the police and prosecutor's office, for criticising them. Arrested in February 2023.

# **GASHEV ALEKSEY**

Convicted of treason, allegedly for activities in the interests of the Special Operations Forces of Ukraine. Sentenced to 10 years of high-security prison.

## **GASHIMOVA ULKAR**

Charged with justifying terrorist activities for her anti-war messages in WhatsApp and Signal messengers. In custody since 2023.



#### **GAVRILISHEN VASILY**

Convicted of a terrorist act by committing arson of a military enlistment office. Sentenced to 13 years of high-security prison.

## **GAZIEVA EKATERINA**

Convicted of committing a terrorist act by setting fire to a printing supplies warehouse in Magadan. According to the version presented by law enforcement, she tried to set fire to the military enlistment office, but mistook the other building for the one she intended to commit arson to. Sentenced to 12 years 6 months low-security prison.

#### **GETMAN KIRILL**

Accused of attempted arson of the military enlistment office in the city of Artem, Primorsky Krai.

#### **GIBADULLIN AHAT**

Accused of organising mass riots, in fact for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, more than 1000 policemen and National Guard with truncheons dispersed people.

## **GIRALDO SARAY ALBERTO ENRIQUE**

A Colombian man was convicted of spreading false information about the actions of the Russian army, for sending SMS messages, in particular, about the killing of civilians in Ukraine by Russian soldiers. Sentenced to 5 years 2 months low-security prison.

## **GIZATULLIN RUSLAN**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.

# **GLADKIY PAVEL**

A resident of Stavropol was convicted of state treason and preparing a terrorist act, probably due to his anti-war activism. Earlier the man was tried for discrediting the army and for anti-war leaflets.

# **GLEBOV ARSENIY**

A resident of Chistopol, Republic of Tatarstan, was accused of incitement to mass disorder, participation in an illegal armed formation, and dissemination of 'fake news' about the Russian Armed Forces, allegedly for a plan to fight on the side of Ukraine, also for a comment criticising the Russian authorities and a post about Russia bombing cities and maternity hospitals in Ukraine.

## **GLISKOV ALEXANDER**

The deputy of the Legislative Assembly in Krasnoyarsk Krai was convicted of criticising the authorities and reporting on election violations. Arrested in 2023.



#### **GLUKHOV MIKHAIL**

A resident of the Republic of Mordovia was convicted of state treason for allegedly wanting to fight in the Freedom of Russia Legion. Sentenced to 8 years of high-security prison.

## **GLUSHENKOV SERGEY**

Convicted of state treason for allegedly cooperating with the Freedom of Russia Legion. Sentenced to 4 years 6 months high-security prison.

## **GOLDYCHEV DMITRY**

The resident of St. Petersburg was convicted of attempted participation in an illegal armed formation and attempted treason, allegedly for his plan to fight on the side of Ukraine. Sentenced to 13 years of high-security prison.

#### **GOLOVIN ANDREI**

Convicted of unauthorised abandonment of a military unit. Sentenced to 5 years of low-security prison.

#### **GOLUBEV ANDREI**

Charged with committing an act of international terrorism for allegedly planning to attack a Russian humanitarian convoy and Russian servicemen.

#### **GOLUBEV DENIS**

Accused of a terrorist act in Republic of Chuvashia, for his anti-war action (arson of a relay and battery cabinet).

# **GOLUBEV DMYTRO**

Resident of Melitopol (occupied Zaporizhzhya region), convicted of an act of international terrorism, allegedly for a plan to bomb a road and civil and military administration buildings per the instructions of the Ukrainian Ministry of Defense. Sentenced to 18 years of high-security prison.

## **GOLUBKIN VALERY**

A researcher at the Zhukovsky Central Aerohydrodynamic Institute and professor at MIPT was convicted of state treason, for international scientific activity in creating a hypersonic passenger aircraft HEXAFLY-INT; researchers from the European Union, Russia, and Australia were involved in its development. Before the scientific documents were sent by the employee, three commissions had confirmed that they contained no state secrets. Sentenced to 12 years of high-security.

## **GOLYATIN YEVGENY**

Charged with intentional infliction of minor physical harm on political or ideological grounds for fighting with former members of 'special military operation' and criticising the participation of Russian troops in the war in Ukraine.



#### **GONCHARENKO BORIS**

A resident of Goryachy Klyuch, Krasnodar Region, was charged with terrorism for a failed attempt to set fire to a military recruitment centre.

## **GONCHAROVA (KUTS) VICTORIA**

A resident of Maykop, Republic of Adygea, and an animal rights activist was convicted of dissemination of 'fake news' about the Russian Armed Forces on the grounds of political hatred, allegedly for participating in the Right Sector organisation and also for posting a video on behalf of a witness to the events in Bucha. Sentenced to 6 years and six months of low-security prison.

#### **GORBACHEVSKY ALEXEY**

A participant of the StopXam movement was convicted of assault on police officers, actually for attempting to stop a car that was driving on the sidewalk in violation of traffic rules. The car turned out to be a service car, and the driver and passenger were members of the Grom special unit (Main Department of the Ministry of Internal Affairs of Russia in Moscow). Sentenced to 6 years of low-security prison.

#### **GORELIKOV VLADIMIR**

A Ukrainian citizen was convicted of alleged espionage in favour of China; details of the case are classified. Sentenced to 11 years of high-security prison.

#### **GORINOV ALEKSEY**

A deputy of Krasnoselsky District was convicted of public dissemination of deliberately false information for calling the war in Ukraine a war, voiced the number of dead without referencing official sources and offered to honour their memory with a minute of silence. The new criminal case of justifying terrorism is related to Gorinov's conversations with other prisoners in the hospital at the colony about the attack on the Crimean bridge and about the Azov regiment. Sentenced to 6 years 11 months of low-security prison.

## **GORLANOV INGVAR**

The activist was charged with inciting hatred against representatives of the authorities for criticising judges and police officers and calling them 'rats.' The man was forced to undergo compulsory psychiatric treatment.

## **GOROKHOV YURI**

Convicted of extremist activity, allegedly for spreading the Right Sector ideology among natives of Crimea in the correctional facility #2, Republic of Adygea. Sentenced to 9 years 6 months of special regime.

#### **GORULYOV VLADISLAV**

He was accused of participating in sabotage because he allegedly relayed the location of four transformers, two traffic lights, and two relay cabinets (Kaluga region) for subsequent arson.



#### **GRIGORIEV ALEXEI**

Then, a 25-year-old resident of the Orenburg region was charged with terrorism for alleged preparation to commit arson.

#### **GRISHIN ALEXANDER**

Charged with carrying out activities of an undesirable organisation because of his membership in the New Generation religious organisation.

#### **GROMOVOY DMITRY**

A journalist from Chelyabinsk was charged for illegal production and sale of drugs. In fact, he is persecuted for his journalistic activities. He faces up to 15 years of imprisonment.

#### **GRUNIS ILYA**

Convicted of public justification of terrorism because of alleged intention to commit a terrorist act in a technical college. No evidence in tis criminal case. Ilya was under 18 years old when arrested in 2020. Sentenced to 6 years of low-security prison.

#### **GUBANOV ANATOLY**

Convicted of allegedly transferring information to a European state due to his international scientific work on the development of hypersonic civilian aircraft. Sentenced to 12 years of high-security prison.

## **GUBKIN RUSLAN**

Convicted of discrediting the armed forces because of his anti-war posts on the Telegram social network and for allegedly calling to set fire to military enlistment offices. Sentenced to 3 years low-security prison.

## **GURIKOV ALEXEI**

A Moscow resident was convicted of preparing to commit sabotage, likely an action against the war in Ukraine. Alexei faces up to 20 years of imprisonment.

## **GURULYOV DMITRY**

The businessman was convicted of illegal manufacturing of explosives, confidentially cooperating with a foreign state to the detriment of the Russian Federation, and preparing a sabotage action, allegedly for a plan to set fire to transport infrastructure facilities and cooperation with the Freedom of Russia Legion. Sentenced to 12 years of high-security prison.

## **GURYLYOV ILYA**

Accused of organising a terrorist act because of an alleged attempt to damage electrical equipment on railroad tracks.

# **GURYLYOVA ELENA**

Convicted of treason. Details unknown. Sentenced to 9 years 9 months low-security prison.



#### **GHASSED NEJAD BEHNAZ**

Convicted of treason for allegedly acquiring secret equipment. Sentenced to 12 years low-security prison.

#### **GURDZHIYAN ALBERT**

A resident of Nizhny Novgorod was accused of justifying terrorism, criticising judges with comments about them, calling them 'bandits in robes,' and statements on his YouTube channel criticising the authorities. He was sent for compulsory psychiatric treatment.

#### **HASHEMI DOLABI HAMID**

Convicted of treason for allegedly acquiring secret equipment. Sentenced to 13 years of high-security prison.

#### **IGAMBERDIEV AMAL**

Charged with sabotage in Republic of Chuvashia, for anti-war action (arson of relay and battery cabinet).

#### **IGNATOV IVAN**

Charged with high treason for allegedly passing data on military facilities to the Right Sector.

## **IGNASHOV VADYM**

A sailor from the MSC RICCARDA container ship, accused of spreading extremist materials on social networks, probably for supporting the Ukrainian military.

#### **IGUSHEV NIKITA**

Resident of Syktyvkar was convicted of state treason, allegedly for contact with paramilitary formation on the side of Ukraine. Sentenced to 15 years of prison.

# **IKBAYEV DENIS**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with batons dispersed the crowds.

#### **ILYIN VIKTOR**

In early 2022 he was convicted of alleged espionage in favour of Ukraine, the USA and Great Britain. Sentenced to 9 years of high-security prison.

#### **ILYIN RINAT**

A teenager from St. Petersburg was accused of participating in a terrorist organisation, allegedly for cooperating with the Russian Volunteer Corps. In custody since February 2024.



#### **ILYICHEV VLADIMIR**

A resident of Cherkessk was accused of founding an extremist organisation for his participation in the movement in support of the USSR/RFSR.

# **ILYASOV (ABYALIL) ZAKI**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 police and National Guard with truncheons dispersed the crowds.

#### **ISAKOV ALEKSEI**

Convicted of distributing leaflets about joining the Russian Volunteer Corps fighting for Ukraine. Sentenced to 2 years of correctional facility.

#### **ISAYEV ISMAIL**

Convicted of criticising the regime in the Republic of Chechnya and belonging to the LGBTIQ+ movement. Sentenced to 6 years low-security prison.

## **ISAYEV ABDULKADIR**

Tried on a fabricated case of possession, distribution and manufacture of drugs, in reality he was convicted of picketing in support of political prisoners. Mandatory psychiatric treatment was imposed.

## **ISHKUVATOV KHALID**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. In custody since January 2024.

# **ISHMURATOV ILFAT**

Convicted of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 police and National Guard with batons dispersed the crowds.

## **ISHMURZIN AIGIZ**

He was accused of organising mass riots, in fact for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement, who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.

## **ISLAMGULOV YUNIR**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, more than 1000 policemen and National Guard with truncheons dispersed the crowds.



## **ISLAMOV INSAF**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. Arrested in February 2024.

#### ISMAGILOV FIDAN

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, more than 1000 policemen and National Guard with truncheons dispersed the crowds.

#### **ISRAFAILOV SEYMUR**

A student at Tomsk State University of Control Systems and Radioelectronics has been charged with state treason for allegedly acting on behalf of the Cyber Anarchy Squad, a Ukrainian hacker group.

## **ISYANGILDIN MUNIR**

Convicted of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with batons dispersed the crowds.

#### **IVANOV DMITRIY**

Author of the Protest MGU (Moscow State University) Telegram channel, was convicted of posts about the killing of civilians in Bucha and Irpen and the attack on the Zaporizhzhya nuclear power plant. Sentenced to 8 years 6 months of low-security prison.

# **IVANOV ROMAN**

Convicted of dissemination of 'fake news' about the Russian Armed Forces, in reality persecuted for his journalistic activity. The journalist and editor of Chestnoye Korolyovskoe! VK group published three posts on VK and Telegram channel about bodies found in the Kyiv region after the retreat of Russian troops, a UN report describing the humanitarian situation in Ukraine, and a news article with Sergei Shoigu's statement about Russia's shortage of missiles. Sentenced to 7 years low-security prison.

## **IVANOV VLADIMIR**

A member of the Gelendzhik Human Rights centre was convicted of extortion for the purpose of obtaining property on a particularly large scale, however in reality he was persecuted for his human rights activism. Sentenced to 13 years of high-security prison.

#### **IVANOV DMITRY**

Convicted of allegedly passing information to a NATO country. Sentenced to 13 years of high-security prison.



# **IVANOV ANATOLY**

Convicted of justification of terrorism due to allegedly repeated statements about the correctness and permissibility of ISIS actions. He made those statements while being within the premises of correctional facility #6, Pskov Region. Sentenced to 4 years of high-security prison.

### **IVANOV KONSTANTIN**

A resident of the Sverdlovsk region was accused of committing a terrorist act by allegedly setting fire to a relay cabinet at a railroad crossing.

# **IVANOV IGOR (AIKHAL AMMOSOV)**

Charged with discrediting the armed forces for attaching the poster with a sarcastic representation of 'The Groom has Arrived' scene near the bureau of ritual services, laying flowers in memory of those killed in Ukraine at the Hero City of Kyiv memorial plate and 'No to war!' graffiti.

### **IVANOV ILYA**

A teenager from Krasnoyarsk region was convicted of committing sabotage for allegedly setting fire to two electrical cabinets at a railway station. Sentenced to 5 years 6 months in a correctional facility.

#### **IVANOV SERGEY**

A resident of Novosibirsk was charged with sabotage for allegedly setting fire to a relay cabinet.

# **IVASHEV ANDREY**

Civil activist, public defender, pensioner from Komi convicted of extremist statements, for three comments on social networks in 2020 criticising the Komi authorities. Sentenced to 6 years of low-security prison.

# **IVCHENKO YEGOR**

A resident of Kolpashyovo, Tomsk region, was convicted of public incitement to terrorism and extremism, allegedly for comments calling for violent actions against representatives of state authorities, as well as members of law enforcement agencies. Sentenced to 5 years 6 months of maximum security prison.

## **IZIUMOVA LARISA**

Charged with participating in the activities of an extremist organisation, for participation in a religious organisation of followers of the Allah-Ayat doctrine.



### **IZMAILOVA IRINA**

Charged with state treason and manufacture of explosives because of alleged cooperation with the Special Operations Forces of Ukraine, in reality she is persecuted because her partner eco-activist Alexander Kudashev fights in the Russian Volunteer Corps on the side of Ukraine.

### **KABANOV SERGEI**

Convicted of treason for allegedly smuggling products used in missile equipment of the Russian Armed Forces to a US-controlled firm through Latvia. Sentenced to 12 years 6 months high-security prison.

### **KAVINOV IVAN**

A resident of the city of Kovrov, Vladimir region, was convicted of dissemination of 'fake news' about the Russian Armed Forces with the motive of political hatred, for reporting in a Telegram channel that Russian servicemen were raping, torturing and kidnapping civilians in Ukraine, as well as destroying warehouses with humanitarian aid. Sentenced to 3 years of high-security prison.

### **KAGARLITSKY BORIS**

Sociologist, lecturer at Shaninka and editor-in-chief of the Rabkor Internet media was convicted for anti-war statements about the explosion of the Crimean Bridge. Sentenced to 5 years of low-security prison.

### **KAGARMANOV VADIM**

He was accused of organising mass riots for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement, who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.

# **KADYROV MARAT**

Convicted in a murder case that took place in 2004-2005, essentially for political activity in the team of Sergey Furgal, the former governor of Khabarovsk Krai. Marat suffers from lung cancer, his life is in danger. Sentenced to 9 years 6 months of high-security prison.

## **KAZAKOV DMITRY**

Convicted of treason for allegedly cooperating with the intelligence of a foreign state and transferring official information. Sentenced to 13 years of high-security prison.

## **KAZANKOV IGOR**

A resident of Kaluga was convicted of public demonstration of Nazi symbols, tattoos of Nazi symbols, and ardent Ukrainian patriotism. Sentenced to 3 years of high-security prison.



## **KAZANTSEV EVGENY**

Convicted of participating in the activities of an extremist organisation due to alleged cooperation with the Right Sector organisation. Sentenced to 11 years 11 months of high-security prison.

## **KALINYCHEV GLEB**

Accused of repeatedly discrediting the armed forces of the Russian Federation, for publications 'No to War. No to mobilisation', 'F\*ck the war' and 'Don't shoot', reposting anti-war graffiti in the Nizhny Novgorod Civil Movement group on VK social network, where he was an admin.

### **KALINYCHEV GLEB**

A resident of Nizhny Novgorod, accused of financing an extremist organisation for supporting Navalny's Anti-Corruption Foundation.

### **KAMALETDINOV BULAT**

A student from Kazan was accused of destruction of other people's property because of alleged intentions to set fire to a military enlistment office in protest against mobilisation.

### **KAMARDIN ARTYOM**

The poet was convicted of incitement to hatred or enmity with threat of violence and on calls for anti-state activity for a poem read aloud during the Mayakovsky Readings event. The poet was tortured and forced to record a video in which he was on his knees 'apologising' for the following verse: 'Glory to Kyivan Rus, Novorossiya – suck it.' Doctors refused to hospitalise the poet, ambulance staff in presence of a lawyer, diagnosed him with a concussion, closed head injury, chest contusion and numerous facial abrasions. Sentenced to 7 years low-security prison.

# **KAMBIEVA YULIA**

A resident of Cherkessk was accused of founding an extremist organisation for her participation in a movement in support of the USSR.

# **KAMILYANOVA DIANA**

Accused of organizing the activities of an extremist organization, for the activities of the LGBT club, for propaganda of 'non-traditional sexual relations'.

# **KAMLASH GEORGY**

A resident of the Samara region was convicted of state treason for allegedly corresponding with a representative of the Ukrainian secret service and intelligence. Sentenced to 13 years of high-security prison.



### **KAMYNIN DMITRY**

Convicted of drug distribution and extortion, he was persecuted for human rights activism within the Sibir Pravovaya organisation. He helped those who came out of prison and reported on violations of the prisoners' rights to journalists. Sentenced to 18 years of high-security prison.

### **KARAEV DENIS**

A 28-year-old resident of the Tambov region was charged with sabotage, allegedly for a plan to set fire to an energy infrastructure facility and one of the administrative buildings of the regional centre, and support for the Artpodgotovka movement.

### KARACHURIN VILYUR

Accused of organising mass riots for demanding the release of a Bashkir activist and exleader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.

### **KARELIN SERGEY**

A video journalist and cameraman who cooperated with Associated Press, accused of participating in an extremist group for preparing materials for the Navalny Live YouTube channel.

### KARELINA KSENIA

A citizen of the Russian Federation and the United States convicted of state treason for transferring 51.8 U.S. dollars from her U.S. bank account to the account of the Razom for Ukraine Ukrainian foundation. Sentenced to 12 years of low-security prison.

### KAREPOV ANDREI

Convicted in a murder case that took place in 2004-2005, he was persecuted for his political activity in Sergei Furgal's (the opposition ex-governor of Khabarovsk Krai) team. Sentenced to 21 years of high-security prison.

# **KARIMOV ARTUR**

Accused of organising mass riots for demanding the release of a Bashkir activist and exleader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.

## **KARIMOV AYNUR**

Accused of organising mass riots for demanding the release of a Bashkir activist and exleader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.



### KARIMOV IDEL

Accused of organising mass riots for demanding the release of a Bashkir activist and exleader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 police and National Guard with truncheons dispersed the crowds.

### **KARPOV NIKITA**

Convicted of public calls to extremist activity because of allegedly repeated stories of other convicts about the Azov brigade. Sentenced to 3 years of low-security prison.

### KARTOPOLOV ANDREI

A resident of Gorno-Altaisk was convicted of participating in the activities of an extremist organisation for participation in meetings of the 'Citizens of the USSR' movement. Sentenced to 2 years 6 months low-security prison.

#### **KATELEVSKY YAN**

A journalist of the 'Rosderzhava' publication was convicted of extortion for the purpose of obtaining property on a particularly large scale and insulting an official, in reality he was persecuted for his professional activities and investigations on his YouTube channel. Sentenced to 9 years 6 months of high-security prison.

### KATORZHNYKH ALYONA

Charged with attempted arson of military enlistment office in Vladivostok. Details unknown. Sentenced to 6 years low-security prison.

# **KATRYCHKO ARTUR**

Convicted of state treason, allegedly for cooperation with Special Operations Forces of Ukraine. Sentenced to 12 years of high-security prison.

### **KACHIN VALERY**

A geologist and scientist was accused of state treason for allegedly trying to leave the region and fly abroad for permanent residence and acquisition of Ukrainian citizenship and service in the Ukrainian Armed Forces.

# KEREKESHA ALEXANDER (OLEKSANDR VOLODYMYROVYCH KEREKESHA)

A 61-year-old head of the Kherson track department of the Odessa railroad, was convicted of sabotage for instructing his subordinates to damage the switches of the Kherson railway station, which prevented the Russian Ministry of Defense from organising transportation. Sentenced to 6 years 6 months of high-security prison.

## **KHAIBULLIN GAZIZYAN**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, more than 1000 policemen and National Guard with truncheons dispersed the crowds.



### **KHAKIMOV DANIL**

19-year-old Convicted of plan to commit violent seizure of power. Sentenced to 16 years of high-security prison.

### **KHALIDOV YASIN**

A 19-year-old policeman was detained for passing information to human rights activists about Chechen law enforcement agencies: human rights violations, secret operations, illegal developments and provocations in Chechnya and Ukraine. After the detention he was taken to Chechnya, after which he disappeared.

## KHAMROEV BAKHROM

Human rights activist convicted of propaganda of terrorism for Facebook posts allegedly related to the Hizb ut-Tahrir organisation banned in Russia. Sentenced to 13 years 9 months of high-security prison.

### **KHARITONOV MAXIM**

A resident of Kurgan Region was accused of cooperating with a Ukrainian organisation banned on the territory of the Russian Federation, allegedly for distributing pro-Ukrainian materials. Sentenced to 5 years of prison.

### KHASANOV VYACHESLAV

Charged with organizing the activities of an extremist organization, for the activities of the Pose LGBT club for propaganda of 'non-traditional sexual relations'. Arrested in March 2024.

## **KHAUTIEV BAGAUDIN**

Convicted of using violence against law enforcement officers because of participation in protests in Magas against the establishing of the new border between Ingushetia and Chechnya. Sentenced to 8 years of low-security prison.

## **KHAZHIYEV ILNUR**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. Arrested in January 2024.

### **KHAZHIN FANUR**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 police and National Guard with batons dispersed the crowds.

## **KHAZOV ALEXANDER**

A Moscow resident was charged with promoting terrorist activity for donating \$55 to the Ukrainian RDK. Details unknown.



### KHISAMETDINOV YUNIR

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. Arrested in February 2024.

### KHISMATULLIN ZINUR

Accused of organising a terrorist act because of an alleged attempt to damage electrical equipment on railways.

### **KHOLODNY DANIEL**

Convicted of participating in an extremist group because of his work as technical director of NavalnyLIVE. Sentenced to 8 years low-security prison.

## **KHOROSHENIN VALENTIN**

Convicted of the activity of NGOs infringing on the rights of citizens and the article for incitement to mass disorder, in fact for participation in the Vesna democratic movement, which called for participation in anti-war protests. In custody since June 2023.

## **KHRIPKO ANTON**

A 19-year-old man, accused of forming a terrorist group for allegedly planning to dig into a military unit near Moscow to blow up equipment and set fire to it. Anton faces up to 20 years of imprisonment.

### **KHRIPKO IVAN**

A resident of Yaroslavl was charged with terrorism for a failed attempt to set fire to a transformer booth. Ivan is 23 years old, he faces 20 years of imprisonment.

## KHURTSILAVA GIORGI

Convicted of treason for allegedly cooperating with Georgian special services and the FBI. Sentenced to 12 years of high-security prison.

## **KHUSAINOV AYNUR**

Accused of organising mass riots, in reality for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement, who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with batons dispersed the crowds.

### KHVAN VLADIMIR

Sentenced a resident of Primorye of confidential cooperation with a foreign organisation, allegedly for attempting to contact the Freedom of Russia Legion, a terrorist organisation recognized in the Russian Federation. 3 years 6 months low-security prison.



### **KIDRASOV ILMIR**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, more than 1000 policemen and National Guard with truncheons dispersed the crowds.

### **KILDIYAROV VADIM**

A resident of Ufa was accused of preparing for a terrorist act, allegedly for a plan to set fire to the republic's administrative buildings – the Government House, State Assembly and others.

### **KIM YEGOR**

A 17-year-old teenager was convicted of preparing for a terrorist attack for allegedly intending to set fire to a power plant in Kaluga Region per the instructions of the Russian Volunteer Corps. Sentenced to 6 years in a correctional facility.

#### KIM MAXIM

Accused of committing a terrorist act by setting fire to the Museum of History of so-called 'Special Military Operation' in Saratov per the instructions of fraudsters.

### KINYABUZOVA SALIMA

Charged with organising mass riot for demanding the release of a Bashkir activist and exleader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 police and National Guard with truncheons dispersed the crowds.

## **KIRILLOV MATVEY**

Accused of sabotage, allegedly for setting fire to relay and battery cabinets in Chuvashia.

# **KISELEV DMITRY**

Condemned for sabotage and state treason, allegedly for transfer of data to employees of the Security Service of Ukraine and a plan to set fire to railway objects. Sentenced to 13 years in high-security prison.

## **KISLITSYN MARK**

Convicted of treason for allegedly transferring funds to the Armed Forces of Ukraine. Sentenced to 12 years in low-security prison.

# **KITIKOV AITUGAN**

Accused of organising mass riots after demanding the release of a Bashkir activist and former leader of the Bashkort movement who had spoken out against the war. Approximately 10 000 people gathered in front of the courthouse in Baymak in support, the crowd was forcibly dispersed by over 1000 police officers and National Guard members armed with batons.



### **KIYASHKO IHOR**

Ukrainian citizen convicted of espionage for allegedly preparing for smuggling. Testimony was extracted under torture. Sentenced to 8 years in high-security prison.

## **KIZEVALTER ANDREI**

A resident of Mozhaisk, Moscow oblast, was charged with vandalism for pouring yellow paint on a pro-war poster with the letter Z on it. He was sent for compulsory psychiatric treatment.

### KLIMASHEV ANDREI

Convicted of using violence against a representative of the authorities for allegedly fighting with policemen at a rally in support of Alexei Navalny. Sentenced to 5 years 6 months in low-security prison.

## **KLIMKIN ANTON**

A research associate at the Zuev Institute of Atmospheric Optics is being accused of confidential cooperation abroad with a foreign organisation under a contract with China that dates back ten years, essentially for engaging in professional scientific activity.

## **KLYMETS PAVLO**

Businessman convicted of attempting to give a particularly large bribe, probably for political activity: the man was a deputy of the Verkhovna Rada of Ukraine. Sentenced to 9 years in high-security prison.

### **KLYUKA DANIIL**

An art teacher from Lipetsk convicted of promotion of terrorist activity for transferring about 200 euros to the Ukrainian Azov battalion. Sentenced to 20 years in high-security prison.

# **KLYUNYA NIKITA**

19-year-old activist, deputy chairman of the Civil Alliance of Russia in Sortavala, Republic of Karelia, was convicted of creating a 'terrorist organisation and treason', allegedly for a plan to take part in sabotage on the railroad. Sentenced to 14 years in high-security prison.

### **KOBZEV VADIM**

Charged with participating in the activities of an extremist organisation, for being Alexei Navalny's lawyer. In custody since October 2023.

### **KOKIN NIKITA**

A 17-year-old resident of Voronezh region was accused of preparing for sabotage, for tampering with cabinets on the railroad. In Custody since January 2024.

### **KOLGANOV YURI**

A builder from Ivanovo was charged with state treason for two transfers totaling just over \$30 through the cryptocurrency exchange Bice to the cryptocurrency wallet of the Freedom of Russia Legion.



### **KOLIN NIKOLAI**

Convicted of treason and financing of terrorism because of allegedly sending 5000 rubles (50 euros) to the Russian Volunteer Corps. Sentenced to 14 years in high-security prison.

# **KOLIN SERGEY**

The creator of the Kupala TV YouTube channel, a figure in the anti-war case, accused of wanting to join the Freedom of Russia Legion, was declared insane and sent for compulsory treatment in a psychiatric hospital.

## **KOLISTRATOV PYOTR**

A resident of the Rostov region was convicted of treason for allegedly planning to join a Ukrainian military unit. Sentenced to 8 years in high-security prison.

### **KOLOMIYKO NIKITA**

17-year-old convicted of a plan to commit a violent seizure of power. Sentenced to 9 years of low-security prison.

# **KOLOMYTSEV VLADIMIR**

Accused of participation in the activities of an extremist organisation, for participation in a religious organisation of followers of the Allah-Ayat doctrine.

## **KOLOSOV IVAN**

A doctor from Krasnogorsk was charged with attempted participation in an illegal armed group, allegedly for trying to join the Freedom of Russia Legion and comments about a 'Russian warship.' Arrested in March 2023.

# **KOLTSOV VITALY**

Convicted of intentional destruction of property due to arson of two prisoner transport vehicles. Sentenced to 6 years in low-security prison.

### **KOLYADINA NATALIA**

Accused of terrorism for attempting to set fire to a military recruitment centre. Arrested in August 2023.

## **KOMANDIROV SERGEY**

Convicted of public justification of terrorism, due to the publication of a clip from the opposition web series on VK social network. Sentenced to 6 years 6 months in low-security prison.

### **KOMLEVA OLGA**

A Journalist was accused of participating in an extremist group for allegedly participating in the activities of Alexei Navalny's Anti Corruption Foundation. In custody since March 2024.



### KONASHENOK NIKOLAI

An interior designer accused of justifying terrorism for posting about the terrorist attack at Crocus City Hall on social media. In his post, he wondered why terrorists attacked Crocus instead of the Kremlin. In custody since March 2024.

### **KONDRATIEV MAXIM**

Convicted of treason for allegedly passing information and activities of the FSB to the Ministry of Security of the People's Republic of China. Sentenced to 14 years in high-security prison.

#### **KONDRATSKY IGOR**

Ex-advisor of the Russian Embassy in France, the diplomat was convicted of state treason, allegedly for the transfer of information constituting a state secret. A native of Kyiv, the diplomat was deprived of his military rank - colonel of the reserve. Sentenced to 18 years in high-security prison.

### **KONOVALOV FYODOR**

A cleaner of service premises of the Shostakovich Philharmonic in St. Petersburg accused of incitement to terrorism for distributing leaflets calling to join the Russian Volunteer Corps and the Freedom of Russia Legion.

### **KONOKOV ERIC**

A resident of Kabardino-Balkaria has been sentenced under charges of publicly inciting extremist activities online, as well as in a case involving an attempt to commit treason, allegedly for planning to fight against the Russian Armed Forces. Sentenced to 6 years in high-security prison.

## **KOPYLENKO DANIIL**

A resident of Unecha, Bryansk region, convicted of a terrorist act for planning to set fire to the office of United Russia political party. Sentenced to 7 years in high-security prison.

# **KORHOV SERGEY**

Accused of creating a terrorist organisation, allegedly for a plan to dig a tunnel into a military unit near Moscow to sabotage equipment and commit arson.

# **KORKACH ILYA**

The man was accused of participation in a terrorist organisation, allegedly for a plan to dig a tunnel into a military unit near Moscow to sabotage equipment and set the place on fire. Ilya faces up to 15 years of imprisonment.

## **KORMISHENKO ALEXANDER**

He was accused of creating a non-commercial organisation that infringes on the personal rights and freedoms of citizens due to its membership in the Russian Orthodox Church of the Tsarist Empire movement.



### **KORNEEV SERGEY**

A resident of Miass, Chelyabinsk region, sentenced for publicly inciting activities against state security, due to posts calling for sabotage of mobilisation activities and military operations. Sentenced to 2 years in low-security prison.

## **KORNILEVSKY SERGEI**

Theatrical figure and journalist of the Bira state TV and radio company was convicted of justification of terrorism for a Facebook post about mobilisation. Sentenced to 2 years 6 months in low-security prison.

### **KORNY YURY**

Convicted of participating in the activities of a terrorist organisation, allegedly for preparing to set fire to hay on Manezhnaya Square in Moscow. Sentenced to 10 years in high-security prison.

### **KOROLEV VSEVOLOD**

The author of a documentary film convicted of disseminating deliberately false information about the armed forces of the Russian Federation, for two posts on the VK social network about the massacre of civilians in Bucha, Borodyanka, as well as the shelling of Donetsk. Sentenced to 7 years in low-security prison.

### **KORSHUNOV PAVEL**

Resident of Togliatti, Samara region, convicted of terrorism and vandalism, for the failed arson attack on the Togliatti administration building and attempt to prevent mobilisation. Sentenced to 13 years in high-security prison.

### **KOTIKOV YEVGENY**

Sentenced for unlawful interference with critical information infrastructure of Russia due to his alleged support of the Ukrainian government and DDoS attacks on the websites of the Russian Ministry of Defense. Sentenced to 3 years in a correctional facility.

# **KOTOV KIRILL**

A participant of the StopXam movement convicted of assault on police officers, effectively for attempting to stop a car that was violating traffic rules by driving onto the sidewalk. The car turned out to be a service vehicle, and the driver and passenger were officers from the Main Directorate of the Ministry of Internal Affairs of Russia in Moscow. Sentenced to 6 years of low-security prison.

## **KOTOVICH VALERY**

An ex-head of the procurement department of the Southern Logistics centre of the National Guard convicted of dissemination of 'fake news' about the Russian Armed Forces, for commenting on the Russian army as an occupant and aggressor. Sentenced to 6 years in low-security prison.



### **KOSHEVOY SEMYON**

A 19-year-old resident of Tver was charged with state treason, allegedly for an attempt to join the Freedom of Russia Legion.

### **KOSHELEV VYACHESLAV**

Accused of assaulting a police officer during detention, in reality for a cap and sweatshirt with the Ukrainian flag and inscriptions in Ukrainian. Forced psychiatric treatment was appointed.

### **KOVALENKO ANDREI**

Convicted of financing the activities of an extremist organisation for allegedly sending money to Alexei Navalny's Anti Corruption Foundation. Sentenced to 5 years in low-security prison.

### **KOVAL MIKHAIL**

Accused of cooperating with an undesirable organisation, due to the interaction of the Revival Ukrainian Pentecostal Church with foundations, allegedly for collections for the needs of the Ukrainian Armed Forces.

### **KOVYLKOV ILYA**

Charged with participating in the activities of a terrorist organisation for alleged membership in the Azov battalion and the dissemination of information about it. Arrested in March 2024.

### **KOZADAEVA EKATERINA**

Charged with participating in the activities of an extremist organisation, for participation in a religious organisation of followers of the Allah-Ayat doctrine.

## **KOZIN ALEXANDER**

Convicted of participating in a terrorist organisation because of alleged membership in the Making the Revolution club. Sentenced to 19 years in high-security prison.

# **KOZYREVA DARYA**

Anti-war activist was accused of repeatedly discrediting the armed forces of the Russian Federation, for a poster pasted on a monument to Taras Shevchenko, with a fragment of text from Shevchenko's poem, Testament. She was expelled from St. Petersburg State University, Faculty of Medicine.

### **KRASILNIKOV NIKITA**

A resident of St. Petersburg, accused of participation in a terrorist organisation, allegedly for cooperation with the Russian Volunteer Corps.

### **KRAVAL VLADISLAV**

A resident of Ukhta, Komi republic, was convicted of vandalism for defacing a banner with the letter Z on the local palace of culture and the inscription 'F\*ck the war' in white and blue colours. Sentenced to 6 years and 3 months in low-security prison.



## **KRAVTSOVA ANTONINA (FAVORSKAYA)**

Correspondent of the online publication SOTAvision accused of participation in the activities of an extremist organisation because of his alleged cooperation with Alexei Navalny's Anti Corruption Foundation.

## **KRAYCHIK ALEXANDER (KATAEV ALEXEI)**

Accused of financing terrorism, for transferring 50 euros to the Ukrainian armed forces two days after the start of Russia's invasion of Ukraine.

### **KRESHCHUK NIKITA**

A resident of Moscow convicted of organising mass disturbances for political activities and managing regional chats in a Telegram channel. He was accused of calling for protest during the 2021 State Duma elections. Sentenced to 6 years in low-security prison.

#### KRIEGER ARTYOM

A journalist accused of participation in the activities of an extremist organisation because of his alleged cooperation with Alexei Navalny's Anti Corruption Foundation.

## **KRIZHANOVSKYI SERGEY**

A resident of occupied Kherson region, convicted of espionage, allegedly for cooperation with Special Operations Forces of Ukraine. Sentenced to 11 years and 6 months in high-security prison.

### KRINARI DANIIL

Convicted of confidential cooperation with a foreign state to the detriment of Russia for his active civic engagement as a participant in the Vesna democratic movement, managing an opposition Telegram channel and TikTok account, and participating in protests. Sentenced to 5 years in low-security prison.

# **KRYSEVICH PAVEL**

An artist convicted of hooliganism, for a performance on Red Square, where Pavel fired two blank shots from a pistol into the air and one into his head, symbolising the need to kill the fear of impending totalitarianism. Sentenced to 5 years in low-security prison.

# **KSENZHEPOLSKI JAN**

Charged with NGO activity, infringing on the rights of citizens, and an article for incitement to mass disorder, effectively for participation in the Vesna democratic movement, which called for participation in anti-war protests.

## **KUDENKOV RADISLAV**

Accused of allegedly setting fire to a cell tower of Megafon mobile network company in a forest belt of the city.



### **KUDRYASHOV DMITRY**

The founder of the Russian Russia channel from Moscow was tried for laying a pig's head at the monument of Akhmat Kadyrov in Southern Butovo, Moscow.

### **KUDRYASHOV IVAN**

Convicted of planning a terrorist act due to alleged intentions to set fire to a military recruitment centre and anti-war publications on the Internet. Sentenced to 4 years and 6 months in high-security prison.

### **KUKSOV VASILY**

Convicted under the article on organising a terrorist community, effectively for political activity by the Set' ('Network') anti-fascist and anarchist group. Members of Set' reported torture. 9 years in a general regime prison. Sentenced to 9 years in low-security prison.

### **KULACHENKOV DMITRY**

A Moscow resident was charged with displaying extremist symbols and incitement to terrorism for a comment in the Freedom of Russia Movement Telegram chat room with an image of a tricolour white-blue-white flag, and a comment supporting the actions of the Freedom of Russia Legion in the chat room.

### **KULIGIN YAROSLAV**

Accused of committing sabotage due to allegedly several attempts to set fire to the transportation infrastructure of the Moscow region.

## **KULIKOV YAROSLAV**

The Vladivostok resident was convicted of state treason, allegedly for transferring photos of a combined heat and power plant (CHP) to Ukrainian intelligence, effectively for his anti-war stance and criticism of the current government. Sentenced to 12 years in high-security prison.

# **KULIKOV VSEVOLOD**

An 18-year-old student from Lipetsk was convicted of treason for allegedly sending applications to Azov and Russian Volunteer Corps. Sentenced to 9 years of high-security prison.

### **KULKOV MIKHAIL**

Convicted under the article on organising a terrorist community, effectively for political activity by the Set' ('Network') anti-fascist and anarchist group. Members of Set' reported torture. Sentenced to 10 years in high-security prison.

## **KULMUKHAMETOV ZAKIR**

Accused of organising mass riots after demanding the release of a Bashkir activist and former leader of the Bashkort movement who had spoken out against the war. Approximately 10 000 people gathered in front of the courthouse in Baymak in support, the crowd was forcibly dispersed by over 1000 police officers and National Guard members armed with batons.



### **KUPRIN VLADIMIR**

Convicted of anti-war posts in a social network. Sentenced to 5 years of low-security prison.

### **KURANOV ALEXANDER**

76-year-old physicist, a Head of the Scientific Research Enterprise of Hypersonic Systems was convicted of state treason, effectively for scientific activity. Sentenced to 7 years in high-security prison.

### **KURYLENKO SERGEY**

A resident of Norilsk was accused of calling for extremism, for the dissemination of 'fake news' about the Russian Armed Forces on the grounds of political hatred, and for posts criticising the war in Ukraine.

### **KURLOV ALEXEI**

Convicted of organising mass riots, for political activity and maintenance of regional chat rooms of the What to do! Telegram channel, as well as calls to express an opposition position in the election of deputies to the State Duma in 2021. Sentenced to 6 years in low-security prison.

### **KURSAKOV IHOR**

Charged with preparation in a terrorist act, allegedly for an explosive device and symbols of the Ukrainian Azov.

### **KUSAKIN KIRILL**

An activist from Moscow region was convicted of sabotage, for attempting to set fire to a relay cabinet and battery cabinet. Sentenced to 12 years in high-security prison.

## **KUSARBAYEV AZAT**

Accused of organising mass riots, for demanding the release of a Bashkir activist and exleader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, more than 1000 policemen and National Guard with truncheons dispersed the crowds.

## **KUSONETS EGOR**

Accused of sabotage, allegedly for arson of relay and battery cabinets in Chuvashia.

### **KUTSEV ILYA**

A 19-year-old man was convicted of participation in an illegal armed formation, allegedly because he wanted to participate in the Ukrainian Freedom of Russia Legion, but did not admit guilt. Sentenced to 7 years in high-security prison.

# **KUZHEV OLEKO**

A resident of Cherkessk was accused of founding an extremist organisation for participation in a movement in support of the USSR/RFSR.



### **KUZIN ALEKSEY**

A Ukrainian citizen convicted of rehabilitation of Nazism, for a protest against Russian military symbols on the territory of the Sapun Gora memorial complex. Sentenced to 1 year 6 months in a correctional facility

### **KUZNETSOV IGOR**

RusNews journalist convicted of organising mass riots, for political activity and maintaining regional chat rooms of the What to do! Telegram channel, as well as calls to express an opposition stance in the election of deputies to the State Duma in 2021. Sentenced to 6 years in low-security prison.

### **KUZNETSOV VYACHESLAV**

Resident of Menzelinsk, Republic of Tatarstan, convicted of treason and a terrorist act, allegedly for cooperation with the Freedom of Russia Legion. Sentenced to 9 years in high-security prison.

### **KUZOVKIN GERMAN**

Convicted of an attempted terrorist act due to arson of a military registration office in the city of Asha, Chelyabinsk region. Sentenced to 5 years in low-security prison.

### **KVITKOVSKY ROMAN**

The blogger was convicted of insulting the feelings of believers in places of worship, for playing a video during church service, where church is called 'useless bullshit'. Sentenced to 2 years 3 months of correctional facility.

## **LAVRENTIEV LEONID**

Convicted of participating in an extremist group, actually for political activism. Sentenced to 3 years of low-security prison.

### **LAVRENTIEV MAXIM**

Accused of hooliganism and willful infliction of minor harm to health and assault on a representative of authority for videos on his YouTube-channel about human rights violations.

## **LAGOIDA YEVGENY**

A Vyborg resident was convicted of a terrorist act for an alleged plan to set fire to a Ministry of Defense facility. Sentenced to 6 years of high-security prison.

### LAGUTKIN VLADISLAV

Charged with using violence against a representative of the authorities for allegedly fighting with police officers at a rally in support of Alexei Navalny. Sentenced to 4 years of forced labour in a correctional facility.



### LAZAKOVICH MIKHAIL

Then 18-year-old resident of Tver was convicted of a terrorist act, for anti-war stance and an attempt to set fire to the wall of the military enlistment office. Sentenced to 11 years of high-security prison.

### LAZOVOY ROMAN

Accused of attempted arson of the military enlistment office in the town of Artyom, Primorskiy Krai.

## **LALETINA TATYANA**

Then 21-year-old artist was convicted of high treason, allegedly for donating \$30 in favour of the Ukrainian Armed Forces. Sentenced to 9 years in low-security prison.

### LAMANOV DMITRY

A resident of Nadym was convicted of inciting a riot, for his political activity and calls to express an opposition position in the election of State Duma deputies in 2021 through regional chat rooms in a Telegram channel. Sentenced to 6 years in low-security prison.

## **LANCHEKOV ANATOLY**

Convicted of justification of terrorism and illegal trafficking of ammunition because of antiwar and anti-Putin publications on the Odnoklassniki social network. Sentenced to 8 years of general security prison.

### LARIN ALEXANDER

A resident of Togliatti was convicted of participating in the activities of an extremist organisation for his involvement with the Citizens of the USSR organisation. Sentenced to 5 years of general security prison.

## **LARIONOV ROMAN**

Then 18-year-old resident of Saratov was accused of high treason for allegedly crossing the border and planning to fight on the side of Ukraine.

### LASZLO DANIEL

Then 18-year-old resident of Yaroslavl was convicted of preparing for a terrorist act, allegedly for an attempt to set fire to a telecommunications tower. Sentenced to 10 years 6 months of high-security prison.

# **LEVADNY ALEXANDER**

A Murmansk resident has been convicted of high treason and sentenced to 17 years in a high-security prison. The charges stem from an unsuccessful attempt to set fire to a military enlistment office in protest against the war in Ukraine, as well as telephone conversations with a friend fighting on the Ukrainian side. The individual reportedly endured torture by electric shock during the investigation.



### LEVICHEV ALEKSANDR

Then 16-year-old gymnasium student from Krasnoyarsk was accused of preparing for an act of terrorism, allegedly for trying to acquire components for a homemade explosive device.

### LEVCHENKO IGOR

A Russian-Ukrainian citizen from Krasnogorsk, a singer and a music teacher, was convicted of inciting hatred, as well as humiliation of human dignity, for a pacifist song and an anti-war video on his Instagram on February 24, 2022. Sentenced to 3 years of low-security prison.

### **LEVCHENKO ARSENY**

A 17-year-old resident of Krasnodar was convicted of preparing for homicide, allegedly for taking selfies against the background of the military enlistment office and planning to blow up the military enlistment office.

### LEVCHISHIN ALEXANDER

A programmer from the Irkutsk region was accused of unlawful impact on the critical information infrastructure of the Russian Federation.

### **LEGKOBITOV SERGEY**

Convicted of bribery mediating for human rights activities conducted by his father. Sentenced to 7 years 6 months low-security prison.

## **LEDKOV KONSTANTIN**

A resident of the village of Krasnoye, Nenets Autonomous District, was accused of repeatedly discrediting the armed forces, calling for activities against the security of the state, for making an anti-war statement in a bar. Earlier the man was fined for graffiti with the words 'no to war'.

## **LEKOMTSEV NIKOLAI**

Accused of participating in an extremist organisation, for participation in social networks of the Artpodgotovka movement.

## **LERMAN LEV**

Opposition activist was convicted of illegal possession of ammunition, for Facebook posts against the authorities and calls to protest against the regime. Sentenced to 4 years in a correctional facility.

### **LESNOY ARSENIY**

Convicted of participating in a terrorist organisation because of alleged membership in the Making the Revolution club. Sentenced to 18 years of high-security prison.

### **LIMESHKO GENNADIY**

A Ukrainian citizen was convicted of manufacturing homemade explosives for allegedly intending to blow up an electric pole in Crimea per the instructions of the Security Service of Ukraine. Sentenced to 8 years low-security prison.



### **LINTSOV SERGEY**

Accused of spreading false information about the Russian army for an anti-war video.

### LIPTSER ALEXEY

Accused of the activity of an extremist organisation for Alexey Navalny's lawyer.

# **LISITSYN IGOR**

Convicted of threatening to inflict grave harm and intentional infliction of grave harm due to the protection of the natural territory around the Klyazma River, where since 2022 construction debris were brought to strengthen the bank for construction. Sentenced to 4 years 6 months low-security prison.

## LIVENTSEV SERGEI

Accused of desecration of monuments and other memorial structures because of the inscription 'HUR' (Main Directorate of Intelligence of the Ministry of Defense of Ukraine) on the monument to Marshal Zhukov.

#### LIZUNOVA LYUBOV

Then 16-year-old teenager from Chita, an anarchist was convicted of incitement to extremism for posts in two Telegram channels about protests against the war in Ukraine, in which she expressed approval of arson and sabotage of military facilities. Sentenced to 3 years 6 months of low-security prison.

### **LOBANOV VLADISLAV**

A resident of Nizhny Novgorod was accused of cooperating on a confidential basis with representatives of the Special Operations Forces of Ukraine and attempting to take part in an armed conflict on the side of Ukraine.

## **LOBUNICHEV ALEXANDER**

A 16-year-old teenager was accused of trying to set fire to a military recruitment centre.

# LOPATNIKOV SERGEI

Convicted of abuse of dead bodies and their burial places due to alleged picnic, jumping over the Eternal Flame monument and stealing a basket with flowers at the memorial complex to 1200 Guardsmen in Kaliningrad. Sentenced to 1 year of correctional facility.

### **LUGOVOI ANDREY**

Accused of spreading false information about the army on the motive of political hatred, for anti-war posts.

### **LUGOVOI ILYA**

Convicted of a plan to commit violent seizure of power. Sentenced to 16 years of high-security prison.



### **LUKASHIN SERGEY**

Convicted of using violence against a representative of the authorities for allegedly fighting with police officers at a rally in support of Alexei Navalny. Sentenced to 4 years of low-security prison.

### **LUKIN IVAN**

A businessman from Blagoveshchensk was charged with state treason for allegedly spying for China.

## **LUKYANOV ALEXEI**

Convicted of using violence against a representative of the authorities for allegedly fighting with police officers at a rally in support of Alexei Navalny. Sentenced to 4 years low-security prison.

### **LUKYANOVA TATYANA**

Activist was charged with incitement to hatred or enmity, for a solitary picket with a poster 'Freedom to political prisoners', shouting slogans 'Freedom to Furgal' and 'Freedom to political prisoners'.

## **LUTOR VYACHESLAV**

Resident of Krasnoyarsk convicted of state treason and participation in a terrorist organisation, allegedly for correspondence with the Freedom of Russia Legion. Sentenced to 10 years of high-security prison.

### **LUSHKO IGOR**

Convicted of arson on the railroad and alleged intention to fight in the Freedom of Russia Legion. Sentenced to 20 years of high-security prison.

## LYALYAEV DMITRY

Convicted of dissemination of 'fake news' about the Russian Armed Forces because of antiwar publications about the shooting of civilians in Bucha. Sentenced to 2 years 2 months in a correctional facility.

### LYAMIN DMITRY

Convicted of terrorist act, allegedly for attempting to set fire to the military enlistment office in the city of Shuya. Sentenced to 8 years of high-security prison.

### LYPKAN MAXIM

Tried for spreading false information about the Russian army, for his anti-war publications on the Internet. Forced psychiatric treatment was appointed.

### LYUBASHENKO KRYSTYNA

An activist convicted of participating in the activities of a terrorist organisation and dissemination of 'fake news' about the Russian Armed Forces, for attempting to launch white-bluewhite balloons in Moscow as a 'peaceful action against war'. Sentenced to 12 years of low-security prison.



### LYUBSHIN IVAN

A resident of Kaluga was convicted of justification of terrorism, for a comment justifying the self-detonation of a 17-year-old teenager in the building of the Russian Federal Security Service. Reported being tortured and beaten, the European Court of Human Rights awarded compensation for an uninvestigated torture case. Sentenced to 5 years 2 months low-security prison.

### **MAGADEEV AIDAR**

Accused of organising mass riots after demanding the release of a Bashkir activist and former leader of the Bashkort movement who had spoken out against the war. Approximately 10 000 people gathered in front of the courthouse in Baymak in support, the crowd was forcibly dispersed by over 1000 police officers and National Guard members armed with batons.

### **MAGALYAS PAVEL**

Convicted of hooliganism for an unsuccessful attempt to set fire to the building of the Kamyshin city administration in protest against the war in Ukraine. Sentenced to 2 years 6 months low-security prison.

#### **MAGAMADOV SALEH**

Convicted of criticising the regime in the Republic of Chechnya and belonging to the LGBTIQ+ movement. Sentenced to 8 years of high-security prison.

### **MAGDIYEV SHAMIL**

A resident of Dagestan was accused of dissemination of 'fake news' about the Russian Armed Forces, for publishing a video of the Ukrainian Spiritual Administration of Muslims of Crimea movement. Sent for compulsory psychiatric treatment.

# **MAGOMEDOV MAGOMED**

Convicted of attempted treason for allegedly intending to cross the Belarus-Russia border, go to Ukraine and join the Russian Volunteer Corps. Sentenced to 9 years of high-security prison.

# **MAKAYEV RADIK**

A judoist from Togliatti was charged with state treason for allegedly trying to join the Freedom of Russia Legion.

# **MAKARENKO YEVGENIYA**

Convicted of drug smuggling because of receiving a parcel from a friend in the USA, the contents of which were replaced on the territory of the Russian Federation. Sentenced to 10 years 3 months low-security prison.

## **MALABAEV AITUGAN**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.



# MALAKHOV VYACHESLAV (VALAAR MORGULIS)

The author of the Pre-revolutionary Advisor music and performance band and poet from Moscow was accused of repeatedly discrediting the army, for speaking out against Putin and posting: 'Russia: you want to attack us and kill us. Ukraine: we don't want anything like that. Russia: is attacking Ukraine. Ukraine: and now we want to attack you and kill you. Russia: now it's okay!'.

#### MALINA VLADIMIR

A bartender from Moscow was convicted of sabotage and participation in a terrorist organisation, for attempting to set fire to a relay cabinet, allegedly for cooperation with the Freedom of Russia Legion. Sentenced to 25 years of high-security prison.

### MALUSHENKO VLADISLAV

Administrator of the Project Scanner and Riddle Telegram channels, convicted of extortion of Vasily Brovko, the Rostec director for special assignments and his wife Tina Kandelaki, actually he was persecuted for his professional activities. Sentenced to 7 years of high-security prison.

### **MALSAGOV MUSA**

Convicted of using violence against law enforcement officers because of participation in protests in Magas against the establishing of the new border between Ingushetia and Chechnya. Sentenced to 9 years of low-security prison.

### MALTSEV IGOR (EGOR SKOROKHODOV)

The actionist was convicted of hooliganism motivated by political hatred for a performance he had done in St. Petersburg: he set fire to a dummy dressed in military uniform with a bag on its head and the inscription 'Take away', inscribed on the ice of the Malaya Neva river. Sentenced to 3 years 8 months low-security prison.

# **MALYUCHENKO SERGEY**

Convicted of committing a terrorist act because of the arson of a printing supplies warehouse in Magadan. According to the version provided by law enforcers he tried to set fire to the military enlistment office, but mistook the printing supplies building for the latter. Sentenced to 13 years of high-security prison.

## **MALAREVSKY ALEXE**

Convicted of participating in an extremist group (the Navalny headquarters), also for spreading leaflets about the judge who sentenced Alexei Navalny to 19 years in prison and tried his other associates. Sentenced to 7 years of low-security prison.

### **MALYOV YURI**

US citizen convicted of rehabilitation of Nazism, essentially for an anti-war post on the Odnoklassniki social network about the St. George memorial ribbon. Sentenced to 3 years 6 months in a correctional facility.



### **MAMIN RUSLAN**

A resident of Penza region was accused of an attempt to participate in a terrorist organisation for allegedly trying to cross the border and join the Russian Volunteer Corps and Freedom of Russia Legion.

## **MAMUKOV VYACHESLAV**

A resident of Khabarovsk was convicted of state treason for allegedly offering to cooperate with the Ukrainian secret service. Sentenced to 12 years 6 months of high-security prison.

## **MANGASAROV ERIC**

A 19-year-old student was charged with preparation for a terrorist act, allegedly for parts from a homemade explosive device and 'Ukrainian leaflets' found during a search.

### **MANYCHEVA YANA**

A Voronezh resident was accused of justifying terrorism for posting three videos about the Freedom of Russia Legion.

### MARDALEISHVILI ARSEN

Convicted of espionage for allegedly passing secret information about the Western Military District of Russia to the Estonian secret service. Sentenced to 11 years of high-security prison.

### **MARKOV ARKADY**

Pskov businessman and ex-Deputy of the town of Ostrov convicted of justification of terrorism, calls to extremism and participation in the activities of an extremist organisation, for political activism within the Citizens of the USSR movement. Sentenced to 3 years of low-security prison.

## **MARTYNOV ALEXANDER**

Convicted of dissemination of 'fake news' about the Russian Armed Forces on the grounds of political hatred and vandalism, for reposts on the Odnoklassniki social network about killed residents of Mariupol, shelled houses in Kherson, for inscriptions 'Putler kaput', 'Ukraine, forgive us', 'Peace to Ukraine' and 'Putin is war', as well as stencilled pictures 'in the form of a merger of V. V. Putin and A. Hitler' in the villages of Mokshino, Varaksino, Teshilovo and the settlements of Mirny and Novozavidovsky. Sentenced to 6 years 6 months low-security prison.

## **MARTYNOV ELDAR**

Accused of justifying terrorism, calling for mass riots and rehabilitating Nazism because of anti-Putin videos on VK with calls to join the people's resistance against Putin.

### **MARTYUSHEV KIRILL**

Charged with calls to extremist activity, for anti-war video on February 24, 2022 in the #NET-VOINE (No war) Telegram channel. Sentenced to 3 years of low-security prison.



### **MASGUTOV DMITRY**

An 18-year-old man was convicted of sabotage in the Chelyabinsk region for allegedly setting fire to relay and battery cabinets. Sentenced to 11 years 6 months of high-security prison.

### **MASLOV ANATOLY**

Convicted of treason for allegedly passing hypersonic-related data to China. Sentenced to 14 years of high-security prison.

## **MASLOVSKY PHILIP**

Convicted of destruction of another person's property by setting fire to a car with Z-symbols. Sentenced to 1 year 10 months in a correctional facility.

### **MATVEENKO VLADISLAV**

Convicted of destruction of property, allegedly for attempted arson of a military enlistment office. Sentenced to 4 years of low-security prison.

### **MATISOV PAVEL**

Charged with organising a terrorist organisation, actually for political activism within the Marxist Circle, in particular for a video reporting that Russia is 'occupied by capitalists'.

### MATKHEEV ALEXANDER

Convicted of justification of terrorism, attempted state treason and participation in the activities of a terrorist organisation because of alleged intention to join the Freedom of Russia Legion. Sentenced to 10 years of high-security prison.

## **MAKHMUTOV ILNAZ**

Convicted of organising mass riots, in fact for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement, who spoke out against the war. About 10 000 people gathered in front of the court building in Baimak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.

## **MASHARIPOV YUNUS**

A Ukrainian citizen tried for illegal possession of explosives for allegedly intending to set fire to a forest in Yalta to destabilise the socio-political situation in Crimea. Compulsory psychiatric treatment was ordered.

### **MAYBORODA YEVGENIYA**

Convicted of dissemination of 'fake news' about the Russian Armed Forces because of two reposts on the VK social network about the number of dead Russian servicemen. Sentenced to 5 years 6 months of low-security prison.

### **MEDVEDEV FILIPP**

Convicted of anti-war posts in a Telegram channel with 37 followers. Sentenced to 3 years 11 months of low-security prison.



### **MELKONYANTS GRIGORY**

The co-chairman of Golos (The voice) and coordinator of the Golos movement was accused of organising the activities of an undesirable organisation for setting up an organisation that monitors elections together with the European Network of Election Monitoring Organizations (ENEMO). He's facing up to 6 years of imprisonment.

### **MELNIKOV TIMOFEI**

A resident of Dmitrov was charged with preparation for sabotage, allegedly for reconnaissance on the territory of a military unit and desire to set fire to military vehicles.

### **MELNIKOV VASILY**

Convicted of spreading false information about the army because of negative statements about the leadership of the Russian Federation and its political course. Sentenced to 5 years low-security prison.

#### **MELNIKOV MATVEY**

A 19-year-old resident of Dmitrov was charged with preparation for sabotage, allegedly for reconnaissance on the territory of a military unit and a desire to set fire to military vehicles.

### **MEMETSHAYEV ARTUR**

Convicted of participating in an illegal armed formation, allegedly for joining the battalion named after Noman Chelebidzhikhan, in an attempt to escape to Crimea. Sentenced to 6 years 6 months of high-security prison.

## **MENSHIKOV VLADLEN**

Convicted of attempted terrorist act and incitement to terrorism for attempting to blow up railroad tracks where trains carrying Russian military equipment run. Sentenced to 14 years of high-security prison.

## **MENSHOV NIKITA**

A 19-year-old student from Yekaterinburg was convicted of state treason for allegedly wanting to join the Russian Volunteer Corps. Sentenced to 5 years of high-security prison.

## **MEREMSHAOV ADNAN**

A resident of Cherkessk was accused of creating an extremist organisation for participation in the movement in support of the USSR/RFSR.

### **MERKULOV VELIMOR**

While attempting to climb the Mount Yamantau, a 32-year-old climber with the flag of Ukraine was detained, after that he was convicted of treason and justification of terrorism, for posts against the 'special military operation', and reposts with calls to surrender to Russian soldiers, as well as allegedly for the desire to fight on the side of Ukraine. Sentenced to 13 years of high-security prison.



### MIKAILOV ELDAR

A Togliatti resident was accused of calling for terrorism, mass riots and rehabilitation of Nazism for his posts on VK about Putin and May.

### **MILUSHKIN ARTYOM**

Convicted on a fabricated case of illegal sale of drugs on a large scale, in reality he was persecuted for his participation in Navalny's regional headquarters. Sentenced to 11 years of high-security prison.

## **MINENKOVA NATALIA**

A follower of the Falun Dafa movement was convicted of organising the activities of an undesirable organisation for allegedly trying to organise 'colour revolutions' in Russia and China with the direct support of the U.S. State Department.

### **MIRZIN AZAT**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 police and National Guard with batons dispersed the crowds.

### **MIRONOV VLADIMIR**

A postgraduate student of St. Petersburg Academic University was convicted of hooliganism and discrediting the armed forces, for writing 'No to War', 'Stop Killing' and 'How Many Can Kill' on the wall of the military commissariat of the Vyborg district. Sentenced to 4 years of low-security prison.

## **MITROFANOV VLADIMIR**

Convicted of public justification of terrorism for anti-war statements. Sentenced to 7 years of low-security prison.

# **MIFTAKHOV AZAT**

Previously convicted of the Set' (The net) community and the attack on the United Russia office, a postgraduate student of the Moscow State University mechanical engineering department received a new sentence for justification of terrorism, because while watching a TV program with other prisoners, the postgraduate student said aloud that he would 'avenge' the death of a friend who fought on the side of Ukraine and that 'FSB officers should be blown up'. Sentenced to 4 years of high-security prison.

## **MIKHAILOV SERGEY**

An employee of Kaspersky Lab was convicted of state treason for allegedly passing classified information at an international conference. Sentenced to 22 years of high-security prison.



### **MIKHAILOV SERGEY**

A journalist was accused of dissemination of 'fake news' about the Russian Armed Forces, for a repost in the LIStka Telegram channel about the deaths of civilians as a result of Russian troops strikes on a maternity hospital and a drama theatre in Mariupol, and another with a post based on a Wikipedia article about the killing of civilians in Bucha.

### MIKHAILOV VALERY

Retired FSB colonel convicted of state treason for allegedly co-facilitating with CIA agents. Sentenced to 18 years of high-security prison.

### MIKHALYOV VYACHESLAV

Convicted of participating in the activities of a terrorist organisation because of alleged intentions to commit sabotage in cooperation with the Freedom of Russia Legion. Sentenced to 8 years of high-security prison.

#### **MIKHEEV YURI**

An 18-year-old resident of Lobnya was charged with preparation for sabotage, allegedly for reconnaissance on the territory of a military unit and desire to set fire to military vehicles. In custody since November 2023

### **MIKHEEV DMITRY**

Sound engineer of TRK 'Bratsk' media company was accused of terrorist act, allegedly for arson of a military enlistment office. Faces up to 20 years of imprisonment. In custody since 2023.

# **MISHCHENKO YEVGENY**

An activist of Nemtsov bridge memorial was accused of participation in a terrorist organisation, allegedly for cooperation with the Freedom of Russia Legion. The activist reported being beaten during detention, an ambulance was summoned to the court, and doctors recorded fractured ribs. In custody since September 2023

### **MOISEYEV EVGENY**

A member of the Police Ombudsman team was convicted of false denunciation for the Save the Police Ombudsman movie, about how the case against Vladimir Vorontsov (the Police Ombudsman) was fabricated. Sentenced to 4 years low-security prison.

# **MOISEYEV SERGEI**

Accused of organising the activities of an extremist organisation, for creating a religious organisation of followers of the Allah-Ayat doctrine. In custody since March 2024.



### **MORGUNOV VLADIMIR**

Convicted of allegedly cooperating with Special Operations Forces of Ukraine. Sentenced to 12 years of high-security prison.

### **MOROZOV ANDREY**

A resident of the Leningrad region was convicted of state treason, attempted illegal border crossing and attempted to join a terrorist organisation, for allegedly trying to join the Ukrainian Freedom of Russia Legion. Sentenced to 12 years of high-security prison.

### **MOSKALEV VIKTOR**

Tried for dissemination of 'fake news' about the Russian Armed Forces for anti-war publications on the Internet. Appointed compulsory psychiatric treatment.

### **MOSKALENKO TATYANA**

A resident of Maikop, Republic of Adygea, was charged with public calls for activities against the security of the state for video clips calling for organising protests against the war in Ukraine, disrupting 'mobilisation enterprises' and obstructing the work of military enlistment offices. Faces up to 6 years of imprisonment.

### **MOSKALEV ALEXEI**

Convicted of discrediting the Russian Armed Forces because of his daughter's drawing and anti-war comments on the Internet. Sentenced to 1 year 10 months low-security prison.

### **MOSKVIN EVGENY**

Administrator of the Project Scanner and Riddle Telegram channels, convicted of extortion of Vasily Brovko, the Rostech director for special assignments and his wife Tina Kandelaki, in reality he was persecuted for his professional activities. Sentenced to 7 years of high-security prison.

# **MUNGALOV MIKHAIL**

A Krasnodar resident convicted of sabotage for setting fire to a relay cabinet in protest against the war in Ukraine. Sentenced to 12 years of high-security prison.

### **MUSAEVA ZAREMA**

Convicted of fraud with loans taken from home appliance stores in 2019, in reality she was persecuted for being the wife of a retired judge in Chechnya who is in conflict with the head of the Chechen Republic. In the course of detention Chechen security forces broke into her apartment in Nizhny Novgorod and took the woman to Grozny, without the life-saving medicines she needed. Zarema has health problems: she is insulin dependent. Sentenced to 4 years 9 months in a correctional facility.

## **MUTALLAPOV VALLAM**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.



### **MUKHAMETOV DANIL**

Charged with state treason, allegedly for espionage in the interests of Ukraine. In custody since April 2023.

### **MUKHAMETOV ARTUR**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. In custody since January 2024.

## MUKHAMETOVA VICTORIA (ORLOVA VICTORIA SERGEEVNA)

Charged with state treason for allegedly spying for Ukraine. In custody since April 2023.

## **MUCHKIN ANDREI**

A resident of Ulyanovsk was accused of dissemination of 'fake news' about the Russian Armed Forces motivated by political hatred, probably for his anti-war stance. He faces up to 15 years of imprisonment.

### **NACHKEBIA AVTANDIL**

Ex-serviceman of the Black Sea-Azov Frontier Department of the Federal Security Service, a reserve major, was convicted of state treason, allegedly for working with Georgian special services. Sentenced to 12 years of high-security prison.

### **NAGIBIN IGOR**

Convicted of organising mass riots, for political activity and maintenance of regional chat rooms of the What to do! Telegram channel, calls to express an opposition position in the election of deputies to the State Duma in 2021. Sentenced to 8 years in low-security prison.

## **NAIDANOV ANDREI**

Convicted of calls to extremist and terrorist activity and justification of terrorism, for calls to change state power in Russia by force. Sentenced to 4 years low-security prison.

# **NAJAFOV SHAKHVERDI**

A resident of Neftekamsk, Bashkortostan region, was accused of discrediting the armed forces for comments on YouTube, including: 'Glory to Ukraine', 'I will follow NATO! Hello to you orcs from a sane Russian citizen!!!'. He faces up to 5 years of imprisonment.

### **NALGIEV ISMAIL**

Convicted of using violence against law enforcement officers because of participating in protests in Magas against the establishing of the new border between Ingushetia and Chechnya. Sentenced to 8 years of low-security prison.

### **NAPTUGOV ASLAN**

Resident of Cherkessk was accused of creating an extremist organisation, for participating in the movement in support of the USSR/RFSR. In custody since June 2022.



### **NAROLSKY DENIS**

Previously convicted of desertion, a Crimean contract conscription military man was accused of state treason because of his refusal to participate in the so-called special military operation and to undergo military service. Sentenced to 9 years of high-security prison.

#### **NASRYEV ROMAN**

Convicted of terrorism for attempting to set fire to the military registration desk in the local administration building in protest against Russia's invasion of Ukraine. Sentenced to 19 years of high-security prison.

### **NAZARENKO YEVGENY**

Accused of committing sabotage due to alleged several attempts to set fire to the transportation infrastructure in the Moscow region. He faces up to 20 years of imprisonment.

#### **NAZAROV IVAN**

A resident of Novokuznetsk was charged with state treason for allegedly transferring money to the Ukrainian Armed Forces for the purpose of purchasing military equipment. The man reported being surveilled.

### **NECHUSHKIN ALEXE**I

Convicted of hooliganism, for ramming police fences on Pushkin Square in Moscow using a car bearing anti-war slogans, and for subsequently setting fire to his car. Sentenced to 4 years low-security prison.

## **NEDILSKY IVAN**

A former agent of the State Security Service of the Ministry of Internal Affairs of the Russian Federation convicted of treason, vandalism, participation in a terrorist organisation, and terrorism for attempting to set fire to a military commissariat. Sentenced to 26 years of high-security prison.

# **NEIZHMAKOV PROKHOR**

A citizen of Ukraine, who received temporary asylum in Vladimir region in Russia, was convicted of justifying terrorism, for his comments in the Vladimir Gang local chat room: 'You are simply destroying my country', 'How many husbands and brothers have been killed in connection with these conflicts, if you had not meddled in Ukraine, everything would have been normal, we would have been neighbours', 'We will not negotiate with Putin... Overthrow him and then go ahead'. Sentenced to 3 years of low-security prison.

## **NEMATULLOEV KAROMATULLOH**

Accused of sabotage in Chuvashia, for anti-war action: arson of relay and battery cabinet.



### **NEPEIN OLEG**

Accused of dissemination of 'fake news' about the Russian Armed Forces, for comments in the Engels-Saratov Telegram channel about the shooting of civilians in Bucha. Sent for compulsory psychiatric treatment.

## **NESTERKOV PYOTR**

The Syktyvkar resident was charged with public justification of terrorism and calls to extremism, probably for anti-war statements and a rally. Earlier, the activist sent a notice to the election commission of the Komi Republic to hold a referendum on ending the war, prosecuting Putin and Mishustin, and holding new presidential elections. The election commission rejected his application. He was sent for compulsory psychiatric treatment.

#### **NETUNAEVA VERONIKA**

A lawyer of the administration of the city of Uglich, Yaroslavl region, was convicted of preparation to commit a terrorist act, allegedly for the transfer of data to representatives of the Ukrainian Armed Forces and Security Service of Ukraine. Sentenced to 6 years of low-security prison.

### **NEUSTROEV VASILIY**

Charged with NGO activities infringing on the rights of citizens and an article for incitement to mass disorder, in fact persecuted for his participation in the Vesna democratic movement, which called for participation in anti-war protests. In custody since June 2023.

## **NEVMYANOVA ALINA**

She was accused of violating Russian election laws by pouring brilliant green dye into the ballot box (Navalny had been poured with the same substance a few years earlier) during the presidential elections. She reported pressure and confessed that she believed the fraudsters who had urged her to commit that. In custody since March 2024.

## **NEVOROTIN SERGEI**

Convicted of dissemination of 'fake news' about the Russian Armed Forces because of an anti-war video on the VK social network. Sentenced to 6 years low-security prison.

# **NEYELOV VLADIMIR**

The former head of the Centre for Strategic Prospects Research was convicted of state treason for allegedly transferring data on the process of training and retraining of FSB operatives to a German consulting firm. Sentenced to 7 years of high-security prison.

### **NEZNAMOV YURI**

Charged with participating in a terrorist organisation for allegedly intending to carry out terrorist activities out of hatred for the current state regime in the Tyumen and Sverdlovsk regions and Khanty-Mansi Autonomous Okrug. In custody since 2022.



### **NIGAMATOV AIBULAT**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. In custody since February 2024.

### **NIZHEGORODOV VASILY**

Convicted of sabotage, allegedly for setting fire to relay and battery cabinets in Chuvashia.

### **NIKANDROV IGOR**

A native of Ukraine was accused of publicly justifying terrorism, probably for his anti-war stance. Faces up to 7 years of imprisonment.

### **NIKITENKO VLADISLAV**

Convicted of repeated discrediting of the Russian army, for filing a statement of a crime against peace and human security against members of the Russian Security Council, Putin and the country's military leadership and sending it to the Investigative Committee and the Prosecutor's Office, also for his anti-war publications on Facebook. Sentenced to 2 years 11 months of high-security prison.

### **NIKITIN MIKHAIL**

A resident of Yekaterinburg was convicted of preparing a terrorist act, a plan to set fire to a military recruitment centre, and his anti-war stance. Sentenced to 6 years of high-security prison.

## **NIKIFOROV YEVGENY**

Convicted of treason for allegedly intending to join the Ukrainian Armed Forces. Sentenced to 6 years 6 months of high-security prison.

# **NIKOLAEV ANGEL (YEVGENY GOLUBEV)**

Resident of Khabarovsk convicted of abuse of the state emblem and flag of the Russian Federation, hooliganism, vandalism and terrorism, for a failed attempt to set fire to a military conscription office, for painting swastika flags over the graves of so-called 'special military operation' veterans, and for his anti-war statements in his Instagram account (Angel Nikolaev, No to War). Sentenced to 15 years of high-security prison.

# **NIFONTOV ALEXEY**

Accused of sabotage in Chuvashia, for anti-war action: arson of relay and battery cabinet.

# **NOVAK NIKA**

A journalist was charged with cooperation with a foreign state on a confidential basis, for carrying out her professional activities. She faces up to 8 years of imprisonment.

## **NOVIKOV SERGEY**

Accused of participating in the activities of an extremist organisation because of alleged cooperation with the Freedom of Russia Legion. In custody since July 2023.



### **NOVOGRENKO ALEXANDER**

Convicted of committing a terrorist act by setting fire to a military recruitment centre in St. Petersburg. Sentenced to 15 years of high-security prison.

### **NOZDRINOV ALEKSANDR**

A blogger from Novokubansk, Krasnodar Krai, was convicted of 'disseminating knowingly false information' about the use of the Russian armed forces, for posting photos of a bombed-out apartment building in Kyiv and the caption 'Ukrainian cities after the coming of the liberators' in the Sanya Novokubansk Telegram channel. Sentenced to 8 years 6 months low-security prison.

### **NURIEV ALEKSEI**

Convicted of 'terrorist act' for attempting to set fire to the military registration desk in the local administration building in protest against Russia's invasion of Ukraine. Sentenced to 19 years of high-security prison.

### **OBLOGA ALEXANDER**

Ukrainian citizen convicted of treason. Sentenced to 13 years of high-security prison. Sentenced to 13 years of high-security prison.

### **OCHIROV ALTAN**

A resident of Elista, Republic of Kalmykia, was convicted of dissemination of 'fake news' about the Russian Armed Forces, for running the Volniy Ulus Telegram channel, in which he criticised the actions of the Russian military on the territory of Ukraine and in one of the publications allegedly spread false information about the number of dead. Sentenced to 5 years of low-security prison.

# **OGARKOV IVAN**

A 17 years old teenager was convicted of promoting terrorist activity for allegedly preparing an explosion at the Novosibirsk Passport and Visa service centre of the Russian Ministry of Internal Affairs. Sentenced to 3 years in a correctional facility.

# **OKHLOPKOV NIKOLAI**

Convicted of participating in an illegal armed formation for allegedly intending to join the Freedom of Russia Legion. Sentenced to 4 years 6 months of high-security prison.

# **OKRUSHKO SERGEI**

An electrician and a Ukrainian citizen, was charged with sabotage for blowing up an abandoned workshop of the Kuibyshev oil refinery in Samara, with no casualties. In custody since June 2023.

### **OKSENYUK ALEKSEI**

A resident of the Stavropol region was convicted of participating in the activities of a terrorist organisation, preparation for a terrorist act, allegedly for cooperation with a Ukrainian battalion. Sentenced to 15 years of high-security prison.



### **OLEYNIK NIKITA**

Charged with creation of a terrorist organisation because of alleged intentions to carry out terrorist activities out of hatred for the current state regime in the Tyumen, Sverdlovsk regions and Khanty-Mansi Autonomous Okrug. In custody since summer 2022.

### **OLEKHNOVICH ALINA**

Convicted of participating in the activities of an extremist organisation because of her work in Navalny's headquarters. Sentenced to 3 years 6 months low-security prison.

## **ONOSHKIN ALEXEI**

A resident of Nizhny Novgorod was accused of dissemination of 'fake news' about the Russian Armed Forces for a post on VK about the destruction of a drama theatre in Mariupol. He was sent to a psychiatric clinic for compulsory treatment.

#### **OPALNIK PYOTR**

Charged with confidential cooperation with a foreign state for allegedly inducing mobilised persons to treason. Sentenced to 8 years of low-security prison.

## **ORLOVSKY RUSLAN**

33-year-old activist was convicted of preparing participation in the activities of a terrorist organisation and committing high treason in the form of switching to the side of the enemy, allegedly for attempting to travel to Ukraine to participate in hostilities against Russia on the side of the Ukrainian Armed Forces. Sentenced to 6 years of high-security prison.

## **ORLOVSKY IGOR**

A resident of Krasnoyarsk was convicted of calls for extremist activity, public justification of terrorism, false information about the Russian armed forces, rehabilitation of Nazism, for commenting on VKontakte with the words 'Death to Russian occupants! Peace to Ukraine and the whole world!' and 'Death to the old fascist Vovka Putin'. Sentenced to 3 years low-security prison.

# **OROZBAYEV ORUNBEK**

Kyrgyz citizen convicted of organising the activities of an extremist organisation, allegedly for his involvement in the activities of the Tablighi Jamaat religious movement. Sentenced to 6 years of low-security prison.

# **ORUDZHEV IBRAGIM**

A student of Belgorod University was accused of being trained for terrorist activities, allegedly for scouting the area near the military enlistment office and being fascinated by the ideas of the Right Sector and Azov battalion. Faces up to 10 years of imprisonment.

### **OSIPENKO ANTON**

Convicted of preparing high treason because of a 'confession' made under torture about his intention to join the International Legion of Ukraine. Sentenced to 9 years 10 months of high-security prison.



### **OSIPOV OLEG**

A Ukrainian citizen, was accused of committing sabotage for allegedly organising an explosion at the Kuibyshev oil refinery in Samara.

### **OVCHINNIKOV VLADIMIR**

An electrician from Tatarstan was charged with participation in the activities of a terrorist organisation and state treason for allegedly collaborating with Ukraine's Freedom of Russia Legion. In custody since October 2023.

## **OZEROV SERGEI**

Convicted of attempted terrorism for allegedly intending to commit arson against government buildings during an anti-government rally on November 5, 2017. Sentenced to 8 years of high-security prison.

#### **PAVLOV EGOR**

He was accused of preparing to set fire to military enlistment offices. In custody since September 2022.

## **PAVLOV KONSTANTIN**

A deputy of the Bryansk regional Duma was convicted of large-scale fraud, for helping 40 illegally mobilised men to return home. In custody since April 2023.

### **PAVLOV VASILY**

A Belgorod resident was accused of participating in a terrorist organisation for distributing leaflets of the Freedom of Russia Legion.

# **PAVLYUCHENKO DMITRY**

A resident of Syktyvkar was convicted of justifying terrorism because of three comments on the VK social network about the explosion on the Crimean Bridge. Sentenced to 3 years of low-security prison.

# **PAKLIN ROMAN**

Charged with participating in a terrorist organisation for allegedly intending to carry out terrorist activities out of hatred for the current state system. In custody since 2022.

# **PALEY ANDREI**

Convicted in a murder case that took place in 2004-2005, essentially for his political activity in the team of Sergei Furgal, a former Khabarovsk Krai Governor. Sentenced to 17 years of high-security prison.

### **PANIN ARTYOM**

Charged with terrorist act in Chuvashia, for anti-war action: arson of relay and battery cabinet.

## **PARSHINA TAMARA**

A resident of Khabarovsk was convicted of state treason for transferring less than 30 euros to a Ukrainian charity fund. Sentenced to 8 years of low-security prison.



#### **PASKAR IGOR**

Convicted of terrorist act, for burning a Z-banner with the 'We do not abandon our own' inscription in the centre of Krasnodar, and public action with a Molotov cocktail in front of the FSB office on Mira Street in Krasnodar. Sentenced to 8 years 6 months of high-security prison.

#### **PEKPAEV PAVEL**

A resident of Yoshkar-Ola was convicted of dissemination of 'fake news' about the Russian Armed Forces, for publications about Russia's responsibility for unleashing war against Ukraine with the purpose of occupying the territory, and about the losses of Ukrainian civilians as a result of the Russian invasion. Sentenced to 5 years 6 months low-security prison.

#### PEREVOZCHIKOV ARTEMIY

A student from the village of Debesy in the Republic of Udmurtia was accused of participating in the activities of the Navalny's Headquarters 'extremist organisation' for inscriptions in the city: 'Freedom to Navalny', 'No to war!', 'Russian soldier – fascist occupant'. In custody since March 2023.

# **PESTRYAKOV SERGEY**

A resident of Stavropol was convicted of rehabilitating Nazism because of an anti-war post on VK. Sentenced to 3 years low-security prison.

#### **PETRAUSKAS ANDREI**

Convicted of terrorist act because of arson of military enlistment office in Krasnoyarsk. Sentenced to 10 years of high-security prison.

# **PETRENKO DMYTRO**

Ukrainian citizen convicted of aiding a terrorist organisation, for recruitment to the Right Sector. Sentenced to 9 years of high-security prison.

# PETRIICHUK SVETLANA

Convicted of propaganda of terrorism because of directing the Finist the Brave Falcon play about women who were baited to marry representatives of radical Islam and go to Syria to live with them. Sentenced to 6 years of low-security prison.

# **PETROV MAXIM**

Convicted of treason for allegedly transferring materials containing state secrets to an American handler from the intelligence department of the U.S. Department of Defense. Sentenced to 13 years of high-security prison.

#### PETROVA VIKTORIA

Charged with dissemination of 'fake news' about the Russian Armed Forces, agitation in support of Ukraine, for an anti-war post on VKontakte accusing Vladimir Putin and his inner circle of civilian deaths and genocide of the Ukrainian people, and federal media of lying and psychological manipulation. She was sent for compulsory psychiatric treatment.



#### **PETRUSHIN YEVGENY**

Convicted of state treason, allegedly for transferring data on the activities of the Black Sea Fleet to Ukrainian military intelligence. Sentenced to 12 years of high-security prison.

### **PIVOVAROVA ELENA**

A journalist, ex-editor of the Vpered newspaper in Bataysk was convicted of fraud, for her journalistic activities such as the newspaper's investigation of a monopoly supplier of food for children's institutions in the city. During the search she reported theft of personal belongings, she fainted and was taken to hospital. She was dismissed from the post of editor, despite a contract until 2025. Sentenced to 4 years 6 months low-security prison.

#### **PIROGOV VITALY**

Convicted of incitement to terrorism because of alleged publications on Telegram, details unknown. Sentenced to 4 years of low-security prison.

#### **PISKAREV SERGEY**

Charged with intentional infliction of minor harm to health on political or ideological grounds, for fighting with veterans of the so-called 'special military operation' and criticising their participation in the war in Ukraine.

#### **PISKUNOV SERGEY**

Ex-coordinator of Golos (The voice) movement. Charged with organising an extremist group, for committing lewd acts against a minor, for violation of the order of activity of a foreign agent, in reality persecuted for organising observation at the elections and attempting to count the dead at the so-called 'special military operation' for the Mediazona news outlet. Relatives report him being tortured. In custody since February 2024.

# **PICHUGIN ALEXEI**

Received a life sentence in relation to the Yukos case because of his work for Mikhail Khodorkovsky, a businessman and opposition politician.

# **PLATOV ANTON**

Tried for attempted arson of military enlistment office in Omsk. Forced psychiatric treatment.

### **PLETNYOV ALEXANDER**

A Moscow resident was accused of preparing to commit sabotage, probably an action against the war in Ukraine. In custody since June 2023.

# **PLETNYOVA IRINA**

Accused of committing a terrorist act by setting fire to the Kirov government building.

### **PLYSYUK OLEKSANDR**

A resident of occupied Melitopol, Zaporizhzhya region of Ukraine, was convicted of public calls to terrorist activity for taking selfies with the inscription 'Death to PUTIN!' on the VK social network. In custody since March 2024.



#### **POGOROV AKHMED**

Accused of using violence against law enforcement officers because of participation in protests in Magas against the establishing of the new border between Ingushetia and Chechnya.

### **POGHOSYAN RUBEN**

Convicted of spreading false information about the army because of anti-war publications on the Internet about Bucha, Mariupol and Kramatorsk. Sentenced to 6 years of low-security prison.

### **PODKAMENNY ILYA**

An 18-year-old resident of Irkutsk was convicted of public calls for extremist activity, preparing for committing a terrorist act, allegedly for the plan to disrupt train traffic and to blow up a military enlistment office, and for the note with words 'Instead of leaves Putinists will hang from trees'. Sentenced to 12 years of high-security prison.

#### **PODSTRIGAEV DMITRY**

Convicted of attempted treason, aiding and abetting terrorism and preparation for an attempt of assassinating law enforcement officers for allegedly intending to blow up a military recruitment centre in the Bryansk region per the instructions of Special Operations Forces of Ukraine. Sentenced to 15 years of high-security prison.

### **POLEVIK (LEMESH) ANTON**

The Khabarovsk resident was charged with promoting terrorist activity for speaking out against the so-called 'special military operation', cursing the Russian Armed Forces and persuading an acquaintance to join the Ukrainian Freedom of Russia Legion. He faces up to 15 years of imprisonment.

# **POLOVNIKOV MAXIM**

Convicted of justification of terrorism, for comments on the VK social network under the following video: In Moscow there are dispersals of protesters against the war in Ukraine. Sentenced to 2 years low-security prison.

# **POLUNIN DMITRY**

Charged with confidential cooperation with a foreign organisation after a string of arrests for allegedly disorderly conduct. Details unknown.

# **POLYUDOVA DARIA**

Convicted of public justification of terrorism and public calls for extremist activity, in reality persecuted for her political activity within the framework of Left Resistance group, pickets and publications in social networks. Sentenced to 9 years of low-security prison.

### **PONAMAREV VLADISLAV**

Convicted of treason for allegedly transferring data on the deployment of Russian military and military equipment to the Ukrainian side. Sentenced to 12 years of high-security prison.



#### **PONOMARENKO MARIA**

A journalist convicted of dissemination of 'fake news' about the Russian Armed Forces, in reality persecuted for her professional activities as a journalist and her anti-war stance. Sentenced to 6 years in a low-security prison.

#### **PONOMARYOV KONSTANTIN**

Convicted of knowingly false denunciation and fraud, essentially for disagreeing with the state energy policy in Crimea and an attempt to return business assets seized by the state. Sentenced to 10 years and 2 months in penal colony.

### **POPLAVSKY ANATOLY**

Moscow resident convicted of attempted participation in an armed conflict against the Russian Federation, allegedly for filling out a questionnaire to join the Freedom of Russia Legion. Sentenced to 5 years 6 months of high-security prison.

#### **POPOV DENIS**

A resident of Uglich was convicted of attempted terrorist act and calls to extremist activity, probably for anti-war comments in social networks, and allegedly for attempted arson of a military enlistment office. Sentenced to 8 years of high-security prison.

#### **POPOV VYACHESLAV**

Convicted of preparing a terrorist act, planning to blow up a military unit in Kaliningrad, and for anti-war actions. Sentenced to 9 years of high-security prison.

## **PORUCHIKOV VLADISLAV**

Convicted of allegedly trying to join the Freedom of Russia Legion. Sentenced to 9 years of high-security prison.

## **POTEMINA MARINA**

She was accused of creating a non-profit organisation that infringes on the personality and rights of citizens because of her membership in the Russian Orthodox Church of the Tsarist Empire movement.

# **PRIMAK OLGA**

A resident of Cherkessk was accused of founding an extremist organisation for her participation in a movement in support of the USSR/RFSR.

### **PRISHLYAK YEVHEN**

A resident of Novaya Kakhovka, Kherson region, was charged with espionage and international terrorism, for opposing a so-called 'special military operation'. In custody since August 2022.

### **PROKOPETS ARTYOM**

A resident of St. Petersburg was accused of committing sabotage by blowing up two transformer booths. Faces up to 20 years of imprisonment.



#### PROKOPCHUK EVGENY

Convicted of disobeying orders during mobilisation. Sentenced to 2 years 6 months of low-security prison.

### **PROKUDIN PAVEL**

A trash streamer from Volgograd was charged with incitement to hatred or hostility for the Tik-Tok stream on April 4 in which he called the Russian military 'cannon fodder' and that members of the so-called 'special military operation' 'should not live' because 'there is no use for them'. In custody since April 2024.

#### **PROKHORENKO DMITRY**

A resident of Surazh, Bryansk region, was convicted of sabotage and treason for allegedly attempting to set fire to a relay cabinet per the instructions of the Security Service of Ukraine and passing information to Ukraine. Sentenced to 13 years of high-security prison.

#### **PUDOVKIN MAXIM**

Convicted of public justification of terrorism because of alleged intention to commit a terrorist act in a technical college. Sentenced to 5 years of low-security prison.

#### **PUZANOV IGOR**

The lawyer was accused of knowingly making false reports of an act of terrorism with the aim of destabilising the activities of the authorities; earlier the lawyer was sentenced to 9 years in a high-security prison for allegedly planning an assassination attempt on Putin using a toy helicopter. He was sent for compulsory psychiatric treatment.

# **PUSHKOV SERGEY**

A resident of Magadan was charged with public calls for terrorist activity, probably for posts criticising the war in Ukraine.

# **PCHELINTSEV DMITRY**

Convicted of organising a terrorist organisation, in reality persecuted for his anti fascist political activity and working with the Set' ('Network') anarchist community. Participants of the Set' reported torture. Sentenced to 18 years of high-security prison.

### **PYZH ANDREY**

A blogger convicted of illegally obtaining information constituting a state secret for allegedly attempting to smuggle data on the Moscow Metro infrastructure into Ukraine. Sentenced to 5 years low-security prison.

### **PYCHTEEV ANDREY**

Convicted of allegedly justifying terrorism because of publications on the Internet about the Crimean bridge destruction. Sentenced to 3 years low-security prison.



#### RAZUMOVA LUDMILA

Convicted of dissemination of 'fake news' about the Russian Armed Forces on the grounds of political hatred, and vandalism, for reposts on the Odnoklassniki social network about murdered residents of Mariupol, shelled houses in Kherson, for the following inscriptions: 'Putler kaput', 'Ukraine, forgive us', 'Peace to Ukraine' and 'Putin is war', as well as stencilled pictures 'in the form of a merger of V. Putin and A. Hitler' in the villages of Mokshino, Varaksino, Teshilovo and the settlements of Mirny and Novozavidovsky. Sentenced to 7 years low-security prison.

#### RAMAZANOV LEONID

A 16-year-old resident of Tomsk was convicted of sabotage for an unsuccessful attempt to set fire to a relay cabinet. Sentenced to 4 years 6 months in a correctional facility.

#### RAMALDANOV AKHMED

A resident of Rostov-on-Don was accused of preparing for a terrorist act because of his alleged intention to set fire to a military enlistment office. In custody since 2023.

#### **RASSOKHIN ALEXANDER**

Tried for attempted arson of a military enlistment office in Podolsk. Mandatory psychiatric treatment was imposed.

#### **RASTORGUEV VIKTOR**

An activist convicted of preparing to commit a terrorist act for allegedly planning to set fire to a military recruitment centre and to fire homemade rockets at the Uralvagonzavod enterprise, where military equipment is manufactured. Sentenced to 8 years of high-security prison.

# **RAKHIMOV RISHAT**

Convicted of unauthorised abandonment of the unit during mobilisation. Sentenced to 5 years of low-security prison.

# **RAKHMATULLINA ALFINUR**

A 60 years old teacher accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. In custody since January 2024.

# **REMNYOV VLADISLAV**

A Moscow resident was accused of threatening to kill or cause serious harm to health, vandalism and obstructing the lawful professional activities of journalists for drawing a pentagram on the apartment door of Izvestia military correspondent Valentin Trushnin. In custody since October 2023.

#### **ROGACH ANDREY**

A resident of Krymsk, Krasnodar Krai, was convicted of attempted treason for allegedly corresponding with Ukrainian security services to demoralise Russian soldiers.



#### **RODINA ELENA**

PhD in Law, was tried for a terrorist act, for calls on social networks to depose the Russian authorities during the parade on Red Square. Compulsory psychiatric treatment was ordered.

# **ROMANOVSKY (KUZMIN) ARIAN**

Ex-head editor of Tatler magazine convicted of extorting 11 million rubles from Chemezov, in reality he was persecuted for carrying out his professional activities. Sentenced to 5 years of high-security prison.

#### **ROOTS POLINA**

Convicted of public calls to carry out terrorist activities because of anti-war and anti-Putin publications on the Internet. Sentenced to 9 years low-security prison.

# ROSSINSKAYA NADEZHDA (NADINE GEISLER)

A volunteer for the Army of Beauties NGO was accused of urging people to collect donations for the Ukrainian Armed Forces. In custody since February 2024.

#### **ROSSOKHIN VYACHESLAV**

Convicted on charges of justification of terrorism, for comments with public calls for attacks on the life of a Russian statesman. Sentenced to 2 years and six months low-security prison.

### **ROZHKOV ALEXEI**

A resident of Berezovsky, Sverdlovsk region, was accused of terrorist acts and dissemination of 'fake news' about the Russian Armed Forces, for an unsuccessful attempt to set fire to a military recruitment centre, and for saying in an interview with the *Khodorkovsky* LIVE project that he regards the actions of the Russian army against the population of Ukraine as fascism and genocide. In custody since May 2023.

## **RUDENKO TIMOFEY**

Former military psychologist accused of calling for terrorism, for his comments in the Crimea: the Land of Partisan Glory Telegram channel justifying the actions of [Dzhokhar] Dudayev's supporters in Chechnya and calling for sabotage against state authorities in Russia. Sent for compulsory treatment by a psychiatrist.

### **RUDNEV VIKTOR**

Charged with attempted terrorist act and high treason because of alleged contract with the Ukrainian Armed Forces and filling in the questionnaire for joining the Freedom of Russia Legion. In custody since September 2023.

### **RUZAYEV DENIS**

A resident of Krasnoyarsk was convicted of justification of terrorism, for anti-war posts on the VK social network. Sentenced to 2 years 6 months of low-security prison.



#### **RUMYANTSEV VLADIMIR**

Convicted of public dissemination of knowingly false information about the actions of the armed forces of the Russian Federation, for Vovan, his personal radio station, on which he rebroadcast audio tracks from the videos of opposition bloggers and media. Sentenced to 3 years of low-security prison.

#### **RUMYANTSEV STANISLAV**

A resident of Ivanovo Region was accused of discrediting the armed forces for the following inscription: 'No War! No to fascism! Putin is a murderer' on the facade of the Russian president's reception building.

### RYSKULOV ILMIR

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. In custody since February 2024.

#### RYABINININ VASILY

A resident of St. Petersburg has been charged with incitement to hatred or enmity with the threat of violence via posting on the Internet, for his comments on the VK social network speaking out against the authorities. In custody since July 2023.

#### RYAPOLOV SAVELIY

Accused of committing sabotage by setting fire to a relay cabinet. He faces up to 20 years of imprisonment.

# **SAGADIEV VILYUR**

A father of three accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. He faces up to 3 years of imprisonment.

# **SADKOV ILYA**

A resident of Murmansk was convicted of terrorism for an unsuccessful attempt to set fire to a military recruitment centre in protest against the war in Ukraine. The man was beaten during arrest, but his injuries were reported as a result of resisting arrest. Sentenced to 14 years of high-security prison.

# **SADRIYEV ILDAR**

An activist from Sochi was convicted of organising mass riots, for political activity and running regional chat rooms of the What to Do! Telegram channel, calls to express an opposed position in the course of election of State Duma deputies in 2021. Sentenced to 6 years 6 months of high-security prison.



#### SADYGOV EMIN SABIT OGLU

A student charged with committing a terrorist act for allegedly trying to damage electrical equipment on railroad tracks. In custody since 2022.

#### SADYGOV AMIN SABIT OGLU

A student accused of committing a terrorist act for allegedly trying to damage electrical equipment on railroad tracks. Faces up to 20 years of imprisonment as well as his brother Emin.

## **SAITOVA (GALIM) RAMILYA**

Bashkir activist convicted of calls against the security of the state, for a YouTube video calling on mobilised people to refuse to participate in hostilities, to declare their unwillingness to kill, and to desert. Sentenced to 5 years of low-security prison.

#### SAFIULLINA ZULFIYA

A teacher from Bashkortostan accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. In custody since January 2024.

#### **SAFRONOV IVAN**

Journalist convicted of state treason, in fact for his journalistic activity. Sentenced to 22 years of high-security prison.

### **SAMOYLOVA YULIA**

A company manager was convicted of attempted giving of a particularly large bribe, probably for the political activity of a business owner, who was a deputy of the Verkhovna Rada of Ukraine. Sentenced to 7 years 9 months low-security prison.

## **SAMOKHINA EVGENIYA**

A 47-year-old resident of Pushkino, Moscow region, was accused of dissemination of 'fake news' about the Russian Armed Forces, for her post about the Russian army shelling of Ukraine and news about injured civilians. In custody since July 2024.

# **SAMSONOV ARTEM**

A parliamentarian convicted of violent actions of a sexual nature, allegedly for holding a conversation about a subject of an intimate nature among other adults in front of a child. In reality, he was convicted because of his political opposition activity, after winning the elections against the Edinaya Rossiya (United Russia) party. Sentenced to 13 years of high-security prison.

# **SAMUSEV VYACHESLAV**

Charged with public justification of terrorism for allegedly expressing sympathy for the Azov regiment on the Internet. In custody since August 2023.



#### **SARVAROV DINAR**

Convicted of unauthorised abandonment of the unit because of his refusal to take part in the war. Sentenced to 2 years of low-security prison.

#### **SAUTIEVA ZARIFA**

Convicted of using violence against law enforcement officers because of participating in protests in Magas against the establishment of the new border between Ingushetia and Chechnya. Sentenced to 7 years 6 months low-security prison.

#### **SACHKOV ILYA**

Convicted of treason for allegedly passing data on Russian hackers to the U.S. government. Sentenced to 14 years of high-security prison.

### SEVOSTYANIKHIN VLADISLAV

The citizen of Moscow was charged with participating in a terrorist organisation for allegedly trying to cross the border to Ukraine and fight on its side. In custody since February 2024.

#### SEDOYKIN ALEXEI

An Alatyr resident was convicted of allegedly preparing an arson attack on an administrative building in Alatyr under the influence of the Right Sector. Sentenced to 4 years 6 months of high-security prison.

### **SELEZNYOV KONSTANTIN**

A pensioner from Moscow was accused of dissemination of 'fake news' about the Russian Armed Forces, for publications on the VKontakte social network about a letter to the Prosecutor General's Office of the Russian Federation about the UN report 'on the crimes of Russian servicemen in three regions of Ukraine', an investigation done by journalists of The New York Times about the murders in Bucha. Arrested in October 2023.

# **SELIVYOROV OLEG**

Charged with incitement to terrorism and incitement to hatred or enmity with threat of violence because of his comments in the Nexta Live Telegram channel. Sentenced to 3 years of prison.

# **SELYANIN VALERY**

Physicist convicted of treason for allegedly acquiring secret equipment. In custody since August 2013. Sentenced to 15 years of high-security prison.

# **SEMAK NIKITA**

Accused of committing a terrorist act for allegedly blowing up a ventilation shaft of a military recruitment office due to his disagreement with the war in Ukraine and the subsequent mobilisation. Sentenced to 14 years of prison.



#### **SEMENOV MAXIM**

Convicted of using violence against a representative of the authorities for allegedly fighting with police officers at a rally in support of Alexei Navalny. Sentenced to 4 years of low-security prison.

#### SEMENOVA V.

Accused of hooliganism because of her attempt to set fire to a military enlistment office in Moscow. Name and details unknown

#### **SEMERENKO MARIA**

Tried for dissemination of 'fake news' about the Russian Armed Forces for anti-war publications on the Internet. Appointed compulsory psychiatric treatment.

#### **SEMILETKO RUSLAN**

A former Ukrainian military officer was accused of state treason, probably for supporting the Ukrainian side. In custody since November 2023.

#### **SEMYONOV IVAN**

A resident of St. Petersburg was accused of preparing a terrorist attack for a failed attempt to set fire to a military contract conscription office in St. Petersburg. Sentenced to 8 years of low-security prison.

#### **SERGEEV VLADIMIR**

An Omsk resident was convicted of preparing a terrorist act, allegedly for an attempt to organise an anti-war performance in Moscow. He intended to set an empty car on fire. When arrested, the man took a lethal dose of methadone as a sign of protest against the war. He reported being tortured. The doctors recorded evidence of beatings: bruises of soft tissues of the head, multiple abrasions in the face. Sentenced to 7 years 10 months of high-security prison.

# **SERGUNIN IGOR**

Single father charged with participating in the activities of an extremist organisation, in fact he was persecuted for working as a lawyer for Alexei Navalny. In custody since October 2023.

### **SERDYUK DENIS**

A resident of Volgograd was convicted of deliberate destruction or damage to other people's property by arson and hooliganism with the use of weapons for setting fire to a military recruitment office in his protest against Russia's invasion of Ukraine. Sentenced to 4 years of low-security prison.

### **SEREDA KONSTANTIN**

Convicted of allegedly intending to illegally cross the border and fight in the Freedom of Russia Legion. Sentenced to 4 years of high-security prison.



#### SHABALIN KIRILL

An 18-year-old resident of Yaroslavl was convicted of preparing a terrorist act, allegedly for attempting to set fire to a telecommunications tower. Sentenced to 6 years 7 months of high-security prison.

#### **SHABANOV DMITRIY**

Convicted of violation of the statutory rules of relations in military service, allegedly for transferring information about the 'Luhansk National Republic' to the CIA. Sentenced to 13 years of high-security prison.

# **SHABANOV ANDREI**

A saxophonist from Samara has been accused of 'incitement to terrorism' due to his anti-war posts. Andrei has the 1st group of disability. In custody since April 2024.

#### SHADRIN DENIS

Convicted of committing sabotage by setting fire to signalling cabinets on railway tracks in the Omsk region. Sentenced to 16 years of high-security prison.

### SHAYKENOV AYAN

Accused of organising mass riots after demanding the release of a Bashkir activist and former leader of the Bashkort movement who had spoken out against the war. Approximately 10 000 people gathered in front of the courthouse in Baymak in support, the crowd was forcibly dispersed by over 1000 police officers and National Guard members armed with batons.

## SHAKURSKY ILYA

Convicted of forming a terrorist organisation, though in reality for his political activity with the anti-fascist and Set' ('Network') anarchist communities. Participants of the Set' reported being subjected to torture. Sentenced to 16 years of high-security prison.

### SHANIN-VINOKUROV ARKADY

Doctor from Moscow accused of justifying terrorism for an anti-war comment in Telegram. Arrested in November 2023.

# **SHAPOVALOV ROMAN**

Charged with evasion from military service. He was deprived of the military rank of Guards Junior Sergeant.

### SHARIFGALEYEV FANGIZ

Accused of organising mass riots after demanding the release of a Bashkir activist and former leader of the Bashkort movement who had spoken out against the war. Arrested in March 2024.



### SHARYGIN MIKHAIL (NAMYOTKIN)

An activist was accused of participation in an extremist organisation for his involvement in Navalny's HQ. Mikhail ran for the City Duma from Yabloko in 2020. In custody since February 2024.

### SHATKOVSKY NIKOLAI (FATHER HILARION)

Monk Ilarion from the Belgorod region has been convicted under charges of incitement to terrorism for anti-war posts on social media criticising propaganda and expressing support for the Ukrainian Armed Forces. Sentenced to 5 years of low-security prison.

#### SHATRESOV DMITRY

A resident of Krasnogorsk near Moscow was accused of covert cooperation with a foreign state due to anti-war activities.

#### SHATYI MAXIM

Resident of Unecha, Bryansk region, was convicted of a terrorist act for a plan to set fire to the office of United Russia. Sentenced to 5 years of high-security prison.

#### **SHAHBAZOV MUSTAFA**

Charged with committing a terrorist act for allegedly trying to damage electrical equipment on railroad tracks. Arrested in November 2022.

#### SHVEDOV ROMAN

An anarchist from the village of Zimovniki, Rostov region, was accused of terrorism for setting fire to the administration building in protest against the war in Ukraine and mobilisation. Arrested in September 2022.

# **SHVETS NIKOLAI**

Charged with attempted terrorist act for allegedly intending to set fire to a collection point for humanitarian aid for the Russian army.

# **SHEPELEV RAFAIL**

The activist was accused of participation in the activities of a terrorist organisation and justification of terrorism, essentially for supporting the Artpodgotovka opposition movement. The activist suffers from a chronic illness and other health problems. Arrested in November 2023.

### SHEREMETYEV VLADIMIR

Convicted of publicly calling for terrorist activity for comments justifying Mikhail Zhlobitsky, who carried out a suicide bombing at the FSB building in Arkhangelsk. Sentenced to 4 years 5 months of high-security prison.

### **SHESTUN ALEXANDER**

Ex mayor of Serpukhov, Moscow region, convicted of criticising the authorities, speaking out against a landfill, and being nominated in elections. Sentenced to 15 years 6 months of high-security prison.



#### SHEKHTER KIRILL

A 17-year-old teenager from Krasnoyarsk was charged with sabotage for allegedly setting fire to relay and battery cabinets. Kirill faces up to 10 years of imprisonment.

#### SHIBAEV ALEKSEI

Convicted in a fabricated case for justifying terrorism because of alleged publications on the Internet with 'calls for terrorist acts'. Sentenced to 4 years low-security prison.

#### SHIRSHIKOV YAROSLAV

Convicted of justifying terrorism due to anti-war posts in a Telegram channel. Sentenced to 2 years low-security prison.

### **SHLYAKOV VALENTIN**

A YouTube blogger, convicted of public calls for extremist activity, though the actual reason was a video exposing corruption within the judiciary, political involvement with the informal public movement Committee for the Salvation of Russia, and calls for pickets and rallies. Sentenced to 4 years in a correctional facility.

### SHOEV ABDULMALIK

A resident of Cherkessk was accused of creating an extremist organisation for participation in the movement in support of the USSR/RFSR.

#### **SHONOV ROBERT**

A former employee of the U.S. The Consulate General in Vladivostok was charged with covert collaboration with a foreign state over alleged correspondence with U.S. representatives. Arrested in March 2023.

### SHOSTAK NIKITA

Accused of creating a non-profit organisation that infringes on individuals and citizens' rights due to his membership in the Russian Orthodox Church of the Tsarist Empire.

# **SHPORT ROMAN**

Convicted of distributing leaflets about joining the Russian Volunteer Corps fighting for Ukraine. Sentenced to 2 years 3 months in a correctional facility.

### SHTOVBA YEGOR

Poet convicted of incitement to hatred or enmity with threat of violence and on calls to antistate activity, for poetic statements against mobilisation and volunteer armed formations of Luhansk People's Republic and Donetsk People's Republic within the framework of Mayakovsky Readings. Sentenced to 5 years 6 months of low-security prison.

### **SHUMEKOV BULAT**

An activist from Kiselevsk, convicted of dissemination of 'fake news' about the Russian Armed Forces, for reposts and publications on his VKontakte page about the war with Ukraine and civilian casualties. Sentenced to 5 years 6 months low-security prison.



#### SHKHAGOSHEV KAZBEK

A Greco-Roman wrestling coach and the author of the Pravda Kabardino-Balkaria Telegram channel has been accused in a fabricated case of attempted large-scale drug trafficking, as well as slandering officials in Kabardino-Balkaria. In reality, the charges stem from his anti-corruption investigations and criticism of the authorities. Reported torture by electric shock.

#### SHCHERBAKOV ARTYOM

19 years old resident of St. Petersburg was convicted of participating in a terrorist organisation, allegedly for cooperation with the Ukrainian Russian Volunteers Corps. In custody since February 2024.

#### SIDIKI RUSLAN

Russian and Italian citizen charged with committing a terrorist act for allegedly following the instructions of Ukrainian military intelligence and organising an explosion on the railroad and a drone attack on the Dyagilevo military airfield. In custody since November 2023.

#### SIDORKIN ROMAN

A resident of the Kursk region was convicted of treason for allegedly passing data to Ukrainian military intelligence. Sentenced to 17 years of high-security prison.

#### SIDORKINA TATYANA

A resident of the Kursk region was convicted of treason for allegedly passing data to Ukrainian military intelligence. Sentenced to 13 years of low-security prison.

# SIDOROV ALEXEI

In Chelyabinsk, FSB special forces broke down the door of YouTube streamer Alexei Sidorov's apartment using a sledgehammer and a crowbar, and detained him for streaming in support of Ukraine. Sentenced to 2 years 6 months of low-security prison.

### SIDORCHUK SERGEY

A military officer from the missile forces was accused of state treason for allegedly passing secret information to Ukrainian intelligence. In custody since August 2020.

# SID' ANTON

Convicted of statements he made while held in pre-trial detention centre about the activities of the USSR during World War II. Sentenced to 2 years 9 months of low-security prison.

### SIZOV VLADIMIR

The Rostov region resident was condemned for participating in the extremist organisation, for political activity in the Union of Slavic Forces of Russia. Sentenced to 3 years 6 months of low-security prison.



#### SILASHIN LEON

A 15-year-old teenager was charged with participating in a terrorist group for allegedly planning to dig under a military unit near Moscow in order to blow up equipment and set fires. Arrested in May 2023.

#### **SILIN IVAN**

Young activist was accused of participating in a terrorist organisation, allegedly for a plan to dig under a military unit near Moscow to blow up the equipment and set fire to the unit. He faces up to 15 years of imprisonment.

### **SIMONOV MIKHAIL**

The pensioner was convicted of dissemination of 'fake news' about the Russian Armed Forces, for comments on the VKontakte social network about the bombing of Kyiv and Mariupol: 'Killing children and women, we sing songs on Channel One. We, Russia, have become godless. Forgive us, Lord!' and 'Russian pilots bomb children.' The pensioner has vulnerable health and is hard of hearing. Sentenced to 6 years 6 months low-security prison.

#### SIMONOV ALEXANDER

Charged with incitement to hatred or enmity committed by an organised group, allegedly for supporting the MKU (Maniacs: the Cult of Murder) Ukrainian youth radical group, in reality he was persecuted for his political activism, protest rallies and assistance to Navalny's head-quarters. Arrested in March 2021.

### SINELNIKOV PAVEL

Convicted of taking part in activities of NGOs infringing on the rights of citizens and for incitement to mass disorder, in fact persecuted for participating in the Vesna democratic movement, which called for participation in anti-war protests. In custody since June 2023.

# **SINENKO ARTYOM**

A Vladivostok resident convicted of incitement to terrorism, for his anti-war posts. Sentenced to 2 years of low-security prison.

# SINITSA VLADISLAV

While detained in a correctional facility, accused of calling to extremism because of his anti-Putin and anti-war publications on the Internet. Sentenced to 2 years 6 months of highsecurity prison.

# **SKAKALIN ARTEM**

Resident of Tambov convicted of participating in illegal organisations, allegedly for his desire to take part in armed actions on the side of the Ukrainian Armed Forces. Sentenced to 7 years of high-security prison.



#### SKVORTSOV ALEXANDER

Convicted of allegedly abusing the Russian flag by tearing it off the wall and throwing it into a shoe closet. Sentenced to 4 years low-security prison.

#### SKVORTSOV GRIGORY

Photographer, rooftopper, founder of the Jagath, a Perm-based ritual-industrial ambient act, was accused of state treason. Arrested in December 2023.

#### **SKOBOV ALEXANDER**

66-year-old dissident Alexander Skobov was arrested for allegedly "justifying terrorism" in his posts online. Alexander is seriously ill: he has glaucoma, diabetes, hepatitis C and asthma, therefore is vulnerable. He was arrested in April 2024.

#### SLOBODENYUK ALEKSEY

Administrator of the Project Scanner and Riddle Telegram channels, convicted of extortion of Vasily Brovko, the Rostech director for special assignments and his wife Tina Kandelaki, actually he was persecuted for his professional activities. Sentenced to 7 years of high-security prison.

#### **SLOBODCHIKOVA NINA**

The Moscow City Court sentenced programmer Nina Slobodchikova to 12 years in a general regime colony on charges of high treason. According to investigators, she transferred five thousand rubles to help the Armed Forces of Ukraine. Slobodchikova claimed that she sent the money to charity.

# **SMIRNOV VLADISLAV**

A 15-year-old teenager was accused of trying to set fire to a military recruitment centre.

## **SMIRNOV ALEXANDER**

Doctor of Law, Associate Professor of Research Centre #2 (FSIN Institute) was accused of public calls for terrorism, for his update in the WhatsApp that mentioned he was against a special military operation. Arresten in June 2024.

# **SMIRNOV EVGENY**

A resident of St. Petersburg was charged with hooliganism motivated by political hatred for the following writing on a fence: 'Putin killed Navalny'. In custody since February 2024.

### **SMIRNOVA OLGA**

Convicted of spreading false information about the army because of anti-war publications on the VKontakte social network. Sentenced to 6 years in low-security prison.

### **SMOLYANINOV ANTON**

Convicted of committing a terrorist act by setting fire to a transformer booth and cars with Z-symbols on them. Sentenced to 15 years of high-security prison.



#### **SMYSHLYAEV MAXIM**

Convicted of aiding in the preparation of a terrorist act, allegedly for helping a minor citizen of Ukraine in their preparation of a failed terrorist act. Sentenced to 10 years of high-security prison.

#### SNEZHKOV ALEXANDER

A teenager from Chita, an anarchist was convicted of vandalism, for creating a graffiti with the following inscription: 'Death to the regime', and for calls for terrorist activity and extremism, for his posts in the 75zlo and Shugan'-25 Telegram channels about protests against the war in Ukraine, in which he approved of arson of military commissaries and rail blockade activism. Sentenced to 6 years of low-security prison.

#### **SOKOLOV ALEXEI**

The human rights activist was accused of displaying symbols of an extremist organization, in reality he was persecuted for his professional activities: reporting torture in prisons. Arrested in July 2024.

#### **SOKOLOV MAKSIM**

He was tried for insulting a representative of the authorities and sent for compulsory psychiatric treatment. One of the arguments for the diagnosis was that '[Sokolov] has always been a maximalist, a truth-seeker... He criticised and condemned facts and recommendations that did not suit him. Over the past few years, he has repeatedly appealed to the Ministry of Internal Affairs, reporting various violations by citizens and inaction by law enforcement officials.' Compulsory psychiatric treatment was appointed.

# **SOKOLOV MIKHAIL**

Convicted of participating in a terrorist group, allegedly for activities in the interests of Special Operations Forces of Ukraine. Sentenced to 11 years of high-security prison.

# **SOLDATOV KONSTANTIN**

Ukrainian citizen convicted of treason and attempted terrorism for allegedly preparing to blow up railroad tracks in Crimea per the instructions of the Main Directorate of Intelligence of the Ministry of Defense of Ukraine. Sentenced to 16 years of high-security prison.

### **SOLNTSEVA TATYANA**

Tatyana, a resident of Barnaul, Altai region, was convicted of allegedly cooperating with the Freedom of Russia Legion. Sentenced to 4 years low-security prison.

### SOLOVYOV PAVEL

Accused of committing sabotage by setting fire to a relay cabinet. Details unknown.

### **SOMRYAKOV ALEXANDER**

A resident of Krasnodar was convicted of dissemination of 'fake news' about the Russian Armed Forces on the grounds of political hatred, for his anti-war publications in social networks about the killing of civilians in Mariupol and Bucha. He was subsequently deprived of his acquired Russian citizenship. Sentenced to 6 years of low-security prison.



#### SOSEDKO VLADISLAV

An 18-year-old, accused of participating in a terrorist organisation, allegedly for trying to join the Freedom of Russia Legion and the Russian Volunteer Corps. In custody since July 2024

### **SOSOV SERGEY**

Blogger convicted of rehabilitation of Nazism, for photoshopping a portrait of Adolf Hitler to the group photo of the participants of the Immortal Regiment rally. Sentenced to 3 years of forced labour in a correctional centre.

#### **SPECTOR YEVGENY**

Former chairman of the board of directors of Medpolimerprom, a US citizen, accused of espionage. Yevgeny faces up to 20 years of imprisonment.

#### **SPIRIN ANATOLY**

The author of the Like this and Politburo 3.0 Telegram channels was convicted of extortion executed by a group of persons by prior conspiracy. Allegedly, the group bribed the top manager of Rostec in exchange for removing a publication about certain officials, businessmen and managers. Sentenced to 2 years 6 months low-security prison.

#### STARCHUKOV KONSTANTIN

A resident of Chita was convicted of hooliganism for attempting to set fire to Lenin's Mausoleum in Moscow using Molotov cocktails. The man said he was fighting the influence of Freemasonry on Russian society. Observers suspect the man was tortured. Sentenced to 4 years low-security prison.

# **STEPANOV DANIIL**

Convicted of vandalism and cooperation with a foreign organisation, for alleged cooperation with the Freedom of Russia Legion, for burning Z-banners (pro-war banners) and drawing inscriptions against the authorities. Sentenced to 4 years 6 months of low-security prison.

# **STEPANOV NIKITA**

A 17 years old teenager from Novosibirsk was charged with sabotage for allegedly setting fire to a relay cabinet. In custody since March 2024.

### STEPANOV PAVEL

A Kazan resident accused of repeatedly discrediting the army and justifying terrorism, for posting a video clip and commenting on the VK social network criticising the war in Ukraine and Vladimir Putin. Pavel faces up to 5 years of imprisonment.

### **STOYANOV RUSLAN**

An employee of Kaspersky Lab was convicted of state treason for allegedly passing classified information at an international conference. Sentenced to 14 years of high-security prison.



#### STREKNYOV SERGEY

Convicted of creating inscriptions in support of Navalny and the Anti Corruption Foundation, as well as drawing the following statements: 'No to war', 'Freedom for political prisoners' and 'Putin is a murderer'. Sentenced to 3 years 6 months of low-security prison.

### STRELETSKAYA FLUZA

She was accused of participating in the activities of an extremist organisation, for participation in a religious organisation of followers of the Allah-Ayat doctrine. In custody since March 2024.

#### STRUKOV ALEXANDER

Ex-photographer working for Navalny's headquarters was convicted of incitement to hatred or enmity and public calls for terrorist activity for comments about the FSB and the Ministry of Internal Affairs in the chat room of the Znak.com TV channel, stating the following slogans: 'Glory to Ukraine', 'Down with the power of the Chekists', 'Good morning to everyone, down with Putin!'. Sentenced to 7 years 10 months of low-security prison.

#### **SVISTOV IVAN**

A 50 years old resident of Stepano-Sachensky farm, Rostov region, was charged with hooliganism for the failed arson attack on the building of the military commissariat in Morozovsk. In custody since November 2023.

#### **SUVOROVA YANA**

A 19-year-old journalist, administrator of the RIA-Melitopol news outlet and the Melitopol is Ukraine Telegram chat was accused of espionage in favour of the Ukrainian Armed Forces, in reality she was persecuted for her professional activities.

# **SULIMENKO SERGEY**

Truck driver from Nikolaiv, Ukraine, convicted of espionage. Detained while crossing the border. Sentenced to 12 years of high-security prison.

# **SULIMOVA ALEXANDRA**

A 21-year-old resident of Chita was convicted of state treason, allegedly for her anti-war stance, desire to go to Ukraine and allegedly for transferring data to Special Operations Forces of Ukraine. Sentenced to 12 years of low-security prison.

# **SUSLOV KIRILL**

Resident of Khanty-Mansiysk convicted of high treason. The case is classified. Sentenced to 12 years 6 months of high-security prison.

### **SUKHANOV KIRILL**

Commercial director, who worked for journalist Ksenia Sobchak, was convicted of extorting 11 million rubles from Chemezov (the CEO of Rostec Corporation), but in reality Kirill was persecuted for his professional activities. Sentenced to 5 years 6 months of high-security prison.



### SUKHOBOKOV ALEXEI

A resident of Ostashkov, Tver Region, was convicted of public justification of terrorism for holding a conversation with colleagues during which he approved of the explosion on the Crimean Bridge. Sentenced to 2 years 6 months in a correctional facility

### **SUKHONOSOVA ANNA**

Convicted of state treason, allegedly for collecting and transferring data to the Special Operations Forces of Ukraine, and constituting state secrets about the activities of units and formations of the Black Sea Fleet, the leakage of which could damage the defence capability of the state. Sentenced to 9 years of low-security prison.

#### SUSCHEVSKAYA ANASTASIA

A 35-year-old laboratory assistant at the Kola Medical College, Murmansk region, was charged with terrorism for the failed arson attack on the History of the so-called 'Special Military Operation' museum. In custody since April 2024.

#### SUYARGULOV KABIR

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 police and National Guard with truncheons dispersed the crowds.

#### SYDYKOV BAYAMAN

Charged with assisting terrorist activity, actually for sending medicines to Turkey. 9 years of high-security prison.

# SYNTULSKIY ANATOLIY

Convicted of participating in an illegal armed formation, allegedly for his desire to fight on the side of Ukraine. Sentenced to 5 years of high-security prison.

# **SYCHEV ANTON**

A resident of Belgorod was accused of publicly justifying terrorism, probably for an anti-war comment. In custody since July 2024.

### **SYCHEV NIKITA**

An 18-year-old man was convicted of sabotage in the Chelyabinsk region, allegedly for arson of relay and battery cabinets. Sentenced to 11 years of high-security prison.

### **TAGIROV ALBERT**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.



#### **TALANTOV DMITRY**

Lawyer from Udmurtia region accused of spreading false information about the army because of anti-war comments on Facebook about Bucha, Irpen and Mariupol. Arrested in June 2022.

#### **TARUTIN YEVGENY**

Convicted of treason for allegedly obtaining the results of scientific research work related to the Russian Ministry of Defense. Sentenced to 8 years of high-security prison.

### **TELEGIN YEVGENY**

Convicted of state treason, allegedly for his plans to fight on the side of Ukraine. Sentenced to 9 years 6 months of high-security prison.

### **TEMIRYOV ALEKSEY**

Head of the Mechatronics innovative enterprise and co-owner of the Intelligent Robust Integrated Systems design bureau was convicted of state treason, allegedly for transferring classified information to Vietnam. The scientist worked on his project with a graduate student from Vietnam and applied to the FSB to check a number of documents for secrecy, after which he was detained. Sentenced to 7 years 6 months of high-security prison.

#### TETENEVA LYUDMILA

58 years old resident of Kurgan convicted of spreading false information about the army and justifying terrorism because of her anti violent posts in the Odnoklassniki social network. Sentenced to 8 years of low-security prison.

# **TIMERKHANOV MAXIM**

Convicted of participating in an illegal armed formation, allegedly for attempting to join the Freedom of Russia Legion. Sentenced to 5 years of high-security prison.

## **TIMOFEYEV VALERY**

Businessman charged with state treason for allegedly passing secret data regarding the activities of the Yantar shipyard to a foreign state. Arrested in July 2022.

### TITARENKO NIKOLAI

Convicted of public calls to carry out activities against the security of the state because of his anti-war comments in the Telegram chat room. Sentenced to 8 years of high-security prison.

### **TIKHOMIROV MAXIM**

A 17-year-old resident of Abakan was convicted of public justification of terrorism, allegedly for his posts aimed at spreading propaganda and justification of activity of the Azov battalion. Sentenced to 4 years of high-security prison.

### **TIKHOMIROV NIKOLAI**

An activist from Unecha, Bryansk region, was convicted of a terrorist act for a plan to set fire to the office of the United Russia party. Sentenced to 7 years of high-security prison.



#### TISHAKOVA YULIA

Ukrainian and Russian citizen was charged with justification of terrorism for her post on X (ex-Twitter) in the Holi Lapushka account, where she justified Ukrainian forces blowing up the Crimean bridge. In custody since March 2024.

### **TISHCHENKO YULIA**

Yulia was convicted of public calls to carry out activities against the security of the Russian Federation for a post on her Facebook page in Ukrainian calling for the funding of the Ukrainian Armed Forces. Sentenced to 4 years of low-security prison.

#### **TOKAREV VALENTIN**

A resident of Sochi, Krasnodar Region, was convicted of dissemination of 'fake news' about the Russian Armed Forces and anti-war posts on his Telegram channel. Valentin faces up to 15 years of imprisonment.

#### **TOLKACHEV ANDREI**

Convicted of participating in the activities of a terrorist organisation, allegedly for preparing to set fire to hay on Manezhnaya Square in Moscow. Sentenced to 13 years of high-security prison.

#### **TOLPYGIN IVAN**

A resident of the Orel region was convicted of attempted cooperation with a foreign state on a confidential basis, allegedly for cooperation with Ukrainian agents. Sentenced to 4 years low-security prison.

# **TOMAROVA ZEBONISO**

A 47-year-old native of Tajikistan and resident of Samara region was accused of being a member of an extremist organisation, for participating in the Citizens of the USSR organisation. Faces up to 6 years of imprisonment.

# **TOROCHKOV VITALY**

Convicted of public calls to carry out terrorist activities because of anti-war and anti-Putin publications on the Internet. Sentenced to 13 years of high-security prison.

### TRACHUK ILYA

Convicted of treason. Details unknown. Sentenced to 14 years of high-security prison.

### TRETYAKOV DMITRY

A resident of Izhevsk was convicted of creating an illegal armed formation (NVF), in reality he was persecuted for his activism and participation in the activities of the Union of Indigenous Peoples of Great Russia of the USSR organisation. Witnesses reported testimony had been made under pressure from investigators. Sentenced to 10 years of high-security prison.



#### TRESHCHEV MATVEY

A 15-year-old resident of Bryansk was charged with complicity in the preparation of a terrorist act and participation in the activities of a terrorist organisation for allegedly cooperating with the Freedom of Russia Legion. In custody since May 2024.

#### TRIFONOVA OLGA

Tried for dissemination of 'fake news' about the Russian Armed Forces for anti-war publications on the Internet. Appointed compulsory psychiatric treatment.

#### TROFIMOV ANDREI

Convicted of calls to extremism and dissemination of 'fake news' about the Russian Armed Forces, allegedly for attempting to join the Freedom of Russia Legion, and for discrediting the armed forces: he displayed posters in court (the posters had a 'NO WAR' depicted on them). Sentenced to 10 years of high-security prison.

#### **TROFIMOV IVAN**

Student convicted of participating in activity of extremist organisation because of his work for Navalny's headquarters. Sentenced to 3 years 6 months low-security prison.

#### **TRUFANOV DENIS**

A resident of Krasnoyarsk was convicted of dissemination of 'fake news' about the Russian Armed Forces on the grounds of political hatred, for publications on the VKontakte social network about the events in Bucha. Sentenced to 5 years of low-security prison.

## TRUFANOV VLADIMIR

A salesman from Norilsk was accused of calling for terrorism for five comments he posted on Telegram in the Russian Volunteer Corps chat channel.

## **TSILYK OLEKSANDR**

Oleksandr was convicted of allegedly illegally crossing the border, participation in the activities of a terrorist organisation and illegal trafficking and smuggling of explosives per the instructions of the Main Intelligence Directorate of the Ministry of Defense of Ukraine. Sentenced to 12 years of high-security prison.

# **TSUPROV OLEG**

A resident of Izhevsk, convicted of creation of an illegal armed formation (NVF), in reality for activism and participation in the activities of the Union of Indigenous Peoples of Great Russia of the USSR. Witnesses reported testimony made under pressure from investigators. Sentenced to 10 years of high-security prison.

### **TSURKAN KARINA**

A top manager of the Inter RAO energy company was convicted on state treason for allegedly passing information on electricity supplies to Ukraine. Sentenced to 15 years of low-security prison.



#### **TSYGIPA SERGEY**

Journalist, convicted of espionage for allegedly passing information to the Security Service of Ukraine on the deployment and movement of the Russian military. Sentenced to 13 years of high-security prison.

### **TSYMBALIUK NIKOLAI**

A resident of Pervomaisky district of Altai Krai was accused of calling for terrorism, for posts in his Telegram channel with calls to donate to the Armed Forces of Ukraine and condemnation of the Russian invasion of Ukraine.

#### **TUKMAMETOV RUSLAN**

Convicted of organising mass riots, in fact for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. Arrested in January 2024.

#### **TUKOVA ANITA**

A resident of Cherkessk was accused of founding an extremist organisation for her participation in the movement in support of the USSR/RFSR. In custody since 2022.

#### **TULYBAEV AYSUR**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. According to his relatives, he is disabled and could not work for health reasons, as he suffers from serious illnesses and needs constant medical supervision. Tulybaev's family has three minor children.

# **TURBIN ARSENY**

A 15-year-old schoolboy from Livny, Orel region, was convicted of participation in the activities of a terrorist organisation, allegedly for applying to join the Freedom of Russia Legion and watching videos of opposition politicians. Sentenced to 5 years in a correctional facility.

# **TURKEVICH VYACHESLAV**

An 18 years old teenager was accused of preparing a terrorist act for allegedly intending to blow up a police station in the Volgograd region and damaging 16 cars that had Z-symbols on them.

# **TURLAYEV NIKITA**

A 19-year-old student from Komsomolsk-on-Amur was accused of calling for terrorism for a video in his Telegram channel showing teenagers throwing Molotov cocktails at the wall of an abandoned building, allegedly for supporting the ideology of the Azov battalion. Nikita is sentenced to 4,5 years in a correctional facility.

### **TURTUGESHEV VLADISLAV**

Accused of sabotage in Chuvashia, for anti-war action: arson of relay and battery cabinet. In custody since January 2023.



### **TURUSHEV IGOR**

Charged with extremist statements, for publishing an anti-war post in social networks in February 2022. Sentenced to 3 years in low-security prison.

#### **TURIANSKY ALEXANDER**

Convicted of sabotage, for his plan to destroy part of the railroad tracks because of his antiwar stance. Sentenced to 3 years 6 months of high-security prison.

#### **TUSHKANOV NIKITA**

A teacher from the Komi Republic was convicted of justification of terrorism and discrediting the armed forces, for a post in the VK social network about the explosion of the Crimean bridge. Sentenced to 5 years of low-security prison.

#### **TYURIN ROMAN**

Charged with dissemination of 'fake news' about the Russian Armed Forces and incitement to terrorism because of publications in support of Russian Volunteer Corps on the Internet. Roman has been in custody since August 2023.

### **TYAZHELOV ANDREY**

A resident of Nizhny Novgorod was accused of confidential cooperation with a foreign state to the detriment of the Russian Federation, allegedly for a plan to take part in actions on the side of Ukraine.

#### **UDALYKH ALEXEY**

Convicted of sabotage in Chelyabinsk region, allegedly for arson of relay and battery cabinets. Sentenced to 11 years of high-security prison.

## **UDALTSOV SERGEI**

Politician charged with justification of terrorism, for his political activity within the Levyy Front (Left Front) organisation in 2024, previously convicted of organising mass riots in connection with the events on Bolotnaya Square. Arrested in January 2024.

### **ULITIN NIKOLAI**

Convicted of organising activities of an undesirable organisation because of his work as a pastor in the New Generation Ukrainian church. Sentenced to 3 years 6 months of low-security prison.

### **ULUKSHONOV SERGEY**

A technical school student in Krasnoyarsk was convicted of preparing to participate in an armed formation, allegedly for cooperation with the Special Operations Forces of Ukraine. Prior to his detention in 2021, the student had applied for political asylum in the United States, but was denied it and deported to Russia. Sentenced to 4 years 8 months of high-security prison.



#### **ULMASBAEV SHAFKAT**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with batons dispersed the crowds.

### **ULJABAEV ILSHAT**

Father of eight children accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. Ilshat was arrested in January 224 together with his brother Irshat.

#### **ULIANOV MIKHAIL**

Convicted of rehabilitation of Nazism for publishing a video in which he allegedly humiliated and insulted the participants of the Immortal Regiment rally. Sentenced to 8 months in a correctional facility.

#### **URAZAEV AIGIZ**

Accused of organising mass riots, in fact for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement, who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.

#### **URLASHOV YEVGENY**

Convicted of being popular during his time as the mayor of Yaroslavl, while being vocal about his political position opposed to the major party. Sentenced to 12 years 6 months of high-security prison.

# **USOYAN ILYA**

A resident of Rtischevo, Saratov region, was charged with incitement to voluntary surrender, for corresponding with an acquaintance and urging them to voluntarily surrender to the Ukrainian Armed Forces. In custody since February 2024.

# **UTYABAYEV RAFIL**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, more than 1000 policemen and National Guard with truncheons dispersed the crowds.

#### **USHAKOV RUSLAN**

Convicted of justification of terrorism, calls to extremism, rehabilitation of Nazism and dissemination of 'fake news' about the Russian Armed Forces because of publications on the Internet about the shelling of Mariupol. Sentenced to 7 years 10 months of low-security prison.



#### **USHAKOV NIKOLAI**

Resident of Belebey, republic of Bashkortostan, convicted of calls for murder, allegedly for propaganda materials calling for violent actions against those fighting in Ukraine or supporting the war. Sentenced to 2 years 6 months of high-security prison.

#### **USHAKOV ROMAN**

A Krasnoyarsk policeman convicted of state treason for allegedly giving CIA officers a code to decrypt secret telegrams. Sentenced to 15 years of high-security prison.

#### **UVAROV NIKITA**

A 14-year-old teenager was convicted of training for acts of terrorism, for stickers on the FSB building in Kansk in support of the Seti case defendants and mathematician Azat Miftakhov, as well as for his plan to blow up the FSB building in the Minecraft computer game. Sentenced to 5 years of low-security prison.

#### **UZHAKHOV ISMAIL**

Convicted of using violence against law enforcement officers because of his participation in the protests in Magas against the establishing of the new border between Ingushetia and Chechnya. Sentenced to 8 months of maximum security prison.

#### **UZHAKHOV MALSAG**

Convicted of using violence against law enforcement officers because of participation in protests in Magas against the establishing of the new border between Ingushetia and Chechnya. Sentenced to 9 years of low-security prison.

# **UZYANBAYEV DANIS**

He was accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. During the protest in Baimak Danis was protecting his mother Saniya from police.

# **UZYANBAYEVA SANIYA**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. Together with her son arrested in January 2024.

# **VAZHDAEV OLEG**

A resident of Krasnodar, was convicted of preparing a terrorist act for a failed attempt to set fire to a military recruitment centre. Sentenced to 6 years of high-security prison.

### **VALEYEV DAYAN**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 policemen and National Guard with truncheons dispersed the crowds.



#### **VALUYEV ALEXEI**

Convicted of state treason, he pleaded not guilty and is going to appeal the verdict. He was sentenced to 9 years of high-security prison.

#### **VASILENKO NIKITA**

A resident of Saratov was accused of justifying terrorism and secretly cooperating with a foreign state, allegedly for collaborating with a Ukrainian terrorist organisation.

#### **VASYLENKO VASILY**

Ukrainian citizen, former soccer player, convicted of espionage for allegedly intending to buy components of the S-300 air defence missile system. Sentenced to 12 years of high-security prison.

# **VASILIEV ILYA (ARVIE HACKER)**

The abbot of a Moscow Zen centre was accused of dissemination of 'fake news' about the Russian Armed Forces, for publishing two anti-war Facebook posts in English.

#### **VASILIEV ALEXANDER**

A resident of Izhevsk was convicted of creating an illegal armed formation. In reality, he was persecuted for his activism in the Union of Indigenous Peoples of Great Russia of the USSR. Witnesses reported testimony had been made under pressure from investigators. Sentenced to 9 years of high-security prison.

### **VASILKOVICH SERGEI**

Convicted of justifying terrorism because of anti-war comments on the Internet. Sentenced to 5 years of high-security prison.

# **VASYURENKO ANDREY**

An 18-year-old student from Karelia was convicted of attempt to incite to commit high treason by switching to the side of the enemy, allegedly trying to persuade Russians to participate in the war on the side of the Ukrainian Armed Forces. Sentenced to 9 years of high-security prison.

# **VEDEL SAMUEL (SERGEY VALENTINOVICH KLOKOV)**

An ex-policeman was convicted of dissemination of 'fake news' about the Russian Armed Forces, for discussing the war in Ukraine with acquaintances over the phone, and for his antiwar stance. The investigation considered the phone conversations public because they were tapped by the investigator. The court stripped Vedel of his officer rank. Sentenced to 7 years of low-security prison.

### **VERDIYAN GLEB**

Convicted of treason for allegedly intending to transfer state secret information to foreign intelligence services. Details unknown. Sentenced to 6 years of high-security prison.



#### **VERTINSKY VLADISLAV**

Resident of the city of Ukhta, Komi Republic, convicted of rehabilitating Nazism, for inscribing 'Putler kaput' on the Eternal Flame memorial. Sentenced to 3 years of correctional facility

### **VERYASOV ILYA**

Convicted of property damage, for his unsuccessful arson of the Kulikovo rural settlement administration building in an attempt to protest against the actions of the authorities. Sentenced to 4 years of low-security prison.

### **VESELOV SERGEI**

A resident of Elektrostal was accused of being a member of a terrorist organisation for allegedly trying to join the Freedom of Russia Legion.

#### **VESELOV KIRILL**

Accused of committing sabotage by setting fire to a relay cabinet.

### **VESELOV SERGEY**

Convicted of repeated discrediting of the Russian army, for a YouTube video he published titled 'Do not confuse Germans with Hitlerites, and Russians with Putinites'. Sentenced to 2 years 1 month in a correctional facility

### **VECHIRKO ALEXANDER**

A resident of Khabarovsk Krai was convicted of state treason for making a donation to a Ukrainian charity fund. Sentenced to 7 years in high-security prison.

### VILCHEVSKY YAROSLAV

Convicted of posts on the AnarchoPozitiv Telegram channel, which were seen as alleged justification of terrorism. Sentenced to 2 years in low-security prison.

### **VINATIER LAURENT CLAUDE JEAN LOUIS**

A French citizen, an employee of the Centre for Humanitarian Dialogue (Switzerland), expert on Russia and Central Asia, was accused of evading the duties of a foreign agent, in fact he was persecuted for carrying out his direct responsibilities.

### **VITOVTOV ANDREY**

A resident of Barnaul was accused of justifying terrorism because of his publications in the anonymous Ice under Major's feet Telegram channel. He made a post about the attack performed by Ukrainian drones where he congratulated Russians with the Day of the Ukrainian State Flag.

### **VLADIMIROV VLADIMIR**

The Kirov resident was convicted of discrediting the armed forces, for setting fire to a mobile conscription point for contract military service, and for his correspondence in which he spoke negatively about the Russian authorities and the invasion of Ukraine. Sentenced to 2 years low-security prison.



#### **VLADYKO YAROSLAV**

Convicted of being a member of an extremist organisation for allegedly wanting to join the Right Sector. Sentenced to 10 years of high-security prison.

### **VLASOV LEONID**

Accused of creating a non-profit organisation that infringes the personal data and citizens' rights because of his membership in the Russian Orthodox Church of the Tsarist Empire movement.

# **VLASOV RUSLAN**

Charged with state treason for allegedly passing data on military facilities to the Right Sector.

#### **VODOLAGIN DANIIL**

A student from Volgograd was convicted of dissemination of 'fake news' about the Russian Armed Forces for an anti-war post that allegedly contained inaccurate information about the actions of the Russian army. The court ruled to confiscate his computer and phone in favour of the state. He was sentenced to 5 years of low-security prison.

### **VOGEL ANDREI**

A resident of Nizhny Tagil, Sverdlovsk region, was charged with attempted creation of a terrorist organisation, for his political activism within the For New Socialism movement. Andrei is facing life sentence.

#### **VOLOBUEV DANIL**

Charged with sabotage in Chuvashia for anti-war action (arson of relay and battery cabinet).

# **VOLSKY ALEXEY**

Tried for dissemination of 'fake news' about the Russian Armed Forces and calls for extremist actions. persecuted because of his anti-war publications on the Internet. Forced psychiatric treatment was appointed.

## **VOROBYEV ALEXE**

Convicted of treason for allegedly passing secret information to the Chinese secret services. Sentenced to 20 years of high-security prison.

### **VOROBYOV ALEXANDER**

A former aide to the presidential envoy in the Urals Federal District was sentenced on charges of state treason for allegedly transmitting information from meetings of the Russian Security Council. Sentenced to 12 years and six months of high-security prison.

### **VORONOVSKY MAKSIM**

The activist is tried for justification of terrorism because of a comment under a photo of Mikhail Zhlobitsky posted on VKontakte social network. Zhlobitsky carried out a suicide bombing in the FSB building. Voronovsky believes that he is being persecuted for his participation in the StopXam movement. Compulsory psychiatric treatment was appointed.



#### **VOSKRESENSKY ELDAR**

A Vyborg resident was convicted of terrorism for allegedly planning to set fire to a Ministry of Defense facility. Sentenced to 13 years of high-security prison.

#### **VOSTROKNUTOV VIKTOR**

Accused of organising a terrorist act because of alleged attempt to damage electrical equipment on railroad tracks.

#### **VRAGOV ALEXANDER**

Convicted of anti-war action he executed upon the T-80 tank monument. Sentenced to 1 year and nine months of correctional facility.

### **VYGOVSKY VALENTIN**

Convicted of espionage for allegedly assembling documentation for combat aircraft engines and intending to sell it to the Chinese intelligence services. Sentenced to 11 years of high-security prison.

#### **WINTER GREGORY MARCUS SEVERIN**

A human rights activist from Cherepovets was convicted of dissemination of 'fake news' about the Russian Armed Forces, for his posts and comments on VK social network about the events in Bucha and Irpin and the attack on a drama theatre in Mariupol. Sentenced to 3 years of low-security prison.

#### YAVGASTIN AYSUVAK

Sole breadwinner of 6 children accused of organising mass riots after demanding the release of a Bashkir activist and former leader of the Bashkort movement who had spoken out against the war. Arrested in January 2024.

# YAKIMENKO BOGDAN (MAX VERTSINSKY)

Accused of organising and participating in an extremist movement, for participation in an antifascist community in the Antifa United, a private VK group. In custody since June 2024.

# YAKIMENKO VOLODYMYR

A participant in the Automaidan was convicted of drug trafficking. However, the man reported that he was tortured to extract a confession. In 2023 he cut his wrists in the colony, thus protesting against being forced to sew uniforms for Russian security forces. Sentenced to 15 years 6 months of high-security prison.

### YAKOVLEV NIKITA

A prison inmate was convicted of organising activities for a terrorist organisation, allegedly for promoting the ideology of the Ukrainian Azov Battalion to a fellow inmate. Sentenced to 3 years 2 months of high-security prison.



#### YAKUNICHEV ALEXEI

A resident of the village of Pangody, Yamalo-Nenets District, was tried for dissemination of 'fake news' about the Russian Armed Forces, justification of terrorism and repeated discreditation of the armed forces for publications about the crimes of the Russian army in Bucha and Avdeevka on VKontakte, and a video about the Freedom of Russia Legion. The man was forcibly hospitalised in a psychiatric hospital.

#### YAKUPOV AKHMET

60 years old activist accused of organising mass riots after demanding the release of a Bash-kir activist and former leader of the Bashkort movement who had spoken out against the war. Arrested in January 2024.

#### YAKUSHEVA LARISA

A resident of Cherkessk was accused of founding an extremist organisation for her participation in a movement in support of the USSR/RFSR.

#### YANOCHKIN ALEXEI

Resident of Krasnoyarsk convicted of the organisation of mass riots, for political activity and maintenance of regional chat rooms of the What to do! Telegram channel, calls to express an opposition position in the election of deputies to the State Duma in 2021. Sentenced to 6 years of low-security prison.

#### YAROTSKY VLADIMIR

Convicted of rehabilitating Nazism for posting images on Vkontakte. One of the images depicted an artist painting a portrait of Vladimir Putin, instead the canvas showed a penis adorned with a St. George's ribbon. The image was accompanied by the caption: 'Smart people see that Putin is burying Russia alive, while fools believe he is saving it.' Received a sentence of 1 year and 6 months.

# YAROSHENKO YURI

Charged with sabotage for allegedly participating in the activities of the Russian Volunteer Corps and planning to poison food that was to be sent to soldiers of the Russian army.

# YAUBASAROV VENER

Accused of organising mass riots after demanding the release of a Bashkir activist and former leader of the Bashkort movement who had spoken out against the war. Arrested in January 2024.

### YEVTUSHENKO POLINA

Charged with state treason, promotion of terrorist activities, rehabilitation of Nazism, and calls to extremism because of anti-war publications on the Internet.



#### YEVTUSHENKO PAVEL

Convicted of possession of explosives. Yevtushenko reported about provocative actions executed by the FSB. He was subsequently in correspondence with a person pretending to be in need of help; then he was detained, beaten, and forced to take a grenade with a plastic explosive in his hand and confess.

### **YEDIGAREV ANDREI**

A former deputy of the City Duma of Glazov, Republic of Udmurtia, accused of justifying terrorism because of three anti-war posts on Facebook. Listed as extremist and terrorist by Rosfinmonitoring. Reported being beaten during detention.

#### YELKIBAYEV SALAVAT

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 police and National Guard with truncheons dispersed the crowds.

#### YEPIKHIN IVAN

Convicted of calling for terrorism and extremism, for distributing leaflets in the village of Tovarkovo. The leaflets contained statements that Crimea belonged to Ukraine and that the Russian regime was fascist. Sentenced to 2 years 9 months of low-security prison.

#### YERMOLENKOV ANDREI

A resident of Zheleznogorsk was convicted of state treason for allegedly intending to fight on the side of theUkrainian Armed Forces and transferring data on the dislocation of troops in the Kursk region. Sentenced to 6 years of high-security prison.

# YEROSHIN DENIS

A student convicted of justifying terrorism, for his posts in an anti-war chat in Telegram.

# YESIPENKO VLADYSLAV

Ukrainian citizen and journalist detained for possession of explosives, in fact persecuted for the pro-Ukrainian position, participation in the memorial event of Taras Shevchenko. The man reported that a grenade was planted on him, and during the detention he was tortured with electricity and beaten. Sentenced to 5 years of low-security prison.

# **YUGOV SVYATOSLAV**

Convicted of organising activities of an undesirable organisation due to his work as a pastor in the Ukrainian church the New Generation. Sentenced to 3 years 6 months low-security prison.



#### YUDIN LEONID

A 20-year-old resident of the Republic of Buryatia, convicted of state treason for allegedly filling out a questionnaire to join the Ukrainian Freedom of Russia Legion and the Russian Volunteer Corps. Sentenced to 13 years of high-security prison.

#### YULDOSHEV DAVRONBEK RAVSHANBEK UGLI

Charged with attempted terrorist act for allegedly preparing to set fire to a conscription centre in St. Petersburg.

### YULMUKHAMETOV SAGIT

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. Arrested in February 2024.

#### YURYEV NIKOLAI

Convicted of preparing a terrorist act because of alleged intentions to set fire to the conscription centre in Novouralsk, Sverdlovsk region, and to overthrow the constitutional order of the Russian Federation. Sentenced to 18 years of high-security prison.

#### YUSUBOV AMID

Charged with incitement to hatred or enmity with threats of violence due to voice messages sent in a Telegram chat about martial arts. The messages expressed support for Ukrainians in the war, advocated for the harassment of migrants in Moscow, and called on Muslims to stand up for their rights. Arrested in September 2023.

# YUSUPOV AIDAR

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. In custody since March 2024.

# YUSHKOV SERGEY

An ex-specialist in information technologies of a St. Petersburg defence enterprise was convicted of public justification of terrorism, public calls for extremist activity and rehabilitation of Nazism, for anti-war posts on his page on VK social network. Sentenced to 7 years of low-security prison.

# **ZHARIKOV MIKHAIL**

A fan of the Torpedo, a Nizhny Novgorod hockey club, was convicted of dissemination of 'fake news' about the Russian Armed Forces and rehabilitation of Nazism, for an Instagram post in which he compared Russia to Nazi Germany and criticised Russians for not participating in protests against the war. Sentenced to 5 years 10 months low-security prison.

### **ZHELEZNYAKOV SERGEI**

A programmer, accused of starting a terrorist organisation by creating a Telegram channel. The man denies the charges and reports being tortured.



#### **ZHIGULYOV ANDREI**

An 18-year-old political science student in Omsk was charged with public justification of terrorism for a comment justifying the murder of military officer Vladlen Tatarsky, which he wrote as a schoolboy. He reported physical assault during detention.

#### **ZHITNIKOV YEGOR**

A resident of Sarapul, Republic of Udmurtia, was convicted of public justification of terrorism, for comments about the destruction of the Kakhovka hydroelectric power plant. Sentenced to 3 years 6 months of low-security prison.

#### **ZHITNYUK ALEXEY**

Convicted of treason for allegedly passing secret information about the Russian Navy to a Norwegian citizen. Sentenced to 13 years of high-security prison.

#### **ZHUKOV ANDREY**

A military researcher and reserve captain of the Russian Armed Forces was convicted of state treason for gaining access to classified maps posted by someone on an online historical forum. Sentenced to 12 years 6 months of high-security prison.

#### **ZHUKOV ARTEM**

Convicted of using violence against a representative of the authorities for allegedly fighting with police officers at a rally in support of Alexei Navalny. Sentenced to 4 years of low-security prison.

## **ZHURAVEL NIKITA**

19-year-old resident of Volgograd and native of Sevastopol was convicted of insulting religious feelings of believers and hooliganism for burning Quran. The case was transferred to the Chechen Investigative Committee, after which Adam Kadyrov, son of the head of Chechnya, demonstratively beat Nikita Zhuravel on video. Sentenced to 3 years 6 months low-security prison.

# **ZHURAVLEV DENIS**

Tried for participating in activities of an extremist organisation because of anti-war publications on the Internet. Forced psychiatric treatment was ordered.

# **ZHURAVLEV ALEXANDER**

Convicted of preparing a terrorist act because of alleged cooperation with the Ukrainian Defense Ministry's intelligence service and preparation for a terrorist act in Stavropol. Sentenced to 4 years 6 months of high-security prison.

### **ZHUCHKOV ANTON**

An Omsk resident was convicted of preparing a terrorist act, allegedly for an attempt to organise an anti-war performance in Moscow: to set fire to an empty car. When detained, the man took a lethal dose of methadone as a sign of protest against the war. Reported torture with a stun gun. Sentenced to 9 years 10 months of high-security prison.



#### **ZABOLOTNY YEVGENY**

Resident of Usinsk, Komi Republic, convicted of terrorist act for unsuccessful arson attack on FSB department building. Sentenced to 12 years of high-security prison.

#### **ZAGURSKIKH YURI**

A resident of Vyborg was convicted of terrorism for allegedly planning to set fire to a Defense Ministry facility. Sentenced to 11 years of high-security prison.

### **ZAZULYA SERGEY**

Charged with sabotage for allegedly attempting to blow up a gas distribution station in the Leningrad region per the instructions of the Security Service of Ukraine.

#### **ZAYTSEV ANTON**

A resident of Pechory, Pskov Region, was convicted of cooperation on a confidential basis with a representative of a foreign state to the detriment of the Russian Federation, allegedly for attempting to establish contact with a representative of the Embassy of the Republic of Latvia in Moscow and transfer data on the movement of military personnel. Sentenced to 3 years 6 months low-security prison.

#### **ZAYTSEV VALERY**

A 14-year-old schoolboy from Solnechny settlement in Komsomolsk-on-Amur was detained in a tuberculosis clinic where he was being treated for tuberculosis. He was accused of being trained in preparation for a terrorist attack for a video in his Telegram channel where teenagers throw Molotov cocktails at the wall of an abandoned building, allegedly for supporting the ideology of the Azov battalion.

# **ZAITSEV VITALY**

A resident of Tula, accused of calling for extremism and terrorism for comments calling for the murder of Russian servicemen.

# **ZAMANOV GALIM**

Accused of organising mass riots, essentially for demanding the release of a Bashkir activist and ex-leader of the Bashkort movement who spoke out against the war. About 10 000 people gathered in front of the court building in Baymak, and more than 1000 police officers and National Guard with truncheons dispersed the crowds.

### **ZARIPOV ZAKHAR**

Convicted of public calls to carry out terrorist activities because of an anti-war comment on the Internet. Sentenced to 5 years low-security prison.

### **ZAROVNYAEV ROMAN**

A resident of the Sverdlovsk region was accused of committing a terrorist act by allegedly setting fire to a relay cabinet at a railroad crossing.



### **ZATEYEV EVGENY**

He was accused of participation in the activity of NGOs, infringing on the rights of citizens, and for inducement to mass disorder. In reality he was persecuted for being a member of the Vesna democratic movement, which called to participate in anti-war protests.

#### **ZELENIN GEORGY**

Convicted of sabotage, for a plan to destroy part of the railroad tracks because of his anti-war beliefs. Sentenced to 3 years 6 months of high-security prison.

### **ZELTSEV KONSTANTIN**

Accused of sabotage, allegedly for setting fire to relay and battery cabinets in Chuvashia.

### **ZENKOV SEMYON**

Accused of committing sabotage by setting fire to a relay cabinet at a railway station.

#### **ZIBROVA ANASTASIA**

A dog handler for the Ministry of Internal Affairs. A single mother. Sentenced to 5 years in prison for a single repost on social media. Has a six-year-old daughter.

### ZIMINA ANTONINA

Convicted of allegedly cooperating with Latvian special services. Sentenced to 13 years low-security prison.

#### ZINKOVSKIY DANIEL

Convicted of treason because of alleged intention to go to Ukraine and to join the Ukrainian Armed Forces. Sentenced to 7 years of high-security prison.

# **ZIZA (AZIZOV) BOGDAN**

A Ukrainian citizen in Yevpatoria, in annexed Crimea, convicted of terrorism for spraying the city administration with yellow and blue paint and throwing a Molotov cocktail at it. Reported beating and pressure on him while recording apologies on video. Sentenced to 15 years of maximum security prison.

# **ZOKIROV FARRUKHZHON**

Charged with committing a terrorist act for allegedly trying to damage electrical equipment on railroad tracks.

## **ZOLOTAREV VLADIMIR**

Convicted of a terrorist act for setting fire to the building of the National Guard in protest against the invasion of Ukraine. Sentenced to 18 years of high-security prison.

## **ZOTOV MAXIM**

A resident of Zarechny, Penza region, was charged with cooperation on a confidential basis with a foreign state, and state treason, allegedly for his connection with the British intelligence agency MI-6. Reported provocation acts on behalf of the FSB.



#### **ZOTOVA VALERIA**

A 19-year-old resident of Yaroslavl was convicted of attempted terrorist act, for attempting to stage an arson attack on the administration building. She reported provocative actions by FSB officers: someone had corresponded with her and motivated her to commit the action. Sentenced to 6 years of low-security prison.

### **ZUHUROV BAKHODUR**

A citizen of Tajikistan was accused of justifying terrorism for a comment in the St. Petersburg Communicate/Yandex Food Telegram messenger chat group justifying the terrorist attack in Crocus City Hall.

### **ZYRYANOV IVAN**

Charged with intentional infliction of minor harm to health on political or ideological grounds, for fighting with former members of the so-called 'special military operation' and criticising participation in the war in Ukraine.

#### **ZVEGINTSEV VALERY**

Founder of the High Speed Aerodynamics laboratory in the Institute of Theoretical and Applied Mechanics of the Siberian Branch of the Russian Academy of Sciences, accused of state treason for a scientific publication on the subject of gas dynamics in a foreign scientific journal.



Unfortunately, the list of political prisoners in Russia is growing. Anyone can become a terrorist, an extremist, an undesirable person, or a foreign agent, regardless of age, occupation, political views, or health conditions.

Each name on this list matters.
